Engineer's/Contractor's associations resent suspension of JE by DDC

Rajouri, Mar 22: Engineer's and Contractor's Associations here at Rajouri have strongly condemned the suspension of Junior Engineer (JE) by the DDC for alleged dereliction of duty & demanded revocation of the order.

Danish Mirza, JE posted with Rajouri PWD(R&B) division was placed under suspension by Rajesh Kumar Shavan, DDC yesterday allegedly for failing to achieve the assigned target in the stipulated time period.

He was entrusted with the job of completion of the approach road to under construction Government Medical College complex.

Representatives of contractor

Associations today held a protest before the office of DDC (who was not present) to raise their grievances/problems, including pending payments, higher cost of construction material (despite rates were fixed by the DDC), their inability to execute works in double shifts as their agreement(s) with competent authorities don't carry any such clause etc.

Engineer's fraternity has also strongly condemned the action of the DDC and alleges that deputing men and machinery at the site (for double shift) is the job of the contractor & not of JE.

They alleged that one of the main reasons behind the delay in the execution of de-



velopmental works was the seizure of crushers' by the au-

"The method of execution of the work(s) is clearly men-

tioned in the agreement signed with the competent authorities & there is no mention to execute works in double shifts," said Ashfaq Magray, president of District Contractors Association.

DDC cannot direct anything outside the purview of the tender document as it amounts to creating a new agreement for which we are neither willing nor bound to do, he added. "In the month of January DDC

had seized all the crushers operating in the district and then after about one & half the month he allowed their operation that resulted in delaying of the construction works during peak working season" said Shafqat Wani, President, Pir Panjal Contractor Association (PPCA). "As per terms and conditions

of the contract (s) the powers to communicate with contractors lie with the Executive Engineer. So the suspension of JE is nothing but a sheer misuse of official position" he added.

Mohd Yaqoob, Shakoor Ahmed, Lucky Sharma & others alleged that the seizure of the crushers was the main reason behind low performance in the construction of various infrastructure projects in the district.

"Now, DDC is pressurising the contractors/engineers to complete the works within the stipulated time frame by executing works in double shifts which is not possible for the contractors" sources said.

All the Engineers were on casual leave today in protest against the suspension of JE by DDC Source said both Engineers & Contractors may go on strike if the suspension order was not revoked.

Meanwhile, Mohd Zubair, XEN, PWD (R&&) has deputed Ansul Bhagat, JE in place of Danish Mirza as per DDC
