CRIME REPORT

Covid SoP: Rs 26,100 fine recovered from violators in Ramban

■ **STATE TIMES NEWS**

RAMBAN: Continuing the enforcement drive to implement Covid protocol across the district Ramban, the Enforcement teams on Thursday fined scores of violators for roaming without wearing face masks and not maintaining physical distance. The enforcement teams, during the inspection in their respective jurisdictions, recovered a fine of Rs 26,100 taking the total amount fined since April 1, 2021 to Rs. 55, 83,700.

The Enforcement officers urged the people to wear face masks and maintain physical distance besides taking Covid vaccination doses at their nearest CVC. District Immunization Officer, Ramban, Dr; Suresh informed that as many as 3026 persons were administered first and second Covid vaccine doses across Ramban district today. As per daily bulletin issued by the Chief Medical Officer, Ramban, Dr. Mohammad Fareed Bhat, the Health Department has collected 1552 samples including 356 RT-PCR and 1196 RAT samples besides administering Covid vaccine to 3026 persons at dedicated Vaccination Centres in the district.

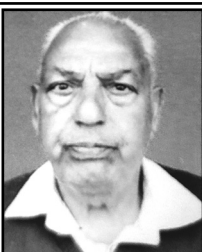

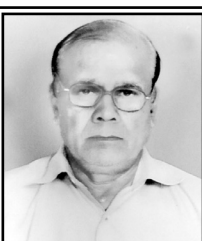

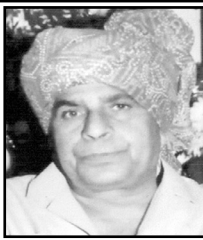
