Arrangements for Navratri, Ramnavmi, Dussehra festivals in Jammu reviewed

JAMMU: Additional Deputy Commissioner (Law and Order) Jammu Ghan Shyam Singh on Thursday convened a meeting of officers of various departments to review the arrangements for Navratri, Ramnavmi, Charri and Dussehra festival here today at DC Office complex.

Threadbare discussions were held on various issues including sanitation, uninterrupted electricity, ensuring regular and safe drinking water, security arrangements, traffic management, decoration of temples, adequate stocks of ration and fire wood, check on the rates and quality of food etc

The ADC emphasized on maintaining cleanliness and hygiene in and around the temples and decoration of important temples and

directed the concerned departments to promote the message of sanitation.

He asked the Police authorities to provide adequate security arrangements at temples and called for inter-departmental coordination to put in place all necessary arrangements well in time for the smooth celebration of the festival.

He asked the PHE and PDD Departments to take all measures to provide uninterrupted water and Power supply. The PDD was asked to ensure proper lighting arrangements in addition to uninterrupted power supply throughout the festival season.

The Food Civil Supplies and Consumer Affairs authorities were asked to keep a check on the rates and quality of food items being

sold during the festival. The Health Department was directed to keep sufficient provision for Medicare facilities and medical staff.

Enforcement of Covid protection guidelines and SoPs

was also stressed including wearing of masks and maintaining social distance.

The examination forms shall be submitted to the concerned Sub/Branch office of the JKBOSE after completing all the requisite formalities along with the certification from the concerned head of the institution that these students have not appeared earlier in any examination of the said class for which they are submitting the examination forms.

Further, the schools have to submit only the examination forms/ enrolment to the concerned Sub/Branch office without paying the fee. Once the concerned Sub/Branch office verifies/scrutinize the examination forms and transmit the same to the Head office after ascertaining the eligibility of the candidates to appear in the examination, the fee Portal shall be made available to the institutions for making payment of prescribed normal fee through online mode (for Class 10th and 11th) only, whereas the deposition of prescribed normal fee for Class 12th candidates shall be through offline mode as in vogue, for which the dates shall be notified separately.

Eligibility:- Any candidate applying for M.Sc.Nursing courses shall be eligible, if he/she:

- has passed, B.Sc. Nursing/B.Sc. Hons. Nursing/Post Basic B.Sc. Nursing with minimum of 55% aggregate marks,

- has minimum one year of work experience prior to or after Post Basic B.Sc. Nursing .
