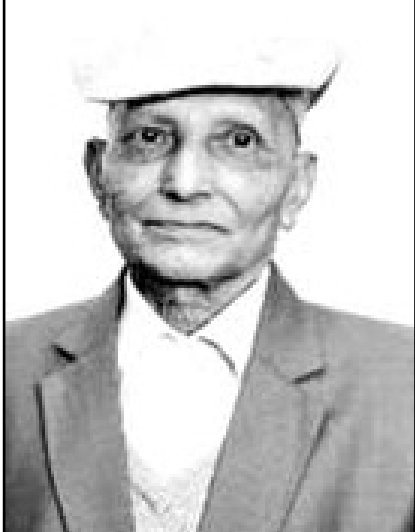

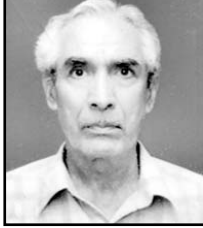

CRIME REPORT

Two absconders arrested

■ **STATE TIMES NEWS**

JAMMU: Police on Monday nabbed two absconders who were evading their arrest since long. As per details, a hardcore criminal cum absconder namely Dheeraj Kesar, son of Darshan Kesar, resident of Upper Roopnagar Janipur, Jammu who was booked in FIR No. 73/2021 under sections 376/420 of IPC at Police Station Satwari but was absconding his arrest since 7 months, has been arrested by Jammu police. Jammu Police was looking for accused and accordingly local intelligence was activated. On a tip off, a team from Police Station Satwari led by SHO Satwari Inspr Deepak Jasrotia assisted by PSI Sandeep Kumar under the supervision of SDPO South P K Mengi generated input about presence of absconder in UP. On this, a dedicated team went there and with help of local police of concerned area, arrested accused from Deepak Vihar, Noida (UP). Finally, he was produced before the High Court Jammu, which remanded him for 7 days Police custody.

Meanwhile, another absconder namely Ashok Kumar, son of Lt Malk Ram, resident of Tali Morh, Miran Sahib, Tehsil R S Pura, District Jammu who was booked in FIR No. 86/1999 under section 279 of RPC at Police Station Batote but was evading arrest for the last 22 years, has finally been arrested. Ramban Police was looking for accused from last 22 years and finally an information was received through reliable sources about accused. Acting quickly on the information, a special police team of Police Station Batote headed by Ajeet Singh, SHO Batote under the supervision of Pardeep Singh Sen, DySP Hqrs Ramban and overall supervision of P D Nitya, SSP Ramban was constituted. The team raided suspected locations and finally arrested the accused person from Jammu.

Lease-holder files complaint against illegal mining, seeks action against 3 crushers

JAMMU: A lease-holder filed a complaint against illegal mining and sought action against three crushers in Jourian area. As per details, Lease holder Kuldeep Singh lodged a written complaint with Director, Mining Department, DC Jammu and SSP Jammu stating therein that three crushers in Jourian area are indulged in illegal mining despite the fact that he has been granted lease of Jourian block. He alleged that these crushers have been warned by him several times but even then they indulged in illegal mining due to which he is suffering huge loss. He has lodged complaint against Mahaveer Stone Crusher, Sai Stone Crusher and Ram Stone Crusher.

Cyber Police Jammu nabs 2 fraudsters in Rs 3,30,000 online fraud case

JAMMU: Cyber Police Station Jammu has succeeded in apprehending two fraudsters involved in Rs 3,30,000 online cyber fraud case, regarding which FIR No 25/2021 under sections 66D of IT Act, 420, 120-B of IPC was registered at Cyber Police Station, Jammu. The accused were identified as Irshad Ahmed, son of Gulzar Ahmed Nadaf, resident of Sarai Safakadal, Srinagar and Mohammed Tahir Khan, son of Abdul Gani Khan, resident of Watal Kadal Safakadal Srinagar.

As per details, on September 8, 2021, complainant namely Sajjad Hussain, son of Ghulam Mustafa Shah, resident of Kishtwar reported at Cyber Police Station Jammu that he was duped by unknown fraudsters on pretext of issuance of Visa to Dubai for his son. The complainant, desperately in need of visa for his son, got trapped in luring offer of accused and consequently lost Rs 3,30,000 in multiple transactions. During the course of investigation, cyber police succeeded in identifying the fraudsters. SP Cyber Police Station after ascertaining the location of the accused persons deputed dedicated team to nab them. The deputed team acting swiftly arrested accused from Safakadal, Srinagar. They were brought to the Cyber Police Station Jammu and produced before competent court and obtained police remand. Police is also searching for other fraudsters involved in the offence.

Four vehicles seized for illegal mining

JAMMU: Continuing its drive against menace of illegal mining, a multi-pronged strategy was devised by Jammu Police in which dedicated teams of Police Station Jhajjar Kotli, Police Posts Pounichak and Bel Charanara acted stringently on specific inputs and raided at different locations in their respective areas and seized four different vehicles involved in illegal mining. Police has registered a case against truck driver and started investigation.

Migrant labourer murdered; body found from under-path

JAMMU: A migrant labourer was murdered and his body was found from under-path in Gangval area on Monday.

As per details, locals on seeing a blood-ridden body lying at under-path in Gangval area informed police, which rushed to the spot and shifted body to morgue. The deceased was identified as Ram Charan, resident of Madhya Pradesh and was presently working with a factory. Police has registered a case and started investigation.
