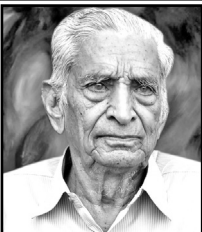

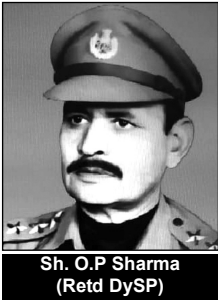

CRIME REPORT

Youth injured in mishap

SAMBA: A youth got injured in Samba area, after his bike collided with a water tanker on Wednesday.

He was immediately shifted to nearby hospital, from where he was further referred to GMC Jammu for advanced treatment. The injured has been identified as Vicky Kumar, son Darshan Lal, resident of Pathankot, while the driver of water-tanker managed to flee from the spot along with tanker. Ghagwal Police has registered a case and started investigation.

Man found hanging

JAMMU: A man was found hanging with ceiling fan hook of his house, under mysterious circumstances, in Gandhi Nagar area on Wednesday.

On Wednesday, when his daughters returned home after attending tuition, they found Raghurib Singh hanging with ceiling fan hook. Police was informed which rushed to the spot and shifted body to GMC Hospital for post-mortem. A case has been registered at Gandhi Nagar Police Station in this regard.

Meanwhile, one Jasbir Singh, son of Sujan Singh, resident of Lower Gadigarh also tried to commit suicide but due to timely action of family members, he was rescued. He was immediately shifted to hospital, where he is under treatment. The police has taken cognizance in the matter.

Theft case solved, accused arrested

JAMMU: Bari Brahmma Police has solved a theft case on Wednesday by arresting an accused.

As per details, one Mohd Jaffar, resident of Uttar Pradesh, lodged a complaint with Police that his bundle of wire, costing lakhs of rupees, has been stolen. During sustained questioning, he confessed his involvement in crime and on his disclosure; stolen wire was also recovered by Police. Further investigation in the matter is going on to ascertain involvement of accused in some other cases.

Bootlegger held with illicit liquor

JAMMU: Police has arrested a bootlegger and recovered 45 bottles of illicit liquor from his possession in Pouni Chak area on Wednesday.

As per details, a party from Police Post Pouni Chak led by Incharge Police Post Pouni Chak SI Nitish Khajuria, while on patrolling duty near Patta Chungi, rounded up a suspect, who was identified as Rattan Lal Bhagat, son of Ramu, resident of Padrore, Tehsil Jammu West. During search, 23 bottles of 180 ml each and 22 bottles of 250 ml, total 45 bottles of illicit liquor were recovered from his possession. The accused was arrested and FIR no. 300/2021 under section 48(a) of Excise Act was registered at Police Station Domana. The arrest and recovery took place under supervision of SDPO Domana Sunil Singh and SP Rural Sanjay Sharma. Further investigation of case is going on.

Mundra port heroin seizure: NIA seizes 'talc mixed with drugs' after raid

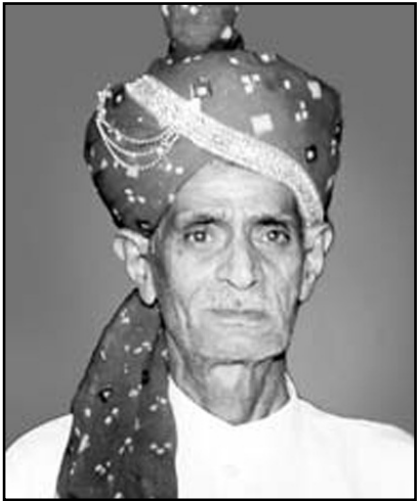
NEW DELHI: NIA on Wednesday seized what is understood to be talc-mixed with narcotics during a raid at a godown here in connection with case RC-26/2021/NLA/DLI, related to recent seizure of 3,000 Kg heroin at Gujarat's Mundra port. The search, according to the agency, was carried out a building located in Nebsarai area of the national capital in connection with the seizure of narcotics substance imported in the guise of semi processed Talc stones by M/s Aashi Trading company. "White powder material, suspected to be talc mixed with narcotics, has been seized with help of the FSL (forensic science laboratory)," a National Investigation Agency (NIA) spokesperson said. The agency had carried out similar searches in the Mundra heroin seizure case twice earlier. The NIA early this month took over the case from the Directorate of Revenue Intelligence (DRI) on the directions of the Union home ministry and registered a criminal complaint under sections of the Narcotic Drugs and Psychotropic Substances Act and the Unlawful Activities Prevention Act (UAPA). The case relates to the seizure of 3,000 kg of narcotic substance heroin -- at Mundra port and the involvement of foreign nationals in the procurement and delivery of the consignment, an NIA official had said. On September 13, the DRI detained two containers that had arrived at Mundra Port from Kandahar in Afghanistan through the Bandar Abbas port of Iran. The declaration accompanying the containers claimed they had 'semi-processed talc stones'. However, a thorough examination established that the two containers in fact contained 3,000 kg of heroin worth Rs 21,000 crore, which was concealed in 'the lower layers' of 'jumbo bags' topped with talc stones, an official release had said. The DRI had arrested eight persons, including five foreign nationals, in connection with the seizure of the drugs. Searches were then conducted by the NIA in Chennai, Coimbatore and Vijayawada at premises of the accused.

A staunch devotee of Bhagwan Shiv, he was a polite, social and helpful person always ready to help poor and needy people. He breathed his last on October 11, 2021 due to cancer. He is survived son and two daughters besides families of his brothers, who all live together as a joint family.

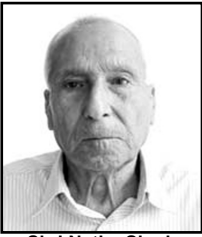

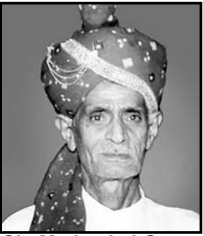
