CRIME REPORT

Rescue operation by Ganderbal Police, 200 stranded vehicles rescued Landslides cleared from main-road Sonamarg

GANDERBAL: Police acted swiftly to restore movement of traffic at Main-road Sonamarg during overnight landslides which had blocked the road. Due to incessant rains in last few days, a huge mass of land slide on main road at Sonamarg, blocking the movement of vehicles and local population. Police Station Sonamarg received an information about the incident, a police party led by SHO Police Station Sonamarg arrived at the spot and initiated the activities for clearance of landslide occurred by snow, rain. Police as a first responder began the rescue operation despite heavy downpour in area. Other senior officers including SDPO Kangan were supervising rescue efforts on the spot.

After hectic efforts, Police managed to evacuate almost 200 passenger vehicles and cleared the debris from the road and make it through for the vehicular movement. Community members have appreciated the quick response of the police for promptly launching rescue operation in area. J&K Police is committed to secure the lives of community members and provide assistance wherever required.

Two drug peddlers nabbed, psychotropic substance recovered

JAMMU: Continuing its efforts to eradicate menace of drugs from society, Police arrested 2 drug peddlers in Budgam and recovered psychotropic substance from their possession.

As per details, officers from Police Post Humhama at a checkpoint established at Railway Track Humhama intercepted 2 persons, who on seeing police party tried to escape from spot but were apprehended tactfully. They were identified as Mudasir Maqbool Ganai, son of Mohammad Maqbool Ganai, resident of Krankshivan Colony Sopore and Manzoor Hussain Bhat, son of Gh. Mustafa Bhat, resident of Mir Mohalla Haigam Goh. During checking, officers were able to recover 19 bottles of codeine phosphate from their possession. They were arrested and shifted to Police Station where they remain in custody. Accordingly, FIR No. 321/2021 under relevant sections of law was registered in Police Station Budgam and further investigation has been initiated.

Bovine smuggling attempts foiled, 46 cattle rescued

The driver vehicle was arrested on the spot. FIR No. 140/2021 under sections 188 of IPC and 11 of PCA Act has been registered at Police Station Hiranagar for further investigation.

Thieves burgled house of ASI; decamped with cash, jewellery
