Whereas, combined updated final Seniority Lists of Panchayat Supervisors/ Panchayat Inspectors Grade-I/Cooperative Extension Officers/Lady Project Officers/HQAs as it stood on 01.01.2008 was issued vide Govt. Order No.324-RD&PR of 2019 Dated 13.12.2019; and

Whereas, the regularization case in respect of the eligible Panchayat Inspector-I & equivalent/Headquarter Assistants, who are/were working as Incharge Block Development Officers in terms of existing J&K Rural Development (Gazetted) Service Recruitment Rules, 2003, has been taken up with the Public Service Commission for their confirmation. However, PSC raised certain observations, among others, that an updated combined seniority list of these Panchayat Inspectors Grade-I & equivalent may be furnished and subsequently a revised proposal be submitted to the Commission; and

Whereas, both the Directorates of Rural Development, Jammu/Kashmir vide their order No. (s). 416-DRD of 2021 dated 06.09.2021 and 1017-DRDK of 2021 dated 13.10.2021 respectively have issued Combined Final Seniority list of Panchayat Supervisors, Panchayat Inspectors Grade-I, CEO, HQA, Panchayat Inspector Grade-II, Plantation Ranger & Mukhya Savikas as Panchayat Inspectors of the Rural Development Department of their respective Division and furnished the same to this Department for taking further necessary action; and

Whereas, the rationalization of the various categories of the posts of this Department has been made vide Govt. Order No.59-RD&PR of 2021 dated 02.03.2021 wherein interalia, all the posts of Panchayat Inspectors Grade-I, II & equivalent/Headquarter Assistants Grade-I & II have been merged and re-designated as Panchayat Inspectors; and

Whereas, both the Directorate of Rural Development, Jammu/Kashmir vide their order No. (s). 416-DRD of 2021 dated 06.09.2021 and 1017-DRDK of 2021 dated 13.10.2021 respectively have issued Combined Final Seniority list of Panchayat Supervisors, Panchayat Inspectors Grade-I, CEO, HQA, Panchayat Inspector Grade-II, Plantation Ranger & Mukhya Savikas as Panchayat Inspectors of the Rural Development Department of their respective Division and furnished the same to this Department for taking further necessary action; and

Whereas, after rationalization of the various posts of the Non-Gazetted categories, which include the re-designation/merger of the posts of Panchayat Inspector Grade-I, II, CEO, Lady Project Officer, Panchayat Supervisors, Plantation Ranger, Headquarter Assistants Grade-I & II as the Panchayat Inspector and their combined Seniority list at the Administrative Department shall be issued strictly in accordance with the existing J&K Rural Development (Gazetted) Service Recruitment Rules, 2003 as the eligible Officials, who are/were holding the posts in the capacity of I/C BDO, are required to be confirmed/regularized through DPC/TSC. However, their combined seniority list in respect of the aforesaid categories as the Panchayat Inspectors may be issued as and when the existing recruitment rules are modified. Moreover, the combined seniority list in respect of proposed eligible Panchayat Inspectors Grade-I & equivalent/Headquarter Assistants are to be issued immediately so that their regularization/confirmation proposal as sought by the PSC will be taken up in a time bound manner; and

Whereas, all the aforesaid categories of posts are the feeding cadre posts, except Panchayat Inspectors Grade-II, for promotion of Block Development Officers in terms of existing J&K Rural Development (Gazetted) Service Recruitment Rules, 2003 and the combined updated seniority list of these categories of posts are required to be issued so that their regular promotion as BDOs shall again be taken up with the JKPSC/DPC and also the placement in respect of eligible incumbents as I/C BDOs is being processed for seeking approval of the competent authority accordingly.
