

Ensure all benefits to specially-abled candidate in JA selection process: CAT to Admn

JAMMU: A Bench of Central Administrative Tribunal comprising RS Jain Judicial Member and Anand Mathur Administrative Member directed Jammu & Kashmir Union Territory to ensure that all the benefits are made available to a specially-abled candidate while appearing in the selection process as also those appearing in the Junior Assistant selection, in terms of Regulations of the Government. This significant order has been passed by Anurag Nishad, a specially-abled person who has applied for Junior Assistant recruitment in the Government. He is seeking direct recruitment requiring candidates with disabilities to type.

various Acts, Rules and Regulations on the subject.

This significant order has been passed in a petition filed by Umar Nisar Zarger who is a specially abled person and has applied for the post of Junior Assistant in the advertisement issued by the Government Department seeking direction to respondents requiring persons/candidates with benchmark disabilities to type 35 words per

minute same as the fully able persons/candidates, provided as a matter of eligibility for the post of Junior Assistant, clerk and Computer cum Junior Assistant, to provide reasonable accommodation to specially abled candidates. He sought suitable direction to respondents who issued the impugned Advance notice dated 22.09.2021, wherein the applicant has been called upon along with other eligible candi-

dates to appear mandatorily in the Computer based/short hand test without any exemption or modification or adjustment to provide "Reasonable Accommodation" to Persons with Disabilities is patently illegal, unreasonable, arbitrary, discriminatory and unconstitutional being violative of Articles 14 and 16 (1) of the Constitution of India.

In the petition, petitioner also seeking direction to Respondents to consider altering/recasting to the extent necessary, the omission in the

Recruitment Rules including SRO 82 of 2004 dated 22/3/2004 governing the various Subordinate Services in the Union Territory of Jammu and Kashmir as far as the post of Junior Assistant is concerned, providing Reasonable Accommodation with exemption or modification or adjustment consistent with the Constitutional parameters, Legislative mandate of the Rights of Persons with Disabilities Act, 2016 and also mandate of law declared on the subject by the Apex Court.

HC dismisses ARTO petition seeking bail in corruption case

JAMMU: Justice Sanjay Dhar dismissed the petition of Khursheed Ahmed Kanna ARTO seeking bail in ACB Raid case.

While dismissing the bail application, Justice Sanjay Dhar observed that the petitioner has approached this Court directly without exhausting the remedy before Special Judge and even if petitioner did approach the said Court, yet he abandoned the application midway without actually exhausting the said remedy as the petitioner withdrew the said application. Justice Sanjay Dhar further observed that apart from the above, since the Court of first instant i.e., Special Judge, Anti-corruption

tion, Baramulla, is already seized of the matter pertaining to grant of bail to co-accused, it will be appropriate if the bail application of the petitioner is also considered by the same Court along with bail application of co-accused. This is important because any expression of opinion by this Court is likely to influence the outcome of the bail application filed by the co-accused before the Special Court. With these observations, without expressing any opinion on the merits of the case, High Court ordered that the petition be dismissed with liberty to the petitioner to approach the Court of Special Judge, Anticorruption, Baramulla, with an application for grant of bail, if he desires.

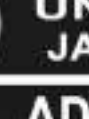
