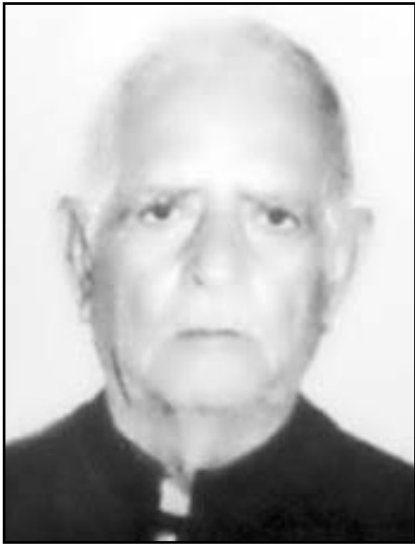

CRIME REPORT

Two absconders apprehended

KATHUA: Police on Thursday arrested two absconders who were evading their arrest. They were wanted in a FIR No. 200/2021 under sections 307/457/147/148 of IPC, 4/25 of Arms Act. On specific information, a police team led by Insp Amit Sangra SHO Rajbagh under supervision of SDPO Border Sachit Mahajan apprehended duo namely Farman, son of Mohd Sharif, resident of Sunjwah and Bagh Hussain, son of Ali, resident of Haria Chak. Further investigation into this matter has been initiated.

33 bovines rescued, 2 smugglers arrested

JAMMU/KATHUA: Continuing its drive against bovine smuggling, Jammu Police during Naka checking at different places have rescued 33 bovines animals and arrested two smugglers.

As per the details, during Naka near Ragoora Morh by a team of Police Station Bagh-e-Bahu led by SHO Insp Kirti Sharma assisted by PSI Sohail Ahmed under supervision of SDPO City East Jammu Sajad Sarwar, rescued 32 bovines from two trucks (JK03C 4340 & JK02X 8999). FIRs No. 83/2021 & 84/2021 both under sections 188 of IPC, 3 of PCA Act were registered at Police Station Bagh-e-Bahu and vehicles have been seized. The recovery has been made under the supervision of SP City South Deepak Digma. Further investigation of the case is going on.

Meanwhile, it was reliably learnt that two persons namely Maradu, son of Shafi, resident of Shapaki Tehsil Hiranagar and Kishore Kumar, son of Dev Raj, resident of Naun Chack Tali Tehsil Marheen have loaded a bovine illegally in a vehicle (Ashoka Leyland Auto) without any registration number and trying to smuggle it to valley. Acting swiftly, a team led by Insp Vikas Sharma IC PP Marheen under the supervision of SDPO Border Sachit Mahajan laid a Naka at Bernadi Pull. During checking of aforesaid vehicle, a bovine was found loaded in the vehicle and both accused failed to produce any legal permission. Thereafter Police team rescued the

bovine, arrested both the persons and seized the vehicle. FIR No 03/2021 under section 188 of
