# SHRADHANJALI

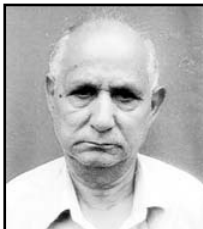

# CRIME REPORT

## 31 bovines rescued, 02 seized.

KATHUA: Police on Sunday rescued 31 bovines and seized two vehicles. As per the details, a police team led by Insp. Amit Sangra SHO Police Station Rajbagh under the supervision of SDPO Border Pankaj Soodan during Naka/Checking duty at NHW Rajbagh noticed two suspicious Trucks (JK08E-4872 & JK02AQ-5369) which were being driven by two unknown persons who were enroute from Punjab side towards Jammu were signalled to stop for checking. On seeing naka party drivers of the vehicles managed to fled away from the spot. During checking, the police team was able to rescue 31 bovines from both the vehicles. Two different cases vide FIR Nos 209, 210/2022 under section 188/IPC,11/PCA was registered at Police Station Rajbagh.

## Drug peddler arrested; contraband substance recovered

PULWAMA: Continuing its efforts to curb the menace of drugs from the society, Police on Sunday arrested a drug peddler in Pulwama and recovered contraband

substance from his possession. As per the details, acting on a specific information received by Police Station Pulwama that one person namely Mohd Yousuf Sheikh son of Ghulam Mohudin Shiekh resident of Chandgham Pulwama has indulged in drug peddling and hoarded a huge quantity of narcotic substance in his residential house. On receipt of this information, a Police party of PS Pulwama alongwith Magistrate raided the specific location. During search, 45Kgs of poppy straw was recovered from the cow shed of accused person. He has also been arrested and shifted to PS where he remains in custody.

Accordingly, case vide FIR No. 298/2022 under relevant sections of law stands registered at Police Station Pulwama and further investigation has been initiated.

## Three missing persons traced, reunited with families

In this regard a missing report on June 22, 2020 was registered at and investigation started. On this, a team of Police Post Chatha under the supervision of SDPO South Sachit Sharma led by SHO Satwari Inspr Sameer Jeelani assisted by In-Charge Police Post Chatha

PSI Harjinder Paul Singh did strenuous efforts and finally traced the missing boy.

Also, another complaint was lodged at Police Post Pouni Chak by the legal heirs of a boy namely Gourav Kumar, son of Sohan Lal, resident of Patta Borhi Talab Tillo Jammu stating that he got missing from his home. In this regard, a missing report on October 14, 2022 got registered and investigation started. On this, a team of Police Post Pouni Chak under the supervision of SDPO Domana Sunil Singh led by SHO Domana Inspnr Tilak Raj assisted by In-Charge Police Post Pouni Chak PSI Nitish Khajuria did strenuous efforts and finally traced the missing boy.

Subsequently, families of all the missing persons were informed and the traced persons were handed over to their family members after completing all the legal formalities.

## Two thieves arrested; stolen gold ornaments recovered

JAMMU: Police on Sunday solved a theft case by arresting two thieves and recovered stolen gold ornaments recovered.

As per the details, an information was received at Police Station Bagh-e-Bahu regarding theft in area. On this, FIR No. 47/2022 under section 454/380/311 IPC was registered and investigation got started. After this, a team of PS Bagh-e-Bahu under the overall supervision of SDPO East Sayed Zaheer Abbas Jafari led by SHO Bagh-e-Bahu Inspr Sikander Singh did strenuous efforts and with the help of various CCTV footages of the area finally rounded up two suspects namely Deepu, son of Manga Ram, resident of Kalka Colony Bahu Fort Jammu and Vikram Kumar, son of Rajeev Nagar Narwal Jammu.

During sustained questioning, they confessed their involvement in the above case and on their disclosure stolen gold ornaments weighing 15 tola(150 grams) was recovered.
