

**7 vehicles seized for illegal mining****STATE TIMES NEWS**

JAMMU: In a quest to stern the menace of illegal mining, a multi-pronged strategy was devised by Jammu Police in which police team of Police Stations Akhnoor, Arnia, Bishnah, Police Posts Phallian Mandal, Chatha and Border Police Post Chakroli acted stringently on the specific inputs and raided at different locations in their respective areas and seized 7 vehicles involved in illegal mining.

The seized vehicles include a JCB and a tipper without registration numbers seized by Akhnoor Police; a tractor trolley bearing Chassis No. MBBBF55AAKCD73238 seized by Arnia Police; a Tractor Trolley without registration number seized by Bishnah Police; a tractor trolley bearing chassis No. MP725D01985875 seized by Phallian Mandal Police; a tractor trolley (JK02CW-0744) seized by Chatha Police and a tractor trolley (JK02AG-2630) seized by Chakroli Police.

The recoveries were made by SHO Akhnoor Insp. H. A. Z. SHO Bishnah Insp. V. K. Sharma, Incharge Police Posts Phallian Mandal PSI Ajesh Singh Jamwal, Chatha-PSI Harjinder Paul Singh and Incharge Border Police Post Chakroli PSI Ishfaq Ahmed Kasana in their respective jurisdictions.

**Theft case solved; 2 arrested, stolen items recovered**

BISHNAH: Police on Saturday solved a theft case by arresting two thieves and recovered stolen items on their disclosure.

As per details, complaint was lodged at Police Station Bishnah by one Pawan Kesar, son of J P Kesar, resident of HNo 3 Sector 7, Channi Himmat, Jammu stating that Kitchen Chimney and other items were stolen from his godown situated near Ring Road, Saree. FIR No 173/2022 under section 380 of IPC was registered at Police Station Bishnah and investigation started.

After this, a team of Police Station Bishnah under supervision of SDPO R S Pura Surinder Singh led by SHO Police Station Bishnah Insp. V. K. Sharma, after putting in hectic efforts, rounded up two accused namely Sandeep Bharti, son of Girdhari Lal, resident of Mandayal, Tehsil Ramgarh and Amit Balli, son of Arvind Kumar, resident of Bagga Marh, Tehsil R S Pura. During intensive questioning, accused confessed their involvement in crime and on their disclosure stolen Kitchen Chimney costing Rs 38,000 was recovered.
