Consequent upon declaration of the NEET UG 2022 result by the National Testing Agency (NTA) on 17-07-2022, the Ministry of Health and Family Welfare, Government of India provided the same to the J&K BOPEE on 27-09-2022 and the Roll Number wise result of candidates belonging to the UT's of J&K / Ladakh was notified by the Board vide Notification No. 065-BOPEE of 2022 dated 29-09-2022; read with Notice No. 026-BOPEE of 2022 dated 05-10-2022.

The Board vide Notification No. 068-BOPEE of 2022 dated 08-10-2022 advised all the eligible candidates to register themselves and upload their documents on the BOPEE website for verification/updating of their category status, through online mode w.e.f. 13-10-2022 to 16-10-2022, so that Provisional UT Merit List (PML) could be prepared and notified/uploaded on website of BOPEE www.jkbopee.gov.in

The online registration forms and the documents uploaded by the candidates have been scrutinized by the Board, and, inter alia, it has been found/ noticed as under:

- Some of the candidates who have not qualified as per the cut off score notified by the NTA have also registered themselves and submitted their documents through online mode, their candidature devoid of any merits has been rejected.
- The candidates who have been listed in **Annexure “B”** to this Notification have been included in the list provided by the J&K Sports Council vide communication No. SC/491-NEET PG/11184 dated 11-10-2022 on the basis of Sports points awarded to them by the J&K Sports Council. However, the candidates who have registered themselves under Sports Category, but have not been awarded any Sports points by the J&K Sports Council shall be treated as OM Category candidates, if otherwise, eligible in the said category.
- Some candidates who have filled up registration forms and whose forms are deficient due to non-availability of one or more documents (which include Domicile certificate, NEET Score Card, DOB, 12th class Marks Card etc.) have been provisionally approved and shall be allowed for counselling subject to the condition that, if selected, they shall have to submit all the deficient documents as required by the Colleges /Institutions at the time of admission in respective College/Institution, failing which their admission shall be automatically cancelled.
- The candidates who have filled up the preliminary registration forms only but have not uploaded any of their documents at the time of registration as mentioned in **Annexure “A”** against their names in their respective columns and therefore these candidates shall be given last and final opportunity to submit their documents physically at BOPEE Office Jammu/Srinagar up to 29-10-2022 (till 02:00 pm), failing which their candidature shall be cancelled.
- The candidates who have registered themselves under PWD / PH category, the Board has provisionally approved their forms and included their names in Provisional Merit List (PML) and they shall also be allowed for counseling, subject to the condition that in case of their selection under PWD category, their eligibility / bench mark/ certificate of PWD shall be verified by the concerned College strictly as per MCI/ DCI rules through Medical Board, wherever required and if any candidate found ineligible at that time, his / her provisional admission shall be cancelled abinitio on his / her own risk and responsibility. Some candidates whose disability / bench mark in PWD category is below 40% are treated as category candidates only in their respective categories, if otherwise eligible.
- The candidates who have applied under EWS category but have not uploaded valid EWS certificate as per SRO 518 of 2019 dated 02-09-2019, their application forms are kept deficient, and last opportunity is given to such candidates to submit their valid EWS certificate as per SRO 518 of 2019 and deposit the same physically at BOPEE Office Jammu/Srinagar a day before start of counselling, otherwise their candidature shall be converted into open category.
- The candidates whose EWS certificates have expired or who have uploaded income certificate or wrong certificate, the Board has rejected their candidature under EWS category but their names are included in Provisional Merit List under relevant category, if otherwise eligible.
- The candidates whose 'category certificate' is deficient as mentioned in column against their names are advised to submit the requisite valid category certificate physically at BOPEE office Jammu/ Srinagar upto **29-10-2022 (till 02.00 p.m.)** failing which they shall be treated as open merit candidates if otherwise eligible, without any further notice.
- No document(s) shall be accepted through e-mail.
- Such candidates, who have registered themselves under some reserved category but do not possess the valid category certificate, shall be considered as OM candidates subject to their eligibility in the OM.

Now, therefore, it is notified that:-

- The candidates who have qualified NEET-UG-2022, and have registered themselves online and uploaded their documents up to the prescribed date, the Board has prepared Provisional Merit List (PML) of such candidates which is annexed as **Annexure “A”** to this Notification, for objections, if any, up to 29-10-2022 (till 02:00 P.M).
- Any candidate who desires to make a representation against the position assigned to him/her in the PML, may do so by reporting physically at BOPEE office Jammu / Srinagar upto 29-10-2022 (till 02:00 P.M.).** Such representations shall be disposed-off in accordance with the rules. No representation(s) / objection(s) shall be accepted after the last date i.e. 29-10-2022. In case no representation is received, the PML notified by the Board shall be treated as final. Further, Board also reserves the right to make any corrections / changes in the records as may be found necessary on the basis of documentary evidence.
- The Board shall notify the schedule for submission of online preferences/counseling forms by the candidates separately. For the said purpose, the candidates are advised to remain in touch with BOPEE website www.jkbopee.gov.in for day to day updates.
