



SHRADHANJALI

Shri A S Wazir, a highly decorated engineer, who retired as Chief Engineer and was crusader to foster the culture of honesty, trustworthiness by his unique and unblemished contributions, passed away on October 19, 2022 at an age of 76 years. In his 34 years of marvelous service career in the department, Shri A S Wazir had done acts and deeds in performance of his duties which are so eventful and exemplary in their nature that these have not just left behind an everlasting impression in history but have also inculcated and inspired present generation to work with more vigour and dedication for Nation.

Shri A S Wazir was born in October, 1946 as youngest son of Thakur Jagat Ram, resident of a remote village of Bariot of district Udhampur who served in J&K State Irrigation Department at Kashmir valley. Tragedy hit the family by sudden demise of father at an early age. Shattered childhood and financial crisis brought into his life by this disaster, did not deter him back from marching ahead in life. He struggled under the patronage of his mother Late Smt. Nirmal Devi. After completing primary education in Govt. Schools of Tehsil Reasi with bright academic career, Shri A S Wazir joined REC Srinagar, Kashmir in September 1962 after having distinguished himself in Jammu & Kashmir University by securing 1st Position in Pre-University examination of the State. During his stay in the Engineering College, Shri A S Wazir dominated almost every aspect of college life. Besides being first class first student throughout his career, he was aquo animo in front of sports and cultural activities as well. He captained College Volleyball team, College Hiking and Kabaddi Team and brought laurels to the College in various spheres. It was on account of these

unique contributions that Shri A S Wazir was awarded 'Allround Best Certificate of Merit' by College authorities. He passed B.E. Degree in November 1967 getting first class first with distinctions entitling him academic Meritorious Gold Medal. He did Law Graduation later. State Public Service Commission found Shri A S Wazir first on its list of selection for Engineering Services of J&K State. Accordingly he joined Govt. Service as Assistant Engineer PWD in 1970. With all these ethical and technical possessions in him, together with his varied experience of handling successfully, many tough and odious assignments, overcoming series of challenges, having mental toughness and endurance with instinct of going for breath taking and risky constructional adventures, Shri A S Wazir developed into awe-inspiring personality in the Civil Engineering profession of State Govt. 'Legendary, Exemplary and Innovative Professional Engineer' is how he is described by one and all who knew him. He had a unique and distinctive quality of being in the high esteem of the masses during his service career in PWD. Affectionate and heart touching stories narrated by people of far-flung areas and from cities, expressing interior of their mind for respect in token of selfless contribution to the cause of masses, showed how his services were valued by all sections of the society. The act of bestowing such type of heart touching tributes given to this Legend, in the shape of Civil Awards like Prestigious 'Raja Jambu Lochan Award', 'Man of the year Award', Citations by the Civil Societies wherever this Officer served, as a mark of respect and affections for marvelous contribution, is in itself a unique gesture, were never heard earlier. State Administration also did not lag behind in appreciating and encouraging this one of the finest state Civil Engineer and sought after person to take any type of tough assignment, by decorating him with State Govt. Meritorious Service Gold Medals, (twice), His Excellency the Governor's Commendation medals during Governor's Rule in the State, (twice), Civil Awards by Autonomous Bodies like JDA, Municipalities where Officer worked and by other Social Organizations during his service career in different capacities in J&K State Engineering Departments in token of his memorable achievements. Shri A S Wazir has a record of unique achievements to his credit during his working in State Govt. Brief revelation of a few of his courageous achievements which inculcated State administration to contemplate the name of Officer for meritorious awards are:-

Toughest ever assignment of Reconstruction of Bridges and restoration of colonies and other Infrastructures submerged in Salal Dam lake: The Dam submerged the entire network of roads, tracks, bridges and the surrounding villages. Reconstruction of infrastructure, restoration of communications and resettlement of villagers was proving nightmarish for the Govt. Reconstruction of this entire Infrastructure and working in water body was cumbersome and a risky job. Many Engineers showed reluctance and some even refused to take up the assignment, thereby putting Government in awkward position and the department in an embarrassing situation. But, Shri A S Wazir, the then Executive Engineer accepted the challenge, put himself up in a small and isolated hut near the work site along with his family and worked tirelessly, round the clock, and fast-tracked the multifarious tasks. He reconstructed prestigious Kantham Bridge over Chenab and other bridges and roads in record time. Govt was highly impressed by this accomplishment. In recognition of his services he was awarded 'Meritorious Service Gold Medal,' the honour never given to any state Engineer. Restoration of Terrorism Affected Infrastructure : He was promoted to the post of Superintending Engineer and sent to Rajouri-Poonch where terrorists had blown and damaged important installations like bridges, drainage crossings, and other engineering structures at strategic locations mainly to disrupt army movement which had been a regular phenomenon since long. He worked overtime and speedily shoulder to shoulder with Army and restored the infrastructure to enable smooth movement of civil and military vehicles. Army was highly appreciable of the work done by PWD under him. Despite peak of terrorism in the districts, development targets were successfully achieved by this Officer. Seeing the accomplishment in record time, District Development Commissioner Poonch recommended him for President's Medal for his selfless services of high order in the militancy inflicted district.

Developing Jammu City: In 1991-92, Shri A S Wazir was transferred to Jammu Municipal Corporation (JMC) during Govt of India funded multi-crore Jammu City Core Area Development Programme where he worked as a crusader. He streamlined the engineering system and put a stop to the corrupt practices prevalent in the department. He restored transparency and professional perfection in the execution of the assigned work. He improved on Street Lights network which illuminated the neglected and crime prone areas. During 1991 Safaikaramcharis' strike, there was an imminent danger of an epidemic. Shri A S Wazir himself picked up the broom, joined hands with health dept and led from the front to keep Jammu clean. This initiative brought him public appreciation. In recognition of his dedicated services, Shri A S Wazir was awarded 'Meritorious Service Gold Medal' by the JMC. Civil Society honored him with the prestigious 'Raja Jambu Lo
