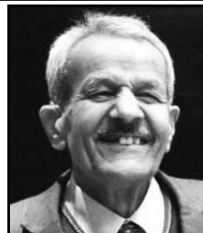

CRIME REPORT

Thief arrested, stolen vehicles recovered

UDHAMPUR: Police on Sunday arrested a thief and recovered two stolen vehicles (scooties) from his possession.

As per details, based on a complaint lodged by Parul Sharma, son of Parshotam Lal, resident of New Plot, Jammu regarding unknown thieves, who stole his Scooty (JK02CK 4197) from Bansa Morh, Tikri, Udhampur; FIR No. 142/2022 under section 379 IPC was registered at Police Station Rehambal. During investigation, a party of Police Post Tikri led by PSI Abdul Satar and assisted by Insp Rajesh Sharma SHO Rehambal under the supervision of Sahil Mahajan DySP Hqrs Udhampur zeroed in some suspects. During sustained interrogation, one suspect namely Sudanshu Gahi, son of Satish Chander, resident of Patoli Jammu broke down and confessed his crime. On his disclosure, police party recovered the stolen vehicle (scooty) from Lehnoo area. On his further disclosure, police party recovered another stolen scooty (JK02BH 2912) which was stolen from Nowabad area of Jammu against which FIR No. 128/2022 under section 379 of IPC has already been registered at Police Station Nowabad, Jammu.

Man arrested with illicit liquor

VIJAYPUR: Police on Sunday arrested a bootlegger and recovered 52 bottles of illicit liquor from his possession.

As per details, a party of Police Station Vijaypur headed by SHO Vijaypur, Insp Tribhuvan Khajuria under the supervision of SDPO Vijaypur; Priyanka Kumari during surprise vehicle checking near canal road Vijaypur; apprehended one Amarjeet Singh, son of Makhan Singh, resident of Rara, Ramgarh and recovered 52 bottles (180 ml each) of Desi Special Whisky from his possession which were meant for selling to general public. FIR No. 165/2022 under section 48(A) Excise Act was registered against him at Police Station Vijaypur and investigation started.

Blind murder case solved, accused held

UDHAMPUR: Police on Sunday solved a blind murder case by arresting an accused.

As per details, on October 20, 2022, a party of Police Post Tikri, while performing patrolling duty on NH noticed a male body at Mand area (near Prince Cafteria). The body was identified as that of Amit Gupta, son of Kuldeep Kumar, resident of Ward- 15 Shakti Nagar, Udhampur. On this inquest proceeding under section 174 of CrPC was initiated at Police Post Tikri. During the course of enquiry, a team of Police Post Tikri headed by PSI Abdul Satar and assisted by Insp Rajesh Sharma SHO Rehambal under the supervision of Sahil Mahajan Dy SP Hqrs Udhampur detained some suspects. During sustained questioning, one of them namely Tarun Sharma, son of Dev Raj, resident of Mand confessed that he had murdered deceased over some money dispute.

The inquest proceeding was converted into murder case and FIR No. 248/2022 under section 302 of IPC was registered at Police Station Rehambal. The accused was arrested and further investigation of the case is underway.
