IAF inducts indigenously...

for reposing confidence in indigenously developed platforms.

Air Chief Marshal Chaudhari said the capabilities of LCH are on a par with the helicopters of its class globally.

The helicopters were given a traditional water-canon salute that followed a multi-religious prayer ceremony.

The need for developing a light combat helicopter for mountain warfare was felt during the Kargil War in 1999.

"Subsequently, the IAF and HAL began exploring the possibility of developing the platform with a capacity to carry an adequate weapon load, sufficient fuel and still be capable of operating in the higher reaches of the Himalayan ranges," said an official. By mid-2010, the prototype of LCH completed a major flight test and it was deemed to have fulfilled the desired parameters.

In February 2020, the LCH was declared ready for production. In March, the Prime Minister Narendra Modi-led Cabinet Committee on Security (CCS) approved the procurement of 15 indigenously developed Limited Series Production (LSP) LCH at a cost of Rs 3,887 crore.

The defence ministry had said 10 helicopters would be for the IAF and five will be for the Indian Army.

The induction of the chopper comes at a time India and China are locked in a military stand-off in certain friction points in eastern Ladakh. The LCH has similarities with Advanced Light Helicopter Dhruv. It has a number of stealth features, armoured-protection systems, night attack capability and crash-worthy landing gear for better survivability, officials said.

The LCH is equipped with requisite agility, manoeuvrability, extended range, high altitude performance and all-weather combat capability to perform a range of roles including combat search and rescue (CSAR), destruction of enemy air defence (DEAD) and counter-insurgency (CI) operations.

The helicopter can also be deployed in high-altitude bunker-busting operations, counter-insurgency operations in the jungles and urban environments as well as for supporting ground forces. The helicopter can also be used against slow-moving aircraft and remotely piloted aircraft (RPAs) of adversaries. Officials said it would be a potent platform to meet the operational requirements of the IAF and the Indian Army.

They said state-of-the-art technologies and systems compatible with stealth features such as reduced visual, aural, radar and IR signatures and crash-worthiness features for better survivability have been integrated into the LCH for deployment in combat roles.

Several key aviation technologies like a glass cockpit and composite airframe structure have been indigenised, they said.

The future series-production version will consist of further modern and indigenous systems, they said.

Four LCH helicopters have already been accepted by the IAF.

The officials said IAF plans to procure more LCH in the near future. The helicopter has been tested under stringent operating conditions including at sea level, in desert regions and in Siachen.

The Army has a plan to acquire 95 LCH largely for a combat role in mountains.

Taj Mohi-ud...

Congress on August 26, launched the DAP in Jammu on September 26 with the support of dozens of former ministers, former MLAs and other prominent leaders of Jammu and Kashmir, most of whom had also resigned from the Congress in solidarity with him.

J&K Govt issues instructions for lodging, disposing of complaints against public servants

JAMMU: The J&K Government on Monday called for discouraging the culture of anonymous or pseudonymous complaints even as it issued a slew of instructions for lodging and disposal of the complaints against a public servant.

"In order to eradicate corruption for providing robust service delivery mechanism and increase participation of citizens in governance at various levels, citizens can draw attention of appropriate authority by making formal complaints regarding any action/inaction on part of public servant in writing or through other specified means for which complaint redressal mechanism has already been put in place in the Union Territory of Jammu and Kashmir," read the circular no 34 of JKGAD issued by Dr. Piyush Singla, Secretary on Monday.

It subsequently issued

instructions for proper lodging and disposal of the complaints against the public servants.

Among others, the government said, complaints can be lodged with appropriate authority by addressing a written communication either directly or through electronic mode or on portal available for this purpose.

"Appropriate authority, after gathering information about corruption, malpractices and misconduct may take appropriate action under law against such public servants in a time bound manner," it said.

It however reiterated that anonymous or pseudonymous complaints or complaints "containing vague, frivolous, non-specific allegations should not be taken cognizance of". Further, it said, complaints about sub-judice matters should also not be entertained.

It reiterated guidelines

regarding disposal of anonymous and pseudonymous complaints in the Departments and autonomous bodies etc.

It reiterated General Administration Department Circular (No. 29-GAD(Vig) of 2014 dated 31 July 2014), reiterated vide Circular (No. 22- GAD(Vig) of 2015) dated 10 July 2015) guidelines notified in consonance with those issued by the Department of Personnel & Training, Ministry of Personnel & Public Grievances & Pensions, Government of India on 18 October 2013 and Central Vigilance Commission's circulars on 25th November 2014 and 7th March 2016.

"As a standard procedure in these matters, the first step is to verify whether the complaints are filed by citizens who have provided their particulars viz. name, address and contact number," the government circular with reads adding, "In case, the com-

plaint is anonymous/ pseudonymous, the same is to be filed without any further action."

The culture of anonymous and pseudonymous complaints is to be discouraged, it said.

The complaints which have been filed by persons who have provided their identity should be processed in accordance with law, the circular reads further. "Where the complaints are genuine, due action be taken against the officers/officials under extant rules and guidelines issued by CVC as well as GAD."

The government also clarified that there are specific provisions in law to deal with fake, frivolous and motivated complaints.

"Importantly, in cases where it is established that the complaints were lodged with a malafide intention or an ulterior motive to harass or harm an innocent Government servant, neces-

sary action should be taken against such Complainants as per law."

It said under section 182 of Indian Penal Code, a person making a false complaint can be prosecuted.

"Under section 195(l)(a) of Code of Criminal Procedure, 1973 a person making a false complaint can be prosecuted on the basis of a complaint lodged with the court of competent jurisdiction by the public servant to whom the false complaint was made or by some other public servant to whom he is subordinate," it added. It said, if a person making a false complaint is a public servant, departmental action may also be considered against them as an alternative to prosecution.

The government said that these instructions have been brought to notice of all administrative departments and autonomous bodies etc., public servants and general public for strict adherence.

NC's fight against abrogation of Article 370 still on, says Farooq

SRINAGAR: National Conference (NC) president Farooq Abdullah Monday said the party is fighting a legal and a political battle against the abrogation of Article 370 at multiple-levels as he urged people to play their part by registering as voters for the imminent state election. Abdullah's remarks came in Kokernag area of south Kashmir's Anantnag district where he made a brief stopover while on way to Chenab valley for a four-day tour.

Interacting with party workers, he urged them to get eligible youths to get registered as voters in their respective areas.

"The party is fighting a

just, democratic, legal, and political battle against the decisions of August 5, 2019 at multiple levels," Abdullah said, referring to the revocation of Articles 370 and 35-A, and the bifurcation of the erstwhile state into two Union territories. The former Union minister, however, said that the people of J-K will also have to play their role by registering and subsequently coming out in large numbers to vote, whenever elections are held.

"Our region is at crossroads, it requires us to remain united as never before. It also requires our party men to educate and inform people about the designs of the anti-JK forces," he added.

11 new COVID cases in J&K

SRINAGAR: Jammu and Kashmir recorded 11 new COVID cases on Monday that took the overall infection tally in the region to 4,79,174, officials said.

No COVID-related fatality was reported in the past 24 hours and the death toll stands at 4,785, they said.

All the new cases were from the Kashmir valley, officials said.

There are 114 active cases in the Union Territory, while the overall recoveries has reached 4,74,275, they said.

There were at present 51 confirmed cases of mucormycosis (black fungus) in Jammu and Kashmir, they added.

200 rail stations to be revamped, India to have 400 'Vande Bharat' trains in future: Vaishnaw

AURANGABAD (Maha): As many as 200 railway stations across the country will get a facelift with modern amenities, Railways Minister Ashwini Vaishnaw said here on Monday.

He attended the foundation stone laying ceremony for a coach maintenance factory at the Aurangabad railway station in central Maharashtra.

"Tendering process for 47 railway stations is completed while physical work has started at 32 stations," he said.

He said the railways is being transformed.

"The government has prepared a master plan to revamp 200 railway stations. Overhead spaces will be created on the stations which will have world-class facilities including waiting lounges and food courts, besides amusement facilities for children," the minister said.

Vaishnaw also said that railway stations will act as the "platform" for the sale of regional products.

Speaking on the contribution of the Marathwada region in Maharashtra in the making of Vande Bharat trains, the minister said, "The country will have 400 'Vande Bharat' trains in future and 100 of these trains will be manufactured in the coach factory at Latur in Marathwada. The necessary

changes in the factory are already being made".

Currently, three Vande Bharat trains are operational and the latest one, between Mumbai Central-Gandhinagar, was launched last week.

The first coaches of the upgraded version of Vande Bharat will roll out from Marathwada Rail Coach Factory at Latur in 13 to 14 months, he said.

Newly launched Vande Bharat trains have generated interest outside India too and therefore coaches required for them will be manufactured at the Marathwada factory. All necessary preparations have been completed. As many as 1,600 coaches will be manufactured at the factory, Vaishnaw said.

The rail coach factory in Latur will provide a fillip to development of Marathwada and due to it, other related projects will also be set up and employment will be generated on a large scale, the minister said.

Vaishnaw said the government doesn't give the reason regarding the 'Rate of Return' for sanctioning of a project.

He said all parts of the country are now being connected either by highways or railways under the PM Gati Shakti scheme, and parts of Marathwada will also be linked.

The coach maintenance facility in Aurangabad has the capacity of 18 coaches, but Maharashtra Leader of Opposition in the Legislative Council, Ambadas Danve, demanded that this capacity be expanded to cater to 24 coaches.

Vaishnaw instructed officials to review Danve's demand and send a proposal in the next 15 days.

Speaking on the occasion, Minister of State for Railways and Jalna MP, Raosaheb Danve said the Central government has sanctioned Rs 11,000 crore for Maharashtra, which was Rs 1,100 crore earlier.

Union Minister of State for Finance Bhagvat Karad demanded to undertake high-speed railway projects along the newly undertaken A u r a n g a b a d - P u n e Expressway.

Aurangabad MP Intiaz Jaleel demanded the ROR condition be kept aside while sanctioning projects for regions like Marathwada.

Lok Sabha MP from Latur Sudhakar Shrangare and former state minister Sambhaji Patil Nilangekar; both BJP members, thanked Vaishnaw and junior Railway minister Raosaheb Danve for Latur getting the rail coach factory.

Nilangekar said, "The rail coach factory is the first such facility in Maharashtra."

BJP let down people of J&K on all fronts: Congress

JAMMU: Jammu and Kashmir Congress chief Vikar Rasool Wani accused the BJP on Monday of putting the Union Territory's interests and development "subservient to the pleasure of its vested interests".

He said the "lack of cohesion and vision" has made the people of Jammu and Kashmir suffer on the development front.

Addressing a meeting convened to discuss the current political scenario of Jammu and Kashmir and organisational affairs at the party headquarters here, the Pradesh Congress Committee (PCC) president made a particular mention of the Bharatiya Janata Party (BJP) and dared its leadership to list its achievements with regard to fulfilling the developmental needs of the people of Jammu and Kashmir.

"Despite being in power at the Centre and in Jammu and Kashmir, the party has failed miserably when it comes to governance and let Jammu and Kashmir down

on all fronts," he said, adding that the BJP has nothing to showcase as its achievement.

Slamming the saffron party for putting Jammu and Kashmir's interests and development "subservient to the pleasure of its vested interests", Wani, in a statement, said, "The treachery and deceit of the BJP is haunting the people of Jammu who reposed their unflinching faith and support to it with the hope that Jammu may perhaps get a better deal as during the days of its wilderness in the opposition, BJP leaders were crying hoarse over discrimination and neglect."

He accused the BJP of reversing some of the prestigious projects launched during the tenure of the Congress government for the Jammu region.

"Not only on the front of development, but equally in terms of instilling a sense of confidence among people, the BJP has miserably failed," Wani said.

Referring to the issues confronting the people of Jammu and Kashmir, the

Congress leader said in the absence of an elected government, the lieutenant governor-led administration has failed to give a push to the schemes and projects aimed at overall development and welfare of various areas and different segments of the society.

"We will keep pursuing and highlighting every issue, major or minor, to see Jammu and Kashmir progress and prosper, notwithstanding the odds," the Congress leader said, adding that the support, cooperation and feedback of people will be useful for the party to get their grievances addressed timely and properly.
