JAMMU: Police on Wednesday solved a hit and run case by arresting an accused.

As per details, information was received at Police Station Kahnachak through reliable sources regarding an accident between a car and motorcycle (JK02CS 9518) driven by one Ashok Kumar, son of Bato Ram, due to which bike-rider Ashok Kumar and his wife (pillion-rider) Asha Devi got injured and later Asha Devi succumbed to injuries during treatment in hospital. Rahul Mahajan, after putting in strenuous efforts, arrested accused driver (JK02CT 0608) namely Bownkesh Razdan, son of D Razdan, resident of Lane-1, Paragti Nagar, Upper Barnai Jammu.

JAMMU: In a quest to stem menace of illegal mining, a multi-pronged strategy was devised by Jammu Police in which police teams of Police Station Bishnah, Police Posts Gujjar Nagar and Phallain Mandal acted stringently on specific inputs and raided at different locations in their respective areas and seized 5 vehicles involved in illegal mining.
