



CRIME REPORT

Theft case solved; trucker & two associates arrested, stolen items worth Rs 22 lakh recovered

JAMMU: Police on Thursday solved a theft case by arresting three thieves and recovered stolen items worth Rs 22 lakh.

As per details, a complaint was lodged at Police Post Narwal by one Deepak Kapoor stating that his company Attar logistics has sold some batteries, solar panels and UPS to a customer namely Arshad Ahmed Butt of Srinagar but articles were not delivered by truck driver. FIR No. 242/2022 under section 407 of IPC was registered at Police Station Bahu Fort and investigation started. After this, a team of Police Post Narwal under the supervision of SDPO East Syed Zaheer Abbas Jafari led by SHO Bahu Fort Inspr Nayat Ali assisted by Incharge Police Post Narwal PSI Lalit Kumar; after putting in strenuous efforts, rounded up three suspects namely Mohd Raffiq, son of Mohd Sadik, resident of Sheikh Daud Colony, Batmaloo; Bashir Ahmed, son of Abdul Ghani, resident of Pital Bagh, Pampor and Irshad Ahmad Bhat, son of Ab Aziz Bhat, resident of Batwara, Srinagar. During sustained questioning, accused confessed their involvement in crime and on their disclosure all stolen items were recovered from Srinagar. It is pertinent to mention that recovered items were worth Rs 22 lakh. The whole operation was done under the close supervision of SP South Mamta sharma.

JAMMU: Continuing its drive against drug trafficking and substance abuse, Police on Thursday nabbed a notorious criminal and recovered 250 gm Ganja and a sharp-edged weapon from his possession at a Naka point on Gazian road area.

As per details, a team of Police Station Miran Sahib constituted under the supervision of SDPO R S Pura Surinder Singh and led by SHO Miran Sahib Insp Zaheer Mushtaq rounded up a suspect and on search, recovered 250 gm Ganja along with a sharp-edged weapon was recovered his possession.

The accused, identified as Sudershan Vishwal, son of Indira Mani, resident of Odisha at present Gazian road, Miran Sahib, was arrested and FIR No 123/2022 under sections 8/15 of NDPS Act and 4/25 of Arms Act was registered against him at Police Station Miran Sahib.
