Nominations/Applications from eligible and willing candidates are invited for filling up of the post of Presiding Officers of two Food Safety Appellate Tribunals established by the Department of Health and Medicai Education, Government of J&K vide SRO No.42 of 2016 dated 10.02.2016 as per rule 3.2.2 of the Food Safety and Standard Rules, 2011.

a) Qualification and terms of Office of Appellate Tribunal No person shall be qualified for appointment as a Presiding Officer of an Appellate Tribunal unless he is or has been a District Judge and has not attained the age of 65 years on the date of appointment and shall be permanent resident of the UT of Jammu and Kashmir.

b) Terms and conditions of service of Presiding Officer.

1. Term of office: The Presiding Officer of the Appellate Tribunal shall hold office for a term of five years from the date on which he assumes office or until he attains the age of 65 years, whichever is earlier.

2. Filling of vacancy: If for reason other than temporary absence, any vacancy occurs in the office of the Presiding Officer of the Appellate Tribunal, then the Central Government or the UT Government, as the case may be, shall appoint another person in accordance with the provisions of the Act to fill the vacancy and the proceedings may be continued before the Appellate Tribunal from the stage at which the vacancy occurred.

3. Salaray and allowances of Presiding Officer: The Presiding Officer of Appellate Tribunal shall be paid such salary as admissible to a serving District Judge of the UT in which the Appellate Tribunal is located.

Provided that if the Presiding Officer is in receipt of any retirement benefit by way of pension, gratuity, employer's contribution to Contributory Provided Fund, etc. the pay of such Presiding Officer shall be reduced by the gross amount of pension or employer's contribution to the Contributory Provided Fund or any other form of retirement benefit, if any, drawn or to be drawn by him.

4. Travelling Allowance: The Presiding Officer while on tour or on transfer (including the journey undertaken to join the Appellate Tribunal or on the expiry of his term with the Appellate Tribunal to proceed to his home town) shall be entitled to travelling allowance, daily allowances, transportation of personal effects and other similar matters at the same scale and at the same rates as are applicable to a District Judge of the UT in which the Appellate Tribunal is located.

5. Leave Travel Concession: The Presiding Officer shall be entitled to Leave Travel Concession at the same rates and at the same scale as are applicable to a District Judge of the UT in which the Appellate Tribunal is located.

6. Conveyance: The Presiding Officer shall be entitled to a staff car as applicable to a District Judge.

7. Facilities of Medicai Treatment: The Presiding Officer of the Appellate Tribunal shall be entitled to medical treatment and hospital facilities as provided in the Service Rules as are applicable to a District Judge in the UT in which the Appellate Tribunal is located.

c) Willing and eligible in-service candidates may apply through proper channel in the prescribed application proforma, (available on the official website of Health and Medicai Education Department: www.hme.jk.gov.in. Only those applications will be considered which are received through proper channel.

d) Retired District Judges shall send their applications as per the prescribed format alongwith testimonials.

e) The terms and conditions of assignment will be governed by the provisions of the Food Safety and Standard Act, 2006 Rules and Regulations framed thereunder from time to time.

f) The application forms, duly filled completed in all respects, alongwith all requisite documents, must be reach the office of Secretary, Health & Medicai Education Department, Government of J&K, Civil Secretariai, Srinagar/Jammu by or before 5.00 PM in 20.10.2022.
