Bids must be accompanied with cost of Tender document in shape of **e-challan through Treasury indicating Treasury Voucher No. & date, e-NIT No. and name of work duly crediting to 0059 (Revenue) favoring Executive Engineer PWD (R&B) Const. Divn. No. I Jammu and upload the same i.e treasury challan/receipt, Earnest money/Bid security in shape of CDR/FDR/BG pledged to Executive Engineer PWD (R&B) Const. Divn. No. I Jammu. The CDR/FDR/BG shall be valid for 45 Days beyond the bid validity period. The original instruments in respect of cost of documents, EMD and relevant documents of L1 be submitted to the Executive Engineer PWD (R&B) Const. Divn. No. I Jammu at the time of allotment.**
2. The electronic bidding system would not allow any late submission of bids after due date and time as per server time. Bidders may modify their bids by uploading their request for modification before the deadline for submission of bids. For this, the bidder need not to make any additional payment towards the cost of tender document. For bid modification and consequential re-submission, the bidder is not required to withdraw his bid submitted earlier. The last modified bid submitted by the bidder within the bid submission time shall be considered as the bid. For this purpose, modification/withdrawal by other means will not be accepted. In online system of bid submission, the modification and consequential-submission of bids is allowed any number of times. The bidders may withdraw his bid by uploading their request before the deadline for submission of bids; however, if the bid is withdrawn, the re-submission of the bid is not allowed. Subject: Final Selection List-cum-Allocation of Cadres & Departments for remaining Class-IV Posts under the provisions of the Jammu & Kashmir Appointment to Class-IV (Special Recruitment) Rules, 2020, advertised vide Notification No. 01 of 2020 dated 26.06.2020.

NOTIFICATION

Whereas, the General Administration Department, vide No. GAD/Mtg/RB-IV/50/2020 dated 22.06.2020, forwarded the requisition for filling up 8575 Class-IV posts pertaining to various departments under direct recruitment, in accordance with the provisions of the Jammu and Kashmir Appointment to Class IV (Special Recruitment) Rules, 2020, notified vide S.O.184 of 2020 dated 04.06.2020; and

02. Whereas, in terms of SRO 99 of 2008 dated 07.04.2008, read with S.O. 184 of 2020 dated 04.06.2020, the required qualification for appointment to Class-IV posts under Direct Recruitment is as under:

"Minimum Matric and Maximum 10+2"

03. Whereas, the Jammu and Kashmir Services Selection Board (JKSSB), vide Notification No. 01 of 2020 dated 26.06.2020, advertised these 8575 Class-IV posts under District/Divisional/Union Territory Cadres; and

04. Whereas, the JKSSB conducted the OMR based Objective Type Written Test Examination for the aforesaid Class-IV posts belonging to various departments in three batches on 27th, 28th February and 1st March, 2021; and

05. Whereas, based on the performance of the candidates in the OMR based Objective Type Written Test Examination, the JKSSB notified the merit/score of the candidates; and

06. Whereas, in terms of the Jammu and Kashmir Appointment to Class IV (Special Recruitment) Rules, 2020, notified vide S.O.184 of 2020 dated 04.06.2020, the selection for Class-IV posts is to be made on the basis of a Written Test and additional weightage to the candidates in possession of Certificate of being a Widow, Divorced Women, Casual Worker etc., as also being a Domicile of a District/Division; and

07. Whereas, after taking note of the representations/ grievances, the Board, in terms of Rule 5(5) of the Jammu and Kashmir Appointment to Class-IV (Special Recruitment) Rules, 2020, called upon the candidates to furnish their preferences for allocation of Cadres/Departments, online w.e.f. 26.03.2021 to 01.04.2021, which was later extended up to 02.05.2021; and

08. Whereas, the Selection Committee constituted for this purpose prepared the Provisional Selection List for 5175 Class-IV posts in Phase-I and the same was placed before the Board for deliberations and approval; and

09. Whereas, the Board in its 190th meeting held on 15th of October 2021, approved the Provisional Selection List-Cum-Allocation of Cadres for 5175 Class-IV posts (out of total 8575 posts), and the same was notified vide No. SSB/Secy/Class-IV/2021/7072-81 dated 15.10.2021; and

10. Whereas, the Final Selection List, along-with allocation of cadres/departments in respect of 5175 candidates, was forwarded to the General Administration Department, vide letter No. SSB/Secy/Sel/Class-IV-2021/7103-11 dated 18.10.2021. However, among these, 60 posts were kept unfilled/reserved for want of certain clarifications; and

11. Whereas, while finalizing the selection for these 5175 posts in Phase-I, the Horizontal Reservation of 4% to the Physically Challenged candidates could not be applied and similarly, Horizontal Reservation of 6% earmarked for Ex-Serviceman was partially applied on account of pending clarification/s from the Competent Authority; and

12. Whereas, after the receipt of clarifications from the Competent Authority, the Jammu and Kashmir Services Selection Board initiated the process of Counselling-cum-Documents Verification for the leftover vacancies and in order to fill up the 320 posts earmarked for Persons with Disabilities, the JKSSB called candidates belonging to such category for Document Verification vide this office Notification No. SSB/Secy/Class-IV/2021/2549-56 dated 08.11.2021, which was conducted from 15.11.2021 to 18.11.2021, at Jammu/Srinagar; and

13. Whereas, the selection process for the remaining posts was initiated strictly as per the provisions contained in the J&K Reservation Act/Rules, while considering all 8575 posts as a one unit and applying reservation rules/extant guidelines, the MRC candidates figuring in the reserved categories in the 1st selection list of 5175 candidates have been considered under the Open Merit which necessitated change of category in respect of some candidates. Also, a need has arisen due to such change in reserved categories to reallocate cadres of several candidates. Besides, there are cases involving changes both in category as well as cadre; and

14. Whereas, in the meanwhile, the General Administration Department, vide communication No. GAD-MTGORB/316/2021-09-GAD dated 28.01.2022, informed that 27 posts of Estates Department shall be treated as withdrawn, besides re-allocation of departments for 11 already selected candidates may be made due to non-availability of 06 and 05 posts in Horticulture and Estates Departments respectively. Further, the candidature in respect of 60 posts which was kept unfilled in Phase-I of selection process has been found ineligible thereby making these posts available at this stage. Consequently, 3422 posts are now available for being considered for filling up in Phase-II (8575-5175+60-38=3422); and

15. Whereas, against these, 80 posts are required to be kept reserved in view of the following directions of the Hon'ble Central Administrative Tribunal, Srinagar in OA NO. 1831/2021 titled Peer Mohd Arif and Others V/S Union Territory of J&K and Ors: "In the meantime, the respondent shall not finalize the select list with regard to the deaf and hard of hearing category as per Govt. order dated 05.11.2021 till next date of hearing";

16. Whereas, taking into account the aforesaid aspects, the Selection Committee in the Board, prepared the Provisional Selection list and placed the same before the Board in its 201st meeting held on 23.04.2022. The Board, after deliberating all the aspects of the selection process, approved the Provisional Selection list/Allocation of Cadres viz; District Cadre, Divisional Cadre and UT Cadre, comprising 3200 candidates only, as recommended by the Selection Committee; and

17. Whereas, the Services Selection Board, vide Notification No. SSB/Secy/Sel/Class-IV/2021/4074-80 dated 25.04.2022, issued the Provisional Selection List-cum-Allocation of Cadres for these Class-IV posts under provisions of the Jammu & Kashmir Appointment to Class-IV (Special Recruitment) Rules 2020. The same was, however, withdrawn vide Notification No. SSB/COE/Class-IV/2021/4174-80 dated 29.04.2022 on account of various deficiencies; and

18. Whereas, having regard to the representations received in the Board from various candidates and after rectifying the omissions/deficiencies noted in the withdrawn provisional selection list, the revised provisional selection list was prepared and the same was, accordingly, placed before the Board in its 204th meeting held on 23.06.2022. The Board deliberated the matter and, accordingly, approved notification of the Provisional Selection list/Allocation of Cadres viz; District Cadre, Divisional Cadre and UT Cadre, comprising of 3422 candidates for Class-IV posts; and

19. Whereas, the SSB, vide Notification No. SSB/Secy/Sel/Class-IV/5095-5102 dated 01.07.2022, issued the Provisional Selection List-cum-Allocation of Cadres in respect of 3422 Class-IV posts as approved by the Board under provisions of the Jammu & Kashmir Appointment to Class-IV (Special Recruitment) Rules 2020 and sought objections from candidates regarding the said provisional list.

20. Whereas, in response, JKSSB received numerous representations majority of which were related to release of withheld recommendations, requests for change in cadres, complaints against inclusion of Graduates in the provisional selection list etc. All the representations were examined on merit and reflected in the Final Selection List, wherever necessary

21. Whereas, upon consideration of objections/representations so received, the Final Selection List was prepared and placed before the Board in its 211th Meeting held on 30.09.2022; and

22. Whereas, the Board, after deliberations and taking note of the fact that while finalizing the selection for 5175 Class-IV posts during the Phase-I, the Horizontal Reservation has not been applied for the Physically Challenged Persons, while as it has been partially applied for the Ex-Servicemen, approved the Final Selection List cum-Allocation-of-Cadres in respect of remaining 3422 Class-IV Posts, advertised vide Notification No. 01 of 2020 dated 26.06.2020, besides change in cadre/category/department in respect of candidates as mentioned in Annexure B, C and D. The Board, also approved allocation of new departments to the already 11 candidates selected during Phase-I, for whom the vacancies were not available in the earlier allocated departments (Annexure-E).

Now therefore,

- (i) The Final Selection List for 3422 Class-IV Posts in District/Divisional/Union Territory Cadres, advertised vide Notification No. 01 of 2020 dated 04.06.2020, is hereby notified as per Annexure-A to this Notification.
- (ii) The Change in Cadre/Category/Departments in respect of some already selected candidates (under Phase-I) is hereby notified as Annexure B, C & D.
- (iii) Re-allocation of departments in respect of 11 candidates for whom the vacancies were not available during the Phase-I, is hereby notified as Annexure-E.
- (iv) The recommendation for selection in respect of each candidate shall be subject to fulfilment of the minimum/maximum qualification as required for Class-IV posts.
- (v) The Final Selection List shall be subject to outcome of the writ petition(s), if any, pending in the court of law.
- (vi) The Final Selection List shall also be subject to the outcome of any enquiry involving candidate(s), figuring in this Selection List.
- (vii) Formal recommendations to the concerned Indenting Department i.e. General Administration Department, shall be made separately.
