'Anusandhan" National Foundation Research (NRF) will realise Prime Minister Narendra Modi's vision of India's science driven growth, said the Union Minister, Dr Jitendra Singh while chairing the monthly joint meeting of Union Secretaries of all the Science Ministries Departments, at Science Centre here on Friday.

The Minister said, the NRF, envisaged by PM Modi, will catapult us to the league of handful of developed nations pioneering new research in new frontiers, he

vation and entrepreneurship in the fields of Natural Sciences including Mathematical Sciences. Engineering Technology, Environmental and Earth Sciences, Health

and Agriculture. Secretary, Department of Science & Technology, Dr. Abhay Karandikar informed the Minister that he convened the first meeting of Implementation Committee recently. The

Draft Rules & Regulations will be ready by next week and once finalized, it will be tabled in Parliament.

Principal Scientific Adviser (PSA) to the Government of India, Prof. Ajay Kumar Sood said, a proposal of names for the 16-member NRF Governing Body is also under finalization. It will include 6 Experts, 5 Industry representatives and 1 Humanities expert. The NRF will connect to Tier 2 & Tier 3 institutions since 11% of its budget is earmarked for their Capacity Building.

Dr Jitendra said the Executive Council of NRF is mandated not only to monitor the progress of the different projects but also to analyse the accountability of the funding at different level stages. NRF will promote the culture of research and innovation India's universities, colleges,

R&D laboratories and give further impetus to Clean energy research in India and Mission Innovation, he said.

Dr Singh stressed that Tier 2 & 3 Institutions will need handholding so that they can absorb the funds. Besides, he said, the NRF will bring about sweeping changes in the work culture as Industry will have to come forward to take risk cover and await the gestation.

Dr Jitendra Singh said the NRF will hike the R&D spending in the country.

The demarcation between the Public and Private sector will be bridged and there will be integration. NRF will also act as a think tank, it has the mandate of deciding the themes on which the projects have to be undertaken and funded, and deciding on foreign tie-ups," he said

RTO officials urged district officers to continue working with enthusiasm towards this objective and emphasized that violators should not only be penalized, but their driving licenses, registration of vehicles, and commercial permits

that across all the districts of Kashmir Division, 303 driving licenses, 52 registration certificates of vehicles, and 305 commercial permits were suspended or cancelled in the last two quarters, beside this during the Q1 & Q2 of the financial year, 43297 new vehicles were registered. Also, 2604 fresh permits were issued and 9792 renewed; 2627 fresh fitness certificates were issued and 14256 renewed; 17599 fresh driving licenses were issued and 17956 renewed, besides 6594 vehicle transfer cases were completed in the first two quarters.

RTO Kashmir officials reiterated the importance of prioritizing a smooth and reliable public transport system to enhance the convenience of the general public. "By implementing an efficient public transport system, the number of cars on the roads can be significantly reduced, thereby alleviating traffic congestion. It will not only ensure ease of mobility for the residents but also conand environment friendly transportation", an official said. It is important to mention

DUSOO PAMPORE: The Saffron harvesting season in Kashmir runs from mid-October to late November. Saffron is one of the most expensive spices in the world, and it comes from the stigmas of the purple flower of the plant. Saffron is also referred to as "Red Gold". Pampore area is the famous for Saffron cultivation, and out of total 5,707 hectares of land under saffron cultivation in Kashmir, more than 90 per cent is in Pampore Tehsil of Pulwama district.

According to Saffron growers, after years of losses, we were in depression and most of the farmers were changing their crops.

Fayaz Ahmad a Saffron farmer from Khrew area of Pampore, said Saffron was cultivated on large scale in rural areas of district Pulwama in the past.

However, due to different obstacles in Saffron cultivation, growers shifted to other horticulture crops and today Saffron crop is limited to the Pampore and its adjacent areas.



Musavir Ahmad, a young saffron grower from Dusoo Pampore told the State Times, "Saffron fields are shrinking drastically as illegal construction of residential houses and other buildings continues. Revenue officials are watching but no action is taken against the culprits. I am

just 20 year old and we have several acres of Saffron land in Dusoo and Lelhar area, my father is taking care of this land, we are getting good yield but I don't understand why people are constructing their residential houses in Saffron field."

He added, that there are hundreds of Kanals of other open land in the area but people are destroying saf-

meadows attracts Pampore tourists from everywhere to witness the yellow, maroon and purple colour of blossoms that bloom beside giant Chinars and harvest time resembles a festival for villages in the area.

The Saffron farmers of Dusoo area are still waiting for Saffron blossoms. "Due to the constant dry , hot and humid weather this year, we do not expect that we will get more productions this year, may be it will be less,"he said. Meanwhile the Director

substantive evidence review: HC **STATE TIMES NEWS**

JAMMU: In a recent pronouncement of legal significance, the Jammu and Kashmir and Ladakh High Court has underscored a critical legal principle pertaining to the

challenge of detention orders. The Court, consisting of a division bench led by Chief Justice N. Kotiswar Singh and Justice Rajesh Sekhri, has asserted that the pre-emption of detention orders through legal recourse prior to their execution effectively precludes the subsequent contention that such orders should be invalidated due to an absence of a "live link" between the present circumstances and the conditions prevalent at the time the detention orders were originally issued.

The Court's rationale is rooted in the notion that the act of pre-emptive challenge, by its nature, forestalls a comprehensive assessment of whether the grounds and evidentiary basis for a detention order were substantively justified. The Court articulat-

ed this principle eloquently: "...But if the petitioners and the appellants have taken recourse to the legal remedy to challenge the order of detention even before it was executed, it is not open for them to contend that it should be quashed because there is no live link between the existing/subsequent situation and the previous situation when the order of detention was passed, overlooking that they succeeded in pre-empting the order by challenging it at the pre-execution stage, never allowing the matter to proceed so as to examine the most crucial question whether there were sufficient material or grounds to pass the order of detention."

Pre-emptive challenge of detention orders hindering

This seminal legal doctrine emerged from a case originating from the suspension of a detention order pursuant to the Prevention of Illicit Traffic in Narcotic Drugs & Psychotropic Substances Act of 1988. The appellants mounted a multifaceted challenge, asserting that the immediate suspension of the detention order, as initiated upon their motion, ran counter to the guiding principle of circumspection when granting interim orders in cases of preventive detention. The respondents, in response to the detention order issued against them, posited its illegitimacy, contending a violation of Article 21 of the Constitution of India and challenging the veracity of their implication in a drug-related case while already on bail. After a comprehensive evaluation of the petitioner's arguments, the Court discerned the presence of a prima facie case necessitating the suspension of the detention order, culminating in an order dated 11.05.2023 that temporarily halted the detention process. The Court invoked legal precedents, citing Secretary to Govt of India vs. Alka Subhash Gadia (1992) and Deepak Bajaj Vs. State of Maharashtra (2008), contending that preventive detention orders can be subject to challenge beyond the five conditions delineated in the Alka Subhash Gadia case. Notwithstanding this latitude, the Court emphatically emphasized that a detention order could not be invalidated solely on the basis of the temporal lapse and the argument that there existed no "live link" between the detention order and the prevailing circumstances, even when the challenge to the detention order was initiat-

ed prior to its execution. Upon scrutinizing the grounds of detention, the Court adjudged them to be meticulously specified and legally sound. The Court opined that the temporal delay in executing the detention order did not suffice to vitiate the order, particularly in light of the authorities' active monitoring of the petitioner's activities subsequent to his release on bail. The Court, consequently, concluded that none of the five conditions for challenging the detention order, as established in the Alka Subhash Gadia case, were met in the present matter.

The bench astutely noted that the respondent had been granted bail on November 11, 2022, and the detention order was issued approximately four months later, on April 27, 2023. It was judiciously observed, "From the pleadings of the writ petition relating to the detention order, it appears that the authorities were considering the activities of the writ petitioner since his release on bail also, and hence, it cannot be definitively said, without examining the records, that the delay of four and a half months had severed the live link."

In its final deliberation, the Court declared that the existence of a "live link" between the impugned activities and the detention order remained indeterminate without a comprehensive review of the records. Consequently, the interim order that suspended the detention order was deemed inappropriate. Consequently, the bench allowed the appeal and the order of detention was upheld.
