In pursuance of the Notification No. 082-BOPEE of 2023 dated the Board has conducted Online Counseling for admission to MS/BPT courses- 2023 in the Government/Private 20.09.2023. BAMS/BUMS/BPT Colleges/Institutions of the UT of J&K. w.e.f. 22.09.2023 to 25.09.2023.

That one of the BPT institute namely Jammu College of Physiotherapy filed a writ petition before the Hon'ble High Court of J&K & Ladakh at Jammu vide WP(C) No.2427/2023, CM No.5694/2023 titled Jammu College of Physiotherapy V/s UT of J&K & Ors and the Hon'ble High Court passed an Order dated 20.09.2023, the operative part of which is reproduced as under:-

"In the meantime, it is ordered that the Notification No.076 issued by the Respondent No.2-BOPEE shall be read to the exclusion of BPT Courses and that the Respondent No.2-BOPEE to conduct the counseling for admission to BPT courses independently for the session 2023-24 without any NEET related regime. This direction is subject to objections from the other side."

That in view of the above directions of the Hon'ble High Court of J&K. and Ladakh, the Board has not allotted the seats to the candidates for BPT Course in the respective College/Institution namely Composite Research Centre (CRC), Bemina Srinagar and Jammu College of Physiotherapy (JCP), Jammu as notified vide Notification No.076-BOPEE of 2023 dated 02 -09-2023.

The candidates who have been allotted seats provisionally on the basis of Merit-cum-Preferences filled by them during the online process of counseling to BAMS/BUMS courses-2023 is hereby notified as per Annexure-A to this Notification, which shall remain available only on the official website of the Board: www.jkbopee.gov.in-

The candidates shall have to report to the respective Colleges/Institutions allotted to them for completion of admission process upto 18.10.2023 (till 04:00 p.m.) w.e.f. the date of uploading of this Notification on website of JKBOPEE along with the following documents in original:-

## Note:

- 1. The admission of the candidates shall be purely provisional and liable to be cancelled in case any information furnished by any candidate(s) proves to be false / fabricated and action as warranted under law shall be initiated against them.
- 2. If any candidate(s) is found to have concealed any information, his/her selection/admission shall be cancelled ab-initio and fine/penalty shall also be imposed upon him / her as may be deemed proper by the Board in accordance with the laid down rules.
- All the provisionally selected candidates are advised to visit their respective allotted College/Institution for fee and other relevant documents required by respective colleges.
- 4. It is the responsibility of the concerned Heads of the Institutions/Colleges to check and verify the documents and eligibility of the provisionally selected candidates before allowing them to join in their respective Institutions/College.
- 5. It is hereby implored upon the management of all Colleges/Institutions to ensure the veracity of documents, particularly the Category Certificates wherever the admission is to be granted in lieu of a particular Reserved Category.
