Whereas, vide Notification No. JKSSB-COE0EXAM(UT)/48/2023-03 (7207093) dated 04.07.2023, the Board called upon candidates falling under consideration zone, to indicate their order of preferences for various items, through the online link, which was kept available on the official website and subsequently Document Verification was conducted both at Jammu/Srinagar Office; and
