Pursuant to Notification No. 092-BOPEE of 2023 dated 15.10.2023, the Mop Up Round of counselling (Physical) for Upgradation/Allotment of Seats of NEET MDS course was conducted by the Board on 15<sup>th</sup> October, 2023 at BOPEE office Jammu/Srinagar simultaneously. It shall be sole responsibility of the Colleges/ Institutions concerned to ensure proper checking/verification of documents/ eligibility as per the DCI guidelines before the candidate is allowed to join the course he/she is provisionally selected for.
