Maa Katyayani - Sixth Navdurga Worshiped in Navratra

aa Katyayani is the sixth form of Maa Durga. So the sixth day of Navratra is dedicated to Durga Katyayani. She is called Katyayani because she was born as the daughter of Sage Katya of Katya clan. Sage Katyayan performed very hard penance of Maa Bhagvati. It was his wish that Maa Durga be born as his daughter. The Goddess acceded to his request.

Meanwhile, army of the powerful demon Mahishasura, who could only be killed by

a warrior Goddess, had reached heaven to overthrow the Gods from their abode. The Trinity of Gods - Brahma, Vishnu and Shiva, got infuriated and they created the Goddess Durga, who was a culmination of the powers of all deities. Sage Katyayana had the first privilege to worship her, so she was also named Katyayani.

Another myth goes by that she was born to Katyayana as his daughter on the 14th dark of the month Asvina. Katyayana worshiped her for three days, 7th, 8th and 9th of the bright fortnight in the same month and killed Mahishasur on Vijayadasami. Her worship done with devotion and faith leads to four objects - Dharma, Artha, Kama and Moksha.

This is the daughter form of Durga. Here she is a loving daughter. She is epitome of love but won't hesitate to rise up in anger to defend righteousness and Dharma. It is believed that Maa Katyayani persistently battles against the evil and deceitful enti-

She has three eyes and four arms. One left hand holds a weapon and the other a lotus. The other two hands respectively display defending and granting gestures. Her skin appears golden in colour. Her mount is a lion.

To get God Krishna as a husband gopis worship Maa Katyayani in Vraj. So she is established as the Queen of Vraj. There is a very famous Temple in Delhi (Chhattarpur) of Maa.

This Shrine is dedicated to Goddess Katyayani, whose Darshan can be availed only on Ashtami falling in every month. Otherwise, the Darshan of Goddess Katyayani can be made throughout the days of Navratra.

The golden image of Katyayani attracts the attention of devotees with its huge size and sheer divinity.

The worship of Maa Durga as Goddess Katyayani on sixth day of Navratra has its very importance. Yogis and Sadhaks penance on Agya Chakra on this day.

Humans offer everything to Maa while worshiping on this day. She gives blessings to her devotee. Red and white colour should be used to wear on this day.

The Adolescent Virgin Goddess in the southern tip of India, Devi Kanya Kumari is said to be the avatar of Devi Katyayani. She is the Goddess of penance and Sanyas. Women take a bath early in the morning and worship the idol of Goddess Katyayani, carved out of wet sand.



Ashada Navratra - Gupt Navratra or Varahi Navratra

shada Navratra, also known as Gupt Navratra or Varahi Navratra, is a 9-Anavratra or varian restriction, and day festival dedicated to Goddess Varahi Devi. It is observed in Shukla Paksha of Ashad month. These are very auspicious days for the Tantriks, Sadhaks for Saadhna and also for any other specific Tantrik pooja to resolve the materialistic problems. By keeping fasts, chanting Shlokas and Mantras, the devotees show their regard for the Goddess. It is believed that during Navratra, the Goddess promptly heeds to devotees and fulfills wishes. She is worshipped in the three forms of the divine femininity, as the remover of vices, as the bestower of wealth and prosperity and as the Goddess of wisdom.

Tantrik Anusthan on Ashad Navratra

Vamtantra conducts Tantrik Anusthan of Shri Durga Saptashati Samput Path, Shrimad-Devi Bhagwat, Devi Mahaatmya and other texts invoking Goddess Durga are cited by Vamtantra during this period of nine

Ashad- Gupt Navratra Puja Benefits

Ashada Navratra Puja is famous in several parts of India for Tantrik Pooja. It is celebrated with primary intention to propitiate Shakti and to bestow upon us all wealth, prosperity, knowledge both sacred and secular, and all other required positive energies. Goddess Durga is known for alleviation of distress; showing great kindness towards the distressed. A particular ritualistic worship of



the Goddess is performed daily, along with the recitation of the Durga Saptashati. Everyone is inspired to do the maximum number of Japa of the Navarna Mantra "Aim hreem kleem chaamundaayai vichche"or the Mantra of their own tutelary God. Sincere spiritual devotees keep fast on all the nine days, or at least once in each of the three-day periods by taking milk

Samput Path

Samput are the clearly and explicitly stated words or Mantras or Slokas usually followed with a specified Path of any Hindu scriptures used in the begining, middle or end of the Mantra Patha. The Samput makes the Mantras more intense, stronger, or more marked. The Path when done with Samput Mantra becomes thousand times more valuable than the original one and gives escalated results.

There are distinctly separate Samput Viddhis to be used with all sacred scriptures. But every scripture has the potential to be used with a Samput Mantra. The Samput holds a special significance in Durga Saptashati Path or in other Mantras and are to be used very carefully and cau-

Samput Path of Durga Saptashati

Vamtantra conducts special Durga Saptashati Samput Path in these auspicious days. In the period of Ashad Navratra consecrated chants of Durga Saptashati are done which is a part of Markandeya Purana. The Mantras in the book narrate how Goddess Durga was empowered and provided with divine weapons by our Trinity of Gods (Brahma, Vishnu and Shiva) to decimate Mahishasura and various other

With the correct use of Samput Mantra along with Shri Durga Saptashati Path persons achievement is of highest order and any impossible can be acquired.

Samput Path of Durga Saptashati Protects a Person From the Following:
