Notorious drug peddler booked under PIT-NDPS Act

Mohd Ganaie resident of Chadoora has been booked under PIT-NDPS Act after obtaining formal detention orders from the competent authority. The booked notorious drug peddler has been detained and subsequently lodged in Kot Bhalwal Jail Jammu.

Pertinent to mention here that many cases are registered against the said notorious drug peddler in various police stations and was promoting drug addiction by supplying drugs to local youth of District Budgam. Despite his involvement in many FIRs, he did not mend his activities and was again involved in promoting drug abuse trade by supplying drugs to local youth.

20 vehicles seized, 8 arrested for illegal extraction & transportation of minerals

SRINAGAR/JAMMU: Acting tough against the persons involved in illegal extraction and transportation of minerals, police on Sunday seized 20 vehicles and arrested 8 persons in Baramulla.

As per details, a party of Police Station Kunzer seized three vehicles (Tippers) and arrested 3 persons, involved in illegal extraction and transportation of minerals at Batpora Kunzer. The accused drivers have been identified as Aijaz Ahmad Dar son of Ab Khaliq resident of Bungam, Bilal Ahmad Shah son of Ab Rahman resident of Takia Gonipora & Gh Qadir Khan son of Ab Rahman resident of Mangloora Kunzer.

Accordingly, a case under relevant sections of law has been registered at Police Station

Kunzer and further investigation has been initiated.

Meanwhile, a police party led by SHO Police Station Tangmarg and Incharge Police Post Palhallan seized 6 vehicles (5 tractors & 1Excavator) and arrested 5 persons (driers), involved in illegal extraction and transportation of minerals at Kulhama Tangmarg & New Colony Palhallan. The accused drivers have been identified as Javid Ahmad Tantray son of Ghulam Mohammad Tantray resident of Sherpora Pattan, Mehraj Din Ganaie Son of Abdul Gani Ganaie resident of Burran Pattan, Intiyaz Ahmad Miyan Son of Mohammad Afzal Miyan resident of Buran Pattan, Ishfaq Ahmad Sheikh son of Gh Ahmad, Kaisar Ahmad Sheikh son of Mohd Subhan both residents of Check Ferozpora Tangmarg.

Accordingly, cases under relevant sections of law have been registered at respective police stations and further investigation has been initiated.
