Pursuant to the Notification No.102-BOPEE of 2023 dated 25.10.2023, the 2nd Physical Round of Physical Counseling was conducted by the Board for admission to the M.Sc Nursing Course- 2023 in the Government/Private Colleges/Institutions of the UT of J&K on 27.10.2023 simultaneously at BOPEE offices Jammu/Srinagar.

The list of candidates who have been Upgraded/Allotted seats provisionally on the basis of Merit-cum-Preferences filled by the candidates on the day of counselling is hereby notified as per Annexure-A to this Notification, which shall remain available on the official website of the Board: www.jkhopee.gov.in only. The candidates shall have to report to the respective Colleges allotted to them for completion of admission process upto 31.10.2023 till 4:00 p.m. along with following documents in original:-

- Marks Card of B.Sc. Nursing / Post Basic B.Sc. Nursing / B.Sc. Hons. Nursing Course
- 2. Domicile Certificate of UT of J&K and for the candidates of UT of Ladakh, ST Certificate issued by the Competent Authority of Ladakh shall be treated as Domicile
- 3. One Year work experience after B.Sc. Nursing / Post Basic B.Sc. Nursing
- 4. Certificate as a registered Nurse or Registered Midwifery or equivalent with any State/UT Nursing Council.
- Category Certificate, wherever applicable.
- 6. Any other Certificate/Document as may be required by the College Authorities.

It shall be sole responsibility of the Colleges/Institutions concerned to ensure proper check and verification of documents/eligibility as per the eligibility/guidelines issued by INC / J&K Paramedical Council before the candidate is allowed for admission and in case of any discrepancy in the requisite eligibility/documents, the same shall be reported to the Board for further course of action under rules.

The provisionally selected candidates shall have to mandatorily report for admission to the allotted College/Institutions by or before 31.10. 2023 upto 4:00 p.m. along with their relevant certificates in original, failing which they shall not be eligible for further rounds of counseling, if any, conducted by the Board.

The Heads of the concerned Colleges/Institutions are advised to furnish the shortfall, if any, on 31.10.2023 upto 5:00 p.m. positively to enable the Board to take further necessary action in the matter.

#### Note:-

- 1. All the Heads of the concerned Institutions/Colleges are requested to keep their admission counters open on Holidays/Off days to facilitate the candidates to complete their admission process well in time and the candidates should in their own interest, avoid waiting for the last day for completing the admission formalities as the delay in such matters has the potential of causing hardships to the candidates only.
- 2. The admission of the candidates is purely provisional and shall be liable to be cancelled in case any information furnished by any candidate(s) proves to be false / fabricated, and action as warranted under law shall be initiated against those candidates.
- 3. The candidate(s), if any, found to have concealed any information, his/her selection/admission shall be cancelled ab-initio and fine/penalty shall also be imposed upon him/her as may be deemed proper by the Board in accordance with the laid down
- The Heads of the concerned Colleges/ Institutions shall keep record of the admissions and send the shortfall of the candidates, if any, who have not completed their admission within the prescribed time mentioned above through E-mail viz. coejakhopee@gmail.com & helpdeskjakhopee@gmail.com on 31.10.2023 upto 5:00 p.m positively alongwith hard copy duly signed by the Head of the concerned
- 5. The Heads of the concerned Institutions/Colleges are advised to release the documents/certificates and fee to those candidates who have been Upgraded during the 2nd Round of counselling so that they may be able to report in the respective allotted colleges well in time.
- 6. It is hereby implored upon the management of all Colleges' Institutions to ensure the veracity of documents, particularly the Category Certificates wherever the admission is to be granted in lieu of a Reserved Category. So far as the Persons with Disability are concerned, if selected under Open Merit or against a Reserved Category, it shall be ensured that his/her PwD Certificate/Eligibility is in conformity with Rights of Persons with Disabilities Act 2016 and wherever required shall refer the matter to the concerned Medical Board i.e. Government Medical College Jammu/Government Medical College Srinagar to assess such candidate(s) and make recommendations based on which Institution(s) shall take further necessary action. In case any candidate who does not

fulfill the benchmarks of eligibility, he/she shall not be admitted to the course/college and the matter shall be reported to the Board for further course of action. However, such a seat shall be deemed to be vacant and shall be filled in subsequent round(s) of counselling, if any, conducted by the Board.

7. As notified vide Notification No. 102-BOPEE of 2023 dated 25.10.2023, the provisional selection letters have already been issued to the candidates on spot after their participation in the counselling and the candidates were advised to report to the allotted College/Institution immediately after receipt of provisional selection letter. In case any candidate fails to join the allotted College/Institute upto 31.10.2023 he/she shall not be eligible to participate in the subsequent round of counselling i.e. Upgradation/Mop up round, if any, conducted by the Board.
