





11 arrested for assault, criminal trespass

SAMBA: Police on Thursday arrested 11 accused for assault and criminal trespass in two separate cases in Samba.

Police has arrested seven 7 accused for assault on one Sarpanch at Dhora, Samba and four 4 accused for criminal trespass committed at Krandi,RakhAmbTalli amba. Sarpanch of Sundla Panchyat of block Khoon of district Udhampur had alleged that his car collided with one youth of Dhora, Samba, following which he was kidnapped, was brutally beaten up by a group of persons and remained admitted to GMC Jammu due to head injury. Man convicted for theft, sentenced 3 years

UDHAMPUR: Court of Sub-Judge Ramnagar (JMIC) convicted an accused person namely Darshan Singh alias Mardotu, son of Ramesh Singh, resident of Marta for commission of offence under section 457/380/279/201 RPC registered at Police Station Basnatgrah and sentenced to 3 years imprisonment and fine of Rs 4000.

Brief facts of the case are that On May 4, 2019, an information was received in the Police Station Basantgarh that one person namely Darshan Singh, son of Ramesh Singh, resident of Marta Tehsil Ramnagar had stolen one Tata mobile bearing registration number JK14F 3222 from Thaldu Pul and on same night he had also broken the locks of five shops at Dudu market and stolen the property of Rs 1,18,000 (approx).

In this regards, police station Basantgarh registered a case vide FIR No. 04/2019under section 457,380,379,201 RPC and after concluding the investigation chargesheet of the case was filed before the court of law for its judicial determina-

tion. Durial trial prosecution succeeded in proving the theft case beyond all reason able doubts and on the fact and circumstances of the case accused namely Darshan Singh has been convicted today by the Honble court of sub judge JMIC Ramnagar and sentenced to undergo 03 years imprisonment and a fine of Rs 4000.

Bootlegger nabbed with 70 bottles of illicit liquor state times news
