



### CRIME REPORT

## 17 vehicles involved in illegal mining seized

**SAMBA:** Continuing vigorous drive against illegal mining launched on the directions of SSP Samba Benam Tosh, Police has seized eleven (11) more vehicles which were being used for illegal mining in district Samba.

Police teams comprising of SHO Police Station Bari Brahmana Sumeet Sharma, SHO Police Station Purmandal Vijay Verma, SHO Police Station Vijaypur Sandeep Charak, SHO Police Station Samba Daljit Singh and Incharge Police Post Rakhambali PSI Davinder Singh under the supervision of SDPO Bari Brahmana Rahul Nagar, DySP Garu Ram, SDPO Vijaypur Rohit Kumar and Additional SP Samba Surinder Choudhary have seized eleven (11) more vehicles being used for illegal mining at different locations in Samba district.

The seized vehicles are :Three (03) Dumpers bearing registration Nos. JK02CG-5983, JK21E-2447 & JK19A-2923, two (02) tippers bearing registration Nos. JK02CS-9114 & one without registration No, six (06) tractor trolleys bearing registration Nos. JK08A-9963, JK21G-1766, JK21H-1732 & JK21J-5547 & two without registration No.

Meanwhile, on the directions of SSP Poonch Vinay Kumar Sharma, team of Police Station Poonch headed by Insp. Deepak Pathania SHO Poonch and assisted by PSI Rahul Angral In-Charge Border Police Post Khari under the supervision of Afrat



Hussain DySP Hqrs. Poonch conducted a drive against illegal mining and seized 06 Tractors/Trolleys.

The seized Tractors/trolleys include Tractor bearing Chasis No.AZZDK129001193 driven by Shakeel Ahmed, son of Abdul Majid, resident of Poonch; Tractor bearing chasis no. HZZDB75026893 driven by Tasveer Hussain, son of Mohd Bashir, resident of Degwar Maldiyalan; Tractor bearing Chasis no.AZZDH92288353 driven by Arshad Ahmed, son of Mohd Shabir, resident of Degwar Maldiyalan; Tractor bearing chasis no.AZZDG72233453 driven by Mumtaz Ahmed, son of Ghulam Rasool, resident of Degwar Maldiyalan; Tractor bearing chasis no.CZZG680297353 driven by Mohd Farooq, son of Majid, resident of Degwar Maldiyalan and Tractor bearing chasis no.HZZDR107165453 driven by Mohd Sajid, son of Mohd Shabir, resident of Chaktroo.

All the vehicles were extracting/carrying minor minerals from Betar Nallah, Poonch without any valid permission.

### Proclamation proceedings initiated against active terrorist

**BARAMULLA:** Baramulla Police in coordination with Revenue department has initiated proclamation proceedings under Section 82 of the Criminal Procedure Code (CrPC) against active terrorist Abid Qayoom Lone son of Abdul Qayoom Lone resident of Wussan Khoie Pattan who was allegedly involved in several acts of terrorism. In this regard, case FIR No 120/2023 under section 7/25 IA Act, 18, 20, 23, 38, 39 UA (P) Act, 4/5 Explosive Substances Act stands already registered against him at Police Station Pattan.

Senior Superintendent of Police (SSP) Baramulla Amod Ashok Nagpure while sharing the details said that Baramulla Police is committed to uphold the law and to ensure the safety and security of general public. We are working closely with other agencies to follow due process and bring such elements to justice.

These proceedings have been initiated against the terrorist who is evading his arrest as open non-bailable warrant dated 17/08/2023 could not get executed against him. Accordingly, proclamation notice under section 82 of CrPC issued by the Court of Additional Sessions Judge Baramulla dated 09/21/2023 has been past-



ed and circulated at his residence and other prominent places in his respective native villages along with revenue officials with the directions that the said wanted terrorist shall surrender before investigation officer or court of law otherwise further proceedings will be initiated accordingly against him. The Police Party was headed by SDPO Pattan assisted by SHO PS Pattan and In-charge Police Post Wussan. The exercise was carried out in presence of Executive Magistrate Pattan and Sarpanch, Lumerdar, Chowkidar of respective village.

Moreover, Baramulla Police also used drum beating to inform the general public about the ongoing efforts to apprehend the said active terrorist who is required in connection with investigation of above-mentioned terror related case.

In addition to these efforts, Baramulla Police is actively engaging the community to ensure a terror free District. Recent initiatives also include the introduction of community policing programs and heightened security measures.

The proclamation proceeding and property attachment are part of a comprehensive effort to address terrorism and maintain the rule of law. We urge the public to remain vigilant and report information that may assist in the apprehension of the active terrorist.

### Crime Branch raids shop at Vidhata Nagar

**JAMMU:** Sleuths of Crime Branch on Sunday carried out raid in a shop in at Bathindi connection with bank fraud case.

As per details, DYSP Shazia Mir along with her team of Crime Branch conducted raid at a Javed Habib Hair Cutting saloon at Vidhata Nagar, Bathindi in the building of Bajji Manzoor. The owner of the saloon are two brother namely Mohd Safer, and Asif Jeelani, son of Nazak Hussain, resident of Mendhar Ari, at present Flat No. 1109 Safa valley. The purpose of the raid was to conduct a search in the shop in regard in connection with FIR no 86/23 under section 419.420,467,468,471 Police Station Crime Branch for cheating to the Jammu and Kashmir bank for 9 Crores loan. During the search the team found 2 CPU which team carried with them for further investigation .

### Landmine blast in Rajouri, two army porters injured

**RAJOURI:** Two Army porters were injured in a landmine explosion near the Line of Control (LoC) in Rajouri district, officials said on Sunday.

Raj Kumar and Ashwani Kumar, both residents of Mangiote village, received splinter injuries in the explosion in forward Kalar area of Nowshera sector on Saturday, the officials said.

They said both the injured porters were shifted to a hospital.

As part of an anti-infiltration obstacle system, the forward areas are dotted with landmines which sometimes get washed away by rains resulting in such types of accidents, the officials said.
