has attached fresh assets worth more than Rs 35 crore that are "beneficially-owned and controlled" by the PFI "in the name of various trusts, companies and individuals" as part of its ongoing probe against the outfit and entities linked to it.

The PFI was banned by the Centre in September 2022 after the ED, the National Investigation Agency (NIA) and various state police forces carried out countrywide raids against its office-bearers and establishments.

The ED alleged that the real objectives of the PFI, formed in 2006 in Kerala but headquartered in Delhi, are "different" from the ones stated in its constitution.

"Real objectives of PFI include formation of an organisation for carrying out an Islamic movement in India through jihad,

though PFI masquerades itself as a social movement. "PFI claimed use of non-violent forms of protest but evidence reveals that the methods of protest employed by them

are violent in nature," the agency alleged.

It described some of the methods of protest used by the outfit for the preparation of a "civil war" by creating unrest and strife in the society, through "non-violent air raids, guerrilla theatre (street plays on social and political issues), alternative communication systems (non-mainstream media outlets) etc.". It alleged that the PFI deployed some methods of cruelty and subjugation like haunting and taunting officials, fraternisation (establishing unethical relations or contacts), mock funerals, interdict (a strong prohibitory order), Lysistratic non-action or sexual abstinence.

The agency said the PFI undertook civil disobedience of laws, propounded dual sovereignty (holding more than one sovereign), creating parallel governments and disclosing idencret agents in order to "undermine" the unity and sovereignty of the country.

The outfit deployed tactics of "politically-motivated counterfeiting", "preclusive purchasing" (buying strategic commodities in global markets to prevent an opponent from purchasing those), non-violent land seizure, seizure of assets, "selective patronage", dumping (selling a commodity at a price lower than its market value to pressure an opponent) etc.

It has also been alleged by the ED that the PFI gave arms training under the garb of physical education classes, where they imparted "offensive and defensive" manoeuvres using different variations of blows, punches, kicks, knife and stick attacks. The outfit, according to the ED, was imparting "intensive" violent training to its cadre for attacks using punches, kicks, blows and also weapons like knives, sticks, sickles and swords. The PFI has also been charged with being "actively involved" in "inciting" violence and "fomenting trouble" during the February 2020 Delhi riots. It has also been alleged that PFI and CFI (Campus Front of India, the PFI's student wing) members visited Hathras in Uttar Pradesh a few years ago with an intent to disturb communal harmony, incite communal riots and spread terror.

The ED has alleged that the PFI had planned to form a 'terrorist gang" by collecting deadly weapons and explosive devices to launch attacks on important and sensitive places and individuals with an intent to undermine India's unity, integrity and sovereignty, and disturb communal harmony.

The outfit has been accused of organising a training camp with an intent to cause disturbance during Prime Minister Narendra Modi's visit to Patna on July 12, 2022 and printing "incriminating" literature that had the potential to pose a

threat to the unity, integrity and sovereignty of the country. It has been alleged that the PFI conspired and raised funds from within the country and abroad through banking channels. "hawala", donations etc. for "committing and financing" terror acts across India. "PFI had more than 13,000 active members in Singapore and Gulf countries, including Kuwait, Oman, Qatar, Saudi Arabia and the UAE.

"PFI has formed well-defined district executive committees (DECs) for the non-resident Muslim diaspora living in the Gulf, which was tasked with collection of funds," the ED said.

The agency said it has seized assets worth a total Rs 61.72 crore as part of its probe, arrested 26 PFI members and filed nine chargesheets.

he said. Modi said at the conclave attended by 17 chief ministers and 18 deputy chief ministers from the BJP and its several allies that smooth governance, fast decision-making and transparency in governance have helped in attracting

The inability to translate financial support into tangible benefits for the people raises questions about governance and priorities," Chugh said.

SC frames slew of guidelines to eradicate child marriages

NEW DELHI: Terming the prevalence of "social evil" of child marriages as "sobering", the Supreme Court on Friday passed a slew of directions to the Centre, states and other authorities to eradicate the malaise.

In a 141-page judgment, a bench of Chief Justice of India D Y Chandrachud and Justice J B Pardiwala and Manoj Misra, therefore, issued several directions to the stakeholders under nine heads, including for appointment of officers solely responsible for discharging the functions of Child Marriage Prohibition Officers (CMPO) at the district level in the country.

The court further said, "Child marriage is a social evil, and its commission is a criminal offence. Despite the nearuniversal agreement on the ills of child marriage, its commission and prevalence have been sobering. Child marriage is the phenomenon of children being married before they attain the minimum legal age under the law."

whether the Prohibition of Child Marriage Act, 2006 would prevail over personal laws governing marriage, it said the Centre had failed to provide conflicting judgements of various high courts on the issue as claimed.

"The Prohibition of Child Marriage (Amending) Bill 2021 was introduced in Parliament on December 21, 2021. The Bill was referred for examination to the Department Related Standing Committee on education, women, children, youth and sports. The Bill sought to amend the PCMA to expressly state the overriding effect of the statute over various personal laws. The issue, therefore, is pending consideration before Parliament," said the bench.

Enforcement", the top court said, "State governments and Union Territories (UTs) must appoint officers solely responsible for discharging the functions of CMPO at the district level. These officers should not be burdened with additional duties that could impede their focus on preventing child

Observing the term child marriage was an "oxymoron", the bench said, "A child implies a person whose capacity to make legal decisions is not fully developed. On the other hand, marriage is an institution with legal standing... Marriage dictates the framework rules of permissible and impermissible social behaviours. However, a child is incapable of understanding the broad and serious obligations expected from members of a marital union."

Such marriages often deprive children of intellectual, social and psychological development and carry life-threatening risks, it underscored.

The top court opined child marriages needed an intersectional approach towards the vulnerabilities expe by children, especially girls from marginalised communities

"Intersectionality involves considering factors like gender, caste, socioeconomic status, and geography, which often increase the risks of early marriage. Preventive strategies should therefore be tailored to the unique needs of various communities and focus on addressing the root causes of child marriage, such as poverty, gender inequality, lack of education, and entrenched cultural practices," it said.

Framing guidelines, it said these would prioritise "prevention before protection and protection before penalisation" as it was cognisant of the impact that criminalisation has on families and

"To ensure effective use of penal provisions in the PCMA, it is imperative that there is widespread awareness and education about child marriage and the legal consequences of its commission, the bench said, adding it should not be understood to discourage prosecution of those who commit illegal acts. It directed the ministries of Women

and Child Development and Home in states and UTs to conduct quarterly performance reviews of CMPOs and law enforcement agencies to assess the effectiveness of child marriage prevention initiatives and response times besides outcomes of a reported case.

It fixed the district-level responsibility for prevention of child marriages and said, "In addition to the mandate of the CMPO ...the collectors and superintendents of police in each district across India shall also be responsible for actively preventing child marriages within their districts.

The top court further ordered the establishment of a specialised police unit to stop child marriages.

"Recognising the sensitivity unique aspects of child marriage cases a specialised police unit is deemed essential. The state Ministries of Home Affairs shall consider the viability of integrating the Special Juvenile Police Unit into the child marriage prevention

framework," directed the apex court. It also empowered magistrates to take suo-motu action and issue preventive orders under the title "Judicial Measures'

Strict disciplinary and legal action was directed to be taken against any public servant found to be in deliberate neglect of duty concerning child marriage cases.

Infamous Gulmarg land Scam: HC transfers Challan from Barmulla to Srinagar

JAMMU: In a much publicized Gulmarg Land Scam, Justice Rajnesh oswal of Jammu & Kashmir and Ladakh High Court allowed the appeal filed by CBI and transferred the case from Special Judge Anticorruption Baramulla to Special Judge CBI Srinagar.

applicant-Central Bureau Investigation(CBI) has preferred this application for transfer of charge-sheet, titled, "VOK vs Mehboob Igbal and others" pending before the court of learned Special Judge, Anti-Corruption, Baramulla to the court of learned Special Judge (CBI), Srinagar, on the ground that pursuant to the directions issued by the High Court of J&K vide its order dated October 9, 2020 in PIL No.19/2011, titled, as "Prof. S. K. Bhalla vs State of J&K and others", the applicant had approached the court of learned Special Judge Anti-Corruption, Baramulla for providing original documents to the applicant for conducting further and thorough investigation and for transfer of the charge-sheet to the court of Special Judge (CBI), Srinagar.

Both the applications of the applicant were dismissed by the court of Special Judge, Anti-Corruption, Baramulla vide order dated May 25, 2021 with the observation that the court cannot transfer the charge-sheet to the court of

coordinate jurisdiction and further no such direction for transfer of the charge-sheet to the court of Special Judge (CBI) Srinagar, has been issued by the High Court vide order dated

It is stated in the application that the supplementary charge-sheet, if any, is required to be filed before the designated court i.e. Special Judge (CBI) Srinagar as the matter has been further investigated by the applicant. It is further pleaded that supplementary charge-sheet is always filed before the court where the main charge-sheet is pending, therefore, the main charge sheet is required to be transferred to the designated court i.e. Special Judge (CBI)

Justice Rajnesh Oswal after hearing both the sides observed that in terms of the directions of the Division Bench of this Court, the applicant-CBI has been directed to conduct thorough investigation in all the cases wherein charge sheets have been filed by the Anti-Corruption Bureau and if necessary, file additional charge sheets in those cases.

High Court further observed that this is an admitted fact that the charge sheet in the instant case is pending before the court of Special Judge, Anti-Corruption, Baramulla and the said court has declined to transfer the

charge sheet on the ground that one court cannot transfer the case to another court of coordinate jurisdiction and that there is no direction by the Division Bench to transfer the case.

There are designated courts both in Jammu and Srinagar, to try the cases exclusively, which are investigated by the CBI. The Special Court at Srinagar, to try the cases, investigated by the CBI was constituted vide Government order 980-LD(A) of 2015 dated February 23, 2015.

In the instant case, the case was further investigated by the Central Bureau of Investigation (CBI) and once the Special Court at Srinagar has been constituted for exclusive trial of the cases investigated by the CBI, then the special court constituted for exclusive trial of the cases investigated by the CBI, can only conduct the

Justice Rajnesh Oswal further observed that so far as present case is concerned, in case the applicant is permitted to file supplementary charge sheet before the same court where the charge sheet filed by the ACB is pending, the private respondents may raise an objection with regard to the competence of the Special Judge Anti-Corruption Baramulla to try the case, when the special court to try the cases investigated by CBI has been established by the

The contention raised by the private respondents that the order pursuant to which the further investigation was conducted by the applicant is under review before the Division Bench of this Court as such, proceedings in the present application deserve to be deferred till the decision of the review by the Division Bench, is misconceived and as such, the same is rejected. If the proceedings are deferred, it would delay the disposal of the charge sheet. The judgment relied upon by the learned senior counsel does not lay down any law so far as the present case is concerned.

In view of the above this Court of the considered view that the charge sheet, titled, "VOK vs. Mehboob Iqbal and others" pending before the Special Judge, Anti-Corruption, Baramulla is required to be transferred to the court of Special Judge, CBI, Srinagar.

The Special Judge Anti-Corruption, Baramulla is directed to transmit the record of the charge sheet to the court of Special Judge CBI Srinagar forthwith.

The parties to appear before the transferee court on November 18, 2024. Court further observed that the CBI shall be at liberty to file supplementary charge sheet before the transferee court i.e. Special Judge CBI, Srinagar.
