Whereas, the Government of India approved the proposal for providing central assistance of Rs. 2000 Crore for 36384 displaced families from PoJK of 1947 and Chhamb displaced persons of 1965 and 1971 as one time settlement under Prime Minister's Development Package, 2015;
Whereas, as decided by the Government of India, the amount of central assistance of Rs. 5,49,692/- per family will be distributed through Direct Benefit Transfer (DBT) to the eligible beneficiaries by the Central Government directly and State Government will transfer the State's share of Rs. 308/- per family to the beneficiaries through DBT;
Whereas, vide Government Order No. 22-DMRRR of 2017 dated 27-03-2017 of Government of Jammu and Kashmir, sanction was accorded to the adoption and notification of the scheme approved by Ministry of Home Affairs, Government of India, for rehabilitation package of PoJK Displaced Persons of 1947 and Chhamb DP's of 1965 and 1971;
Whereas, vide Government Order No. 07-JK(DMRRR) of 2019 dated 11-12-2019 of the Government of Jammu and Kashmir which was in continuation of Government Order No. 22-DMRRR of 2017 dated 27-03-2017, sanction was accorded to the inclusion of those left-out Displaced Persons (DP) families of PoJK-1947 out of the families who initially opted to move outside the erstwhile State of Jammu and Kashmir but later returned and settled in Jammu and Kashmir, in the Rehabilitation Package approved by the Government of India for the Displaced Families of PoJK and Chhamb under Prime Minister's Development Package (PMDP), for Jammu and Kashmir;
Whereas, vide Government Order No. 31-JK(DMRRR) of 2023 dated 24-05-2023, the scheme of Central Assistance for one time settlement of displaced families of PoJK 1947 and Chhamb 1965 and 1971 settled in the Jammu and Kashmir was extended from 31-03-2022 to 31-03-2024 under the Rehabilitation Package approved by the Cabinet on 30-11-2016;
Whereas, vide Government Order No. 24-JK (DMRRR) of 2024 dated 15-03-2024, the scheme of Central Assistance for one time settlement of displaced families of PoJK 1947 and Chhamb 1965 and 1971 settled in the Jammu and Kashmir was extended from 31-03-2024 to 31-03-2025 under the Rehabilitation Package approved by the Cabinet on 30-11-2016;
Whereas, vide Govt. order no. 57-DMRRR of 2018 dated 11.10.2018, a scheme has been notified for disbursement of financial assistance to west Pakistani Refugees (WPRs);
Whereas, inspite of the extension of time limit of the schemes on numerous occasions, a lukewarm enthusiasm is shown by the remaining beneficiaries to apply for this scheme and to fulfil the deficient documents of their respective cases;
In the light of above mentioned details, through the medium of this notice the public in general and displaced families of PoJK 1947 and Chhamb Displaced families of 1965 & 1971 and West Pakistani Refugees (1947) who have not yet applied for availing the benefits of one time settlement schemes are also requested to apply to the Tehsildar concerned immediately and not later than 10th November, 2024.
