Two minutes silence was also observed and it was prayed to Almighty to bestow peace to the departed soul and give courage to the bereaved family to bear irreparable loss.

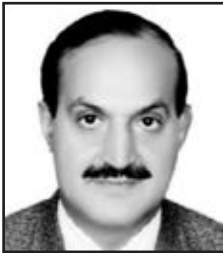

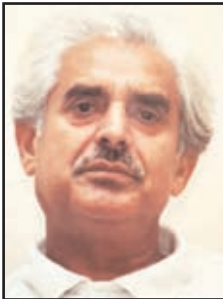
