NEW DELHI: The CBI, police, customs, ED or judges do not arrest people through video calls, the Indian Cyber Crime Coordination Centre (I4C) said in a public advisory issued in view of the rising cases of 'digital arrest' crimes in the country.

Terming it a scam, the federal cyber security agency cautioned people against falling victim to such crimes using

"Don't Panic, Stay Alert.

es DO NOT arrest you on video call," stated the advisory issued on Saturday.

The advisory depicted the logos of social media platforms like WhatsApp and Skype to showcase that calls for such scams are made using such platforms.

These social media platforms have said in the past that they are coordinating with cyber security agencies of the government to provide against such crimes.

The I4C urged people to report such crimes at the central helpline number 1930 or the website -- www.cyber-

Digital arrest is the name given to a cyber crime technique where fraudsters send an SMS or make video calls to a person posing as law enforcement agency officials fraudulently claiming that the individual or his close family members have been caught by a government investigative agency in a criminal activity like drugs trafficking or money launder-

The cyber criminal subsequently confines the person to their premises by asking them to keep their mobile phone cameras on as part of a 'digital arrest' and then seek money through online transfer to bail the victim out of this situation.

A good number of these new-age cyber crimes are virtually reported every day from various parts of the

7 killed as fire breaks out in shop-cum-residential building in Mumbai; CM orders probe

MUMBAI: Seven persons, including three minors, were killed after a fire broke out in a double-storev shop-cumresidential structure in Mumbai on Sunday morning, a fire official said.

The incident took place at 5.20 am at Siddharth Colony in Chembur area, he

Maharashtra Chief Minister Eknath Shinde later visited the site. He announced a high-level probe into the incident and a compensation of Rs 5 lakh for the kin of the deceased.

The ground floor of the structure was used as a shop and the upper floor as residence, an official said

The blaze was confined to the electric wiring and installations in the shop at the ground floor and spread to the upper floor, he said, adding it was a 'level-one'

Seven persons were injured in the incident. They were taken to the Rajawadi Hospital where all of them were declared brought dead, the official said.

Fire engines, water tankers and other assistance were rushed to the spot and the blaze was doused by 9.15 am, the official said.

The deceased have been identified as Paris Gupta (7), Manju Prem Gupta (30), Anita Gupta (39), Prem Gupta (30), Narendra Gupta (10), Vidhi Chediram Gupta (15) and Gitadevi Dharamdev Gupta (60), he

CM Shinde visited the site and met family members of the victims.

Later, talking to reporters, he said the incident was very unfortunate.

The chief minister announced a high-level probe in the incident and a compensation of Rs 5 lakh for the kin of the deceased. The cost of treatment of the injured persons will be borne by the government, he said.

Swachh Bharat campaign to focus on comprehensive sanitation, waste management

NEW DELHI: With the Swachh Bharat Abhiyan marking its 10th anniversary, the government is now planning to expand its efforts, focusing not only on eliminating open defecation but also on more comprehensive sanitation and waste management strategies, a senior official has said.

Swachh Bharat Abhivan is a country-wide campaign initiated by the government in 2014 to eliminate open defecation and improve solid waste management and to create open defecation free villages.

Asked about the road ahead, Vini Mahajan, Secretary, Department of Drinking Water and Sanitation, Ministry of Jal

Shakti, said they are now a critical component of the planning to expand its

from open defecation recognising that this practice was a significant curse we needed to eliminate. While progress has been made, there is still an ongoing need to identify families who lack toilets and ensure they receive them. It's equally important to keep existing toilets functional," the official said.

She emphasised the importance of catering to specific needs, such as providing accessible toilets for people with disabilities, and highlighted ongoing discussions with state governments to address these nuances.

"A lot of work is going into properly managing faecal sludge and setting up treatment facilities like STPs

In addition, there is a significant push toward better liquid waste management, particularly in terms of grey water reuse and recycling. Solid waste management is

also a key focus, especially in rural areas. "In cities, we know there is

an emphasis on segregation at source, but in rural areas, this is still an emerging practice. However, with 5 lakh vehicles for waste collection and over 3.5 lakh segregation sheds already established, progress is being made," she

"The government is also encouraging panchayats to adopt resolutions to avoid single-use plastics and promote composting of organic

"We are seeing panchayats actively working on creating value chains for dry waste and promoting the reuse of plastic. Around 3,000 units have already been set up for plastic waste reuse. Mahajan said.

"As Swachh Bharat moves forward, engaging all stakeholders is crucial," she said, adding the government is collaborating with youth, women, community leaders, and startups to introduce new technologies and innova-

"We are working to ensure that sanitation becomes everyone's business, making sure the entire ecosystem is involved," the official said.

10 die in flashfloods triggered by heavy rain in Meghalaya

SHILLONG: At least 10 people died, including seven of a family, in rain-induced flashfloods that rayaged Meghalaya's South Garo Hills district in the past 24 hours, officials said.

Incessant rainfall has triggered landslides in Gasuapara region of the district, they said on The family of seven were inside their home in

the remote village of Hatiasia Songma when a landslide struck on Saturday, a senior official The deceased include three minors.

Chief Minister Conrad K Sangma held a review meeting on the situation across the five districts of Garo Hills.

He expressed deep sorrow over the loss of lives. as three persons from Dalu and seven people from Hatiasia Songma were confirmed dead, the officials said.

Sangma has also ordered immediate ex gratia payment to the next of kin of the deceased.

Personnel of the National Disaster Response Force (NDRF) and SDRF have been deployed to carry out search and rescue operations in the worst-affected areas, they said.

During the meeting, Sangma suggested the use of bailey bridge technology for rebuilding efforts, which will allow for rapid assembly and transportation, the officials added.
