

12 quintals of adulterated Paneer seized, destroyed

STATE TIMES NEWS SAMBA: In a major crackdown on food adulteration, the Drugs and Food Control Organization (DFCO), Jammu, in coordiation with Samba Police, seized approximately 12 quintals of idulterated pan provisions of the Food Safety and Standards Act (FSSA).

Acting on specific intelligence and under the directions of Commissioner, Food & Drug Administration J&K, Smita Sethi, a joint enforcement team of Food Safety Officers, DFCO Samba, and Samba Police laid a naka near Police Post Rajpura. During the operation, two suspicious vehicles-a Swift car (PB06AL-2806) and a Tata Innova (HR39B-0400)-were intercepted while they were attempting to transport spurious paneer from Punjab towards Jammu via the border road.

Upon inspection, the team recovered around 12 quintals of substandard and foul-smelling paneer, suspected to be unfit for human consumption. Immediate testing was conducted using the Mobile Food Testing Van, which confirmed the adulteration. Legal samples were also drawn and sent for laboratory analysis, which further corroborated that the product was adulterated and unsafe. Both the vehicles were seized on the spot, and the paneer consignment was destroyed as per SOPs under the Food Safety and Standards Act. The team also confiscated relevant documents, bills, and address records associated with the consignment.

Terror hideout busted in Kupwara; AK rifles, rocket launchers recovered

of arms and ammunition, officials said on Thursday. Srinagar-based Chinar Corps of the Indian Army said a joint operation was launched by the Army and police on Wednesday in the Brijthor forest area in Warsun, Kupwara following a specific intelligence input. "During the search, security forces busted a hideout and recovered two AK series rifles, four rocket launchers, a

huge cache of ammunition and other war-like stores," the Chinar Corps said in a post on X. Body of missing soldier found in Kokernag, search continues for another

SRINAGAR: Security forces found the body of a soldier in Jammu and Kashmir's Anantnag district on Thursday, while a search operation to locate another missing soldier entered its third day, officials said here. The body of one of the two soldiers who went missing on Tuesday was found from the Gadole forests in the Kokernag area of Anantnag, the officials said, adding that a preliminary examination suggests that he died of hypothermia.

They said searches to track the other missing soldier are ongoing but dense vegetation, rough terrain and inclement weather The soldiers, both commandos of an elite para unit, went missing during a combing operation at Kokernag on Tuesday. The peration was launched two days ago in the Ahlan Gadole area, following inputs that terrorists were hiding there, the officials said. According to the officials, the two soldiers went missing after their communication line went out. Helicopters were pressed into aerial reconnaissance to locate the commandos. The Srinagar-based Chinar Corps unit of the Army said the operational team was caught in a severe snowstorm. "On the intervening night of October 6 and 7, an operational team on the Kishtwar range confronted a severe snowstorm and whiteout conditions in the mountains of southern Kashmir. Since then, two soldiers have gone out of communication," the Chinar Corps said in a post on X on Wednesday. "Intense search and rescue operations

have been launched but hampered due to prevailing adverse weather conditions," it added. Two persons booked for public misconduct; sentenced fine, community service

JAMMU: Jammu Police, South Zone, has once again reinforced the spirit of the reformed criminal justice system by ensuring accountability through community-based sentencing. On the action of Police Station Satwari, two individuals - Raj Kumar S/o Tara Chand and Rakesh Kumar S/o Jagar Mal, both residents of Chatha Mill, Jammu - were booked for public misconduct under the influence of alcohol. The Court imposed a fine of Rs 200 on Raj Kumar, while Rakesh Kumar was directed to perform community service for two days at Shiv Mandir, Narwal Pain, Satwari. This action reflects the reformative and rehabilitative intent of the newly introduced criminal justice framework, emphasizing corrective community engagement over mere punitive measures in minor offences.

Hotel owner, management booked for violation of Foreigners Act

UDHAMPUR: During routine checking of hotels conducted by the Police team of PS Udhampur, it was found that the owner/management staff of Hotel Samrat, Udhampur had failed to submit Form C, a mandatory online report for all foreign guests staying at their property, as required under the Foreigners Act. It was further revealed that a few days earlier, a foreign national had stayed at the said hotel, but the owner/management staff failed to report the stay to the SSP Udhampur who is also the Foreigners Registration Officer, as mandated under law. Accordingly, a case FIR No. 359/2025 under Sections 7/14 of the Foreigners Act has been registered at Police Station Udhampur. Further investigation is underway.
