JAMMU: The All Daily Wager Jammu & Kashmir Sangharsh Samiti launched a "No Pay, No Work" agitation, suspending non-teaching services in schools and other government establishments. The protest includes Mid Day Meal cooks, CPWs, ASHA workers, land donors, and others engaged under SRO-63 and SRO-43.

Union leaders accused the Education and Finance Departments of failing to implement minimum wages, regularisation, and compensation despite decade-long assurances. They claimed the crisis affects nearly 10,000 families and alleged bias in favour of outside investors over local contributors. Key demands include pending wage pay-

land donor compensation. A one-week deadline has been issued, failing which hunger strikes and mass demonstrations will follow.

Appealing for teacher support, the union held authorities accountable for any school disruptions caused by the strike.
