"This is a sui generis (unique) problem and there are wider concerns involved. Of course, there was a solemn undertaking but several factors need to be considered," Mehta submitted. He alleged that some people are spreading a specific narraive and giving a grim picture of the union territory.

During the hearing, CJI Gavai said the region continued to face security challenges and cited the Pahalgam terror attack. Senior advocate Gopal Sankaranarayanan, appearing for Zahoor Bhat, said, "Pahalgam happened under their

Mehta vehemently objected to the remark, saying, "What is their watch'? It is under our government. I object to this.'

Sankaranarayanan argued that the Centre had assured the court about restoring statehood in 2023 and said, "Much vater has flowed since then.

To this, Mehta retorted, "And blood too. This is a citizen before the Supreme Court who treats the government of India as your government and not my government."

Sankaranarayanan also said that the matter be placed before a five-judge Constitution bench, given that the original Article 370 judgment had been delivered by a bench of similar strength

He clarified that the applicants were not seeking to reopen the abrogation issue but merely enforcement of the Union's commitment "within a reasonable timeframe"

The solicitor general opposed the submissions, saying this cannot be done that too at the behest of interveners.

Senior advocate Maneka Guruswamy, appearing for MLA Irfan Hafiz Lone, argued that the continuing denial of statehood undermines the federal structure of the Constitution.

"If a state can be converted into a Union Territory like this, what does it mean for federalism? The J-K Assembly passed a resolution a year ago calling for statehood. Allowing Jammu and Kashmir to remain a UT sets a dangerous precedent," she

Citing Articles 1, 2, and 3 of the Constitution, she added, These provisions do not envisage converting a state into a union territory. The Union gave an assurance. What is the

consequence of not honouring that assurance for federalism?" "If this is permitted, any state can be downgraded to a UT if the government is inconvenient... tomorrow, it could be Ittar Pradesh or Tamil Nadu. This has never happened in

our constitutional history," another lawyer said. The solicitor general interjected, accusing the counsel of attempting to "create a grim picture" of the union territory

before the world. "Why are you getting agitated? Let him complete the submissions," the CJI told Mehta, drawing mild laughter in the

Counsel representing a group of Jammu-based lawyers submitted that citizens in the region were facing acute unemploy-

ment and stagnation in development projects "There is hardly any developmental work in the Jammu region. Legislators say they have no funds for local works. Despite incidents like Pahalgam, peace has largely prevailed and tourist inflows are high, and the Vaishno Devi yatra continues smoothly. Security concerns cannot be a perpetual excuse," the counsel said.

To this, SG Mehta responded by saying that the region had witnessed significant improvement.

"Jammu and Kashmir has progressed; everyone is happy... 99.9 per cent of the people consider the government of India as their own. These arguments are for some other forum, not this court," he said.

"Delay in the restoration of statehood would cause serious reduction of democratically elected government in Jammu and Kashmir, causing a grave violation of the idea of federalism which forms part of the basic structure of the Constitution of India," Bhat's plea said.

The assembly elections and the Lok Sabha polls were conducted peacefully in Jammu and Kashmir without any incident of violence, disturbance or any security concerns being reported, it said.

"Therefore, there is no impediment of security concerns, vioence or any other disturbances which would hinder or prevent the grant/restoration of the status of statehood to Jammu and Kashmir as had been assured by the Union of India in the present proceedings," the plea added.

Although Trump received a number of nominations for the orize, many of them occurred after the Feb. 1 deadline for the 2025 award, which fell just a week and a half into his first term. His name was, however, put forth in December by Republican Rep. Claudia Tenney of New York, her office said in a statement, for his brokering of the Abraham Accords, which normalised relations between Israel and several Arab states in 2020.

Nevertheless, Trump and his supporters are likely to view the decision to pass him over for the award as a deliberate affront to the US leader, particularly after the president's involvement in getting Israel and Hamas to initiate the first

phase of ending their devastating two-year-old war.

The peace prize, first awarded in 1901, was created partly to encourage ongoing peace efforts. Alfred Nobel stipulated in his will that the prize should go to someone "who shall have done the most or the best work for fraternity between nations, for the abolition or reduction of standing armies and for the holding and promotion of peace congresses.

Three sitting US presidents have won the Nobel Peace Prize: Theodore Roosevelt in 1906, Woodrow Wilson in 1919 and Barack Obama in 2009. Jimmy Carter won the prize in 2002, a full two decades after leaving office. Former Vice President Al Gore received the prize in 2007.

Obama, who was a focus of Trump's attacks well before the Republican was elected, won the prize early in his tenure as president.

"He got the prize for doing nothing," Trump said of Obama on Thursday. "They gave it to Obama for doing absolutely nothing but destroying our country."

As one of his reasons for deserving the award, Trump often says he has ended seven wars, though some of the conflicts the president claims to have resolved were merely tensions, and his role in easing them is disputed.

But while there is hope for the end of Israel and Hamas' war. much remains uncertain about the aspects of the broader ceasefire plan, including whether and how Hamas will disarm and who will govern Gaza. And little progress seems to have been made on the war between Russia and Ukraine, a conflict Trump claimed during the 2024 campaign that he could end in one day. (He later said he made that remark in jest.)

Trump invited Russian President Vladimir Putin to Alaska in August - but not Ukrainian President Volodymyr Zelenskyy for a summit aimed at reaching peace, but he left empty handed, and the war started by Russia's invasion in 2022 has

As Trump pushes for peaceful resolutions to conflicts abroad, the country he governs remains deeply divided and politically fraught. Trump has kicked off what he hopes to be the largest deportation program in American history to remove immigrants in the US illegally. He is using the levers of government, including the Justice Department, to go after his perceived political enemies. He has sent the military into US cities over local opposition to stop crime and crack down on immigration enforcement.

He withdrew the United States from the landmark Paris climate agreement, dealing a blow to worldwide efforts to combat global warming. He touched off global trade wars with his on-again, off-again tariffs, which he wields as a threat to bend other countries and companies to his will. He asserted presidential war powers by declaring cartels to be unlawful combatants and launching lethal strikes on boats in the Caribbean that he alleged were carrying drugs.

The full list of people nominated is secret, but anyone who submits a nomination is free to talk about it. Trump's detractors say supporters, foreign leaders and others are submitting Trump's name for nomination for the prize - and, specifically, announcing it publicly - not because he deserves it but because they see it as a way to manipulate him and stay in his good

The IG also said that counter-drone measures and air defence systems proved very effective during Operation Sindoor, but "we should not be overconfident and adopt modern technology to further enhance our systems".

"The 21st century warfare highlighted the use of drones unmanned aerial vehicles, missile systems and Artificial Intelligence in a big way. The BSF is not lacking behind in this race. We recently organised a 'school of drone warfare event at our academy in Gwalior to enhance the skill of the jawans and officers.

"If there is a need, we will utilise the latest training to counter enemy drones, and also inflict losses on them using our own drone technology," the officer said.

Anand also said the force is organising a full marathon in Jammu on November 9 to mark the diamond jubilee celebrations of the force, which was raised in 1965

"This is for the first time that we are organising this event with an objective to reach out to the border residents and convev a message of fitness and the need for a healthy lifestyle besides identifying local talent who will be groomed to take part in national and international sports events," the IG said.

HC seeks police officers' statements in case of Gujjar youth's death after 'torture' in Kathua

JAMMU: The High Court of Jammu and Kashmir and Ladakh has sought personal appearance of two police officers part of a Special Investigation Team (SIT) -- to record their statements in a case related to the death by suicide of a Guijar youth after alleged custodial torture in Kathua district earlier

A single-judge bench of Justice Wasim Sadiq Nargal passed the directions while hearing the case on Wednesday, asking the SIT head, who is the Superintendent of Police (Operations), and Sub-Divisional Police Officer (SDPO), Billawar, to appear in court on the next date of hearing on October 27.

Makhan Din (25), a Gujjar youth from the Billawar area, ended his life by consuming insecticide on February 4 after alleged police torture and recorded the act on a video, claiming innocence and denying any connection with terrorists, prompting separate probes by police and the local administra-

"Record reveals that when the matter was listed before this ourt on April 25, Neeraj Padyar, SDPO, Billawar, who was part of the SIT headed by SP (Operations) investigating the case, submitted that the SHO of Billawar police station already stood transferred and the other two officials, against whom the complainants have levelled allegations, were not posted in the same police station.

"In addition, the SDPO, Billawar, stated at the Bar that no uch persons, namely Jugal and Harish, were posted at the Billawar police station.

However, Appu Singh Slathia, the counsel appearing for the petitioners, submits that she has placed on record electronic vidence by virtue of a pen drive, which indicates that Jugal and Harish were also present on February 5 when the deceased was taken to his residence and thereafter, he committed suicide in a mosque at Bhatodi village, Billawar," the

He said the petitioners further submitted that even at the time when the body of the deceased was taken to the hospital, four police officers were present, including Jugal and Harish.

"Since, there is an ambiguity with regard to the statement so made by the concerned SDPO, Billawar, on April 25, this court deems it proper to direct him to remain present before this court on the next date of hearing, with a view to record his detailed statement before the registrar judicial of this ourt to proceed further in the matter," Justice Nargal said.

For proper appreciation of the matter, the judge said, it is ecessary to verify whether the police officers, namely Jugal and Harish, were ever posted at the Billawar police station, or whether they were present at the time when the body was taken to the hospital, or when the deceased was taken to his

In addition, the court also sought the personal presence of he head of the SIT, with a view to apprise the court with regard to the investigation so carried as on date in light of the act that the SIT was constituted on March 10.

Government advocate Suneel Malhotra has been directed to produce the case detail file (of the SIT) on the next date of nearing, besides apprising the court about the investigation peing conducted in the case.

Taking serious note of the failure of the respondents - chief ecretary and home secretary - to submit their response to the notices issued to them on April 16, the court granted them one more opportunity to file their response through their counsel.

"The court deems it proper to grant one more opportunity o the (government) counsel for respondents 1 and 2 to file their response within a period of one week positively, failing which the matter will be heard on its own merits on the next date of hearing," the judge said.

Missing soldiers body found

ANANTNAG Security forces on Friday found the body of a soldier who had gone missing in Anantnag district earlier this veek, officials said.

The body of another soldier was found from the area on

The two soldiers of the Army's elite para unit -- Lance Havildar Palash Ghosh and Lance Naik Sujay Ghosh -- had gone missing during a combing operation at Kokernag on Tuesday. The operation was launched in the Ahlan Gadole area, following inputs that terrorists were hiding there, the

While the body of one of the soldiers was found on Thursday, the other body was found on Friday, they said, adding that it ems that both died due to hypothermia

According to the officials, the two soldiers went missing after their communication line went out. Helicopters were pressed into aerial reconnaissance to locate the commandos. The Srinagar-based Chinar Corps unit of the Army said the operational team was caught in a severe snowstorm.

"On the intervening night of October 6 and 7, an operational team on the Kishtwar range confronted a severe snowstorm and whiteout conditions in the mountains of southern Kashmir, Since then, two soldiers have gone out of communiation," the Chinar Corps said in a post on X on Wednesday. "Intense search and rescue operations have been launched but hampered due to prevailing adverse weather conditions,"

The Army paid tributes to the fallen soldiers.

"Chinar Corps honours the supreme sacrifice of Bravehearts Lance Havildar Palash Ghosh and Lance Naik Sujay Ghosh, while conducting relentless counter terror operations in the Kishtwar Range of Kokernag battling extreme weather conditions. Their courage and dedication will forever inspire us," the Chinar Corps said in a post on X.

It said Chinar Warriors salute the valour and sacrifice of the bravehearts.

"We stand in solidarity with the bereaved families and are committed to their well-being," it added.

SRINAGAR: Jammu and Kashmir Police on Friday conduct ed raids at the premises of terrorist associates linked with banned outfits at multiple locations in the city here.



In its sustained efforts to dismantle the terror ecosystem and curb unlawful activities, Srinagar police conducted extensive raids at multiple locations across the city, a police spokesman said.

He said the searches were carried out at the residences of terrorist associates and overground workers (OGWs) affiliat ed with proscribed terrorist organisations, in connection with ongoing investigations under the Unlawful Activities (Prevention) Act (UAPA).

The coordinated search operations were conducted across various areas of Srinagar, targeting individuals involved in facilitating, aiding, or abetting terror-related activities, the spokesman said.

He said the searches were conducted at 21 premises across

The searches were conducted in accordance with due legal procedure, in the presence of executive magistrates and inde pendent witnesses, and under the supervision of senior officers of J-K police, the spokesman added.

The objective of these searches was to seize incriminating material such as documents, digital devices, and other evidence relevant to ongoing investigations, the spokesman said

The raids also form part of a broader intelligence-gathering exercise aimed at pre-empting and disrupting any conspiratorial or terrorist activities threatening public peace and national security, he said. The police said the decisive action underscores its commitment to identify and take firm legal action against all individuals involved in promoting or supporting terror-related and anti-national activities.

India upgrades Tech Mission in Kabul to Embassy

NEW DELHI: India on Friday announced the upgrading of its technical mission in Kabul to the status of an embassy and pledged to renew its development works in Afghanistan. External Affairs Minister S Jaishankar also appreciated the Taliban set-up for showing sensitivity towards New Delhi's security concerns.

Jaishankar made the twin announcements during his wide-ranging talks with Afghan Foreign Minister Amir Khan Muttaqi, who landed in New Delhi on Thursday on a six-day visit.

India had withdrawn its officials from its embassy in Kabul after the Taliban seized power in August 2021. In June 2022, India re-established its diplomatic presence in the Afghan capital by deploying a "technical team"

In his opening remarks at the meeting, Jaishankar listed cross-border terrorism as a shared threat for both the countries and said India and Afghanistan must coordinate efforts to combat the

menace On his part, Muttaqi assured India

that Afghanistan will not allow any element to use its territory against New Delhi's interests and identified the Daesh terror group (ISIS) as the main challenge for the region. He added that Kabul is at the frontlines of this strug-

Since the Taliban came to power, New Delhi has also been insisting that Afghan soil must not be used for any terrorist activities against any country.

"Your visit marks an important step in advancing our ties and affirming the enduring friendship between India and Afghanistan," Jaishankar told Muttaqi in his opening remarks at the meeting. "As a contiguous neighbour and a well-

wisher of the Afghan people, India has a deep interest in your development and progress," he said. India's longstanding partnership that

has seen so many Indian projects in Afghanistan stands renewed, the external affairs minister announced. Jaishankar said both India and

Afghanistan have a common commitment towards growth and prosperity. "However, these are endangered by the

shared threat of cross-border terrorism that both our nations face. We must coordinate efforts to combat terrorism in all its forms and manifestations," he said.

appreciate vour sensitivity towards India's security concerns. Your solidarity with us in the aftermath of the Pahalgam terrorist attack was noteworthy," the minister added.

Jaishankar said India is fully committed to the sovereignty, territorial integrity and independence of Afghanistan.

"Closer cooperation between us contributes to your national development. as well as regional stability and resilience. To enhance that, I am pleased to announce today the upgrading of India's Technical Mission in Kabul to the status of embassy of India," he said.

The external affairs minister said India is now ready to commit to six new projects, the details of which can be announced soon.

"A gift of 20 ambulances is another gesture of goodwill and I would like to hand over five of them to you personally as a symbolic step," he said.
