Whereas, perusal of verification report of 10<sup>th</sup> Class pass marks certificate of above named subject so obtained, it reveals that his correct name is “Mukesh Kumar Sharma” & father’s name is “Darshan Kumar Sharma” but inadvertently at the time of his engagement his name was written as “Mukesh Kumar” instead of “Mukesh Kumar Sharma” & father’s name as “Darhsan Lal” instead of “Darshan Kumar Sharma”.

Whereas, the department is going to make necessary corrections in the name of above, named SPO as Mukesh Kumar Sharma” instead of “Mukesh Kumar” and father’s name as “Darhsan Lal” instead of “Darshan Kumar Sharma” and hence before proceeding further into the matter this notice is hereby issued for the information of general public inviting objection (s), if any, within seven (07) days positively from the date of publication of notice in news papers. In case no objection is received during the prescribed period, the same shall not be entertained and thereafter necessary orders will be issued accordingly.

A crucial piece of legislation to prevent female foeticide and to maintain gender ratios in the country.

This Act prohibits:

- Sex-selection before and after conception.
- Misuse of preconception and prenatal diagnostic techniques for sex determination of foetus.
- Advertisements of such techniques for detection or determination of sex of the foetus even through the internet.

Penalties:

- Violation by Medical Professionals/ staff of clinic:**
  - Imprisonment up to 3 years and fine up to Rs 10,000 for the first offence. and
  - Up to 5 years with Rs 50,000 fine for subsequent offences
  - Suspension of registration if charges are framed
  - Cancellation of registration for 5 years by the Council in first offence and permanently for the subsequent offence.
- Violation by any other person:**
  - Imprisonment up to 3 years and fine up to Rs 50,000 for the first offence. and
  - Up to 5 years with 1,00,000 fine for subsequent offences.
- Violation by advertising facilities for sex Selection:**
  - Imprisonment up to 3 years and fine up to Rs 10,000
