JAMMU: The District Jammu Kurash Championship concluded today with a spectacular series of final matches, marking a decisive end to the two-day sporting spectacle held at the Bhagwati Nagar Indoor Stadium, Jammu. The championship, which commenced on October 10 and culminated on October 11, 2025, witnessed an impressive display of athletic prowess, discipline, and competitive spirit among young Kurash practitioners from across the district. The event, which aims to promote the ancient Turkic martial art of Kurash among the youth, saw a massive turnout, with approximately 294 players from various schools and clubs participating.

This award acknowledges the academy's commitment to upholding the highest standards of conduct, sportsmanship, and discipline values that are central to the ethos of martial arts.

The individual competitions were fierce, with young athletes vying for Gold, Silver, and Bronze medals in several weight categories. The event provided a particular focus on the development of female athletes, with detailed results announced for both the Mini Sub-Junior Girls and Sub-Junior Girls categories.

In the Mini Sub-Junior Girls category, the results were as follows Below 22 kg: Mukanda of Shangrilla School exhibited dominating form to secure the Gold Medal, while Ridhi of Sarvodaya School took the Silver Medal Below 38 kg: The Gold Medal in this division was earned by Disha

Bazaf of Eagle Club Below 30 kg: Jazleen of Sarvodaya School emerged victorious with the Gold Medal, followed by Anjali Rajput of Eagle Club, who secured the Silver Medal Below 26 kg: Aadhya of Spring Dales School claimed the Gold Medal, with Mahi of Sarvodaya School winning the Silver Medal Below 30 kg (Second Division): Vanshika Bhaui of Bagwati School achieved the Gold Medal, and Rashi of Sarvodaya School finished with the Silver Medal.

The Sub-Junior Girls category also saw remarkable performances, particularly from Sarvodaya School Below 34 kg: Kavya of

Sarvodaya School added another Gold Medal to her school's tally Below 42 kg: This category was a triumph for Sarvodaya School, with Ananya winning the Gold Medal, Rohini securing the Silver Medal, and Priyanvi taking home the Bronze Medal, demonstrating the club's deep bench strength in this weight class Below 48 kg: Pooja Devi of Spring Dales School was awarded the Gold Medal, and Tanisha of Eagle Club won the Silver Medal Above 50 kg: Aaradhya of Sarvodaya School concluded the category results with a hard-fought Gold Medal.

The successful organization of the championship

was a testament to the dedication of the organizing body. The event concluded formally with the Vote of Thanks, which was delivered by Rajneesh Gupta, General Secretary of The Amateur Kurash Association of Jammu & Kashmir. JAMMU: In a spectacular display young Arihant Sharma guided J&K to a two-wicket victory against Tamil Nadu in the ongoing Men's U-19 Vinoo Mankad Cricket Tournament at Bharat Ratna Shri Atal Bihari Vajpayee Ekana Cricket Stadium, Lucknow.

Chasing a challenging total of 253, J&K showcased remarkable composure to cross the finish line in 49 overs, losing eight wickets en route to a thrilling win. The hero of the day was undeniably Arihant Sharma, whose breathtaking 105-run knock off just 104 balls turned the game on its head. His innings, decorated with eight boundaries and five sixes, was a masterclass in controlled aggression and resilience under pressure.

Supporting acts came from Salman Ahmad Bakshi (34), Kamaksh

Sharma (27), Shiva Thakur (21), and Zaid Ahmad (18), each playing crucial cameos to complement Arihant's brilliance. Tamil Nadu's bowling attack, led by Alfred Jacob's spirited three-wicket haul, fought hard to maintain pressure, while BK Kishore, Sanjay K, and Benny Hinn chipped in with a wicket apiece but were denied by J&K's determined batting response.

Earlier, Tamil Nadu posted a competitive 253 runs in 49.2 overs, with opener Vineeth VK stealing the show through a classy 94 off 106 balls that included 8 fours and a towering six. Bharath M's fluent 48 off 43 balls further bolstered the innings, while contributions from Raj Jamie Walsh (26) and P Kush Bardia (20) added depth to the total. J&K's bowlers displayed disciplined teamwork, with captain Dhruv Sharma and Zaid

Ahmed scalping two wickets each. Solib Tariq, Salman Ashraf Dar, and Sidharth Jamwal took one apiece, ensuring Tamil Nadu's late push never gained full momentum.

Lauding the team's brilliant performance, Brig Anil Gupta, Member Administration JKCA, extended heartfelt congratulations to the players. He hailed the victory as a defining moment for J&K cricket and praised Arihant's extraordinary

knock, describing it as a top-class batting exhibition that epitomized skill, character, and a winning mindset.
