Whereas, the Vehicle bearing Registration No. JK177513 (Bolero Pickup FB 1.5 T BSIV PS) having Chassis No. MA1ZU2TBKJ1F49974 was registered on the name of Sh. Ghulam Hussain S/O. Sh. Habib R/O. Kakarwagan, Mughal Maidan, Chatroo Kishtwar - 182205;

Whereas, an application under Rule 58 of the Central Motor Vehicles Rules, 1989 was received by this office for issuance of No Objection Certificate in favour of Sh. Vakil Kumar for DTO Sri Ganganagar, Rajasthan;

Whereas, the matter was taken up with Inspector General of Police, Crime Branch, J&K vide No. ARTO/KTR/2024-25/2812 dated: 23.07.2024 for seeking clearance of non-involvement as required under Section 48 (5) of the Motor Vehicles Act, 1988;

Whereas, SP (S) for Spl. Director General of Police, Crime Branch, J&K vide No. CHQ/CS-1/VCC/2024-1404 dated: 23.07.2024 informed that no report of theft/loss of the vehicle is reported;

Whereas, a notice was also got published on 30.07.2024 in First Reporter daily news paper wherein objections were invited from general public with regard to issuance of No Objection certificate from office of the undersigned;

Whereas, since no representation/objection was received by this office and further on the basis of non-involvement report received from SP (S) for Spl. Director General of Police, Crime Branch, J&K, the No Objection Certificate was issued in favour of Sh. Vakil Kumar addressed to DTO Sri Ganganagar, Rajasthan on dated:13.08.2024;

Whereas, at latter stage, it came to the notice of this office that the Registered owner i.e. Sh. Ghulam Hussain have filed some complaint with the Police Department alleging that the said No Objection Certificate (NOC) of vehicle has been issued on the basis of mis-representation of facts/forgery;

Whereas, as per Parivahan Portal, the said vehicle has been further assigned new Registration mark as RJ13GC3494 by Registering Authority, District Transport Officer, Sri Ganganagar, Rajasthan and has also been further transferred on the name of Sh. Vikram S/O Sh. Shiv Kumar R/O W. No 03 Old Purani Abadi Ganganagar W No 07 2 LBM Hanumangarh, Ganganagar, Rajasthan-335803;

Whereas, the notice vide No. ARTO/KTR/2025/1216-23 dated: 11.08.2025 under Sub Section 5 of Section 55 of the Motor Vehicles Act, 1988 was sent/served to the Registered Owner i.e. Sh. Ghulam Hussain with copies to Sh. Vakil Kumar to whom No Objection Certificate (NOC) was issued and Sh. Vikram on whose name the Vehicle is presently transferred/registered by District Transport Officer, Sri Ganganagar, Rajasthan along with other officers/authorities connected with the matter;

Whereas, in response to notice issued by this office, a representation dated: 25.08.2025 has been received from Sh. Ghulam Hussain, which is duly attested by Tehsildar, Mughalmaidan, wherein he has submitted that he has no knowledge about the NO Objection Certificate (NOC) and he has not sold the said vehicle and he has been cheated by some persons;

Whereas, no other connected/affected parties, to whom the notice were served, have submitted any reply/response, till date, in this office;

Whereas, the representation of Sh. Ghulam Hussain, who was registered owner at the time of issuance of No Objection Certificate, thus establishes that the No Objection Certificate of his vehicle has been procured by Sh. Vakil Kumar S/O Sh. Kishan Kumar, 119, Bharat Nagar, Ward No. 2, Purani Abadi, Ganga Nagar, Rajasthan by mis-representation of facts/forgery and thus the under signed is constrained to invoke Sub Section 5 of Section 55 of the Motor Vehicles Act, 1988 which empowers the undersigned to cancel the Registration Certificate "if obtained on the basis of documents which were, or by representation of facts which was, false in any material particular...";
