Two theft cases solved; 3 nabbed, cash and gold recovered

JAMMU: Jammu Rural Police has achieved major breakthroughs in two theft cases registered at Police Station Domana, successfully arresting the accused and recovering stolen property within a short span of time.

In Case FIR No. 219/2025 U/S 331(3),305 BNS,a special team led by SHO Domana Inspr. Varuneshwar Singh swiftly analysed CCTV footage and developed specific leads, resulting in the arrest of Amit Sharma @ Mittu S/o Prabhdayal R/o Susheel Nagar, Camp Road, Talab Tillo, Jammu. Within 12 hours, stolen cash amounting to ?69,100 was recovered following his confession and disclosure during questioning.

In another case, FIR No. 185/2025, the same team arrested Shubam S/o Late Satish Kumar R/o H.No. 319, Bakshi Nagar, Jammu, and Sahil Kumar S/o Subash Chander R/o Bhagwati Nagar, Jammu, for their involvement in a theft case. During sustained questioning, both confessed to their involvement, leading to the recovery of stolen gold (Cost ?2 lakhs) items from their possession.

All recovered property has been seized as per legal procedure, and further investigation is underway to identify any other persons involved and to trace remaining stolen items. The entire recovery was made under the close supervision of

Eight drug peddlers arrested with heroin

JAMMU: Continuing its relentless drive against the menace of drug trafficking and substance abuse, R.S Pura Police achieved a significant breakthrough by apprehending three drug peddlers and recovering approximately 186 grams of Heroin (Chitta) like substance from their possession in Chak Talab area falling under the jurisdiction of Police Station R.S

A special police team from Police Station R.S Pura, led by PSI Iahtsham ul Haq and assisted by other officials, carried out the operation under the close supervision of SHO Police Station R.S Pura, Ravi Singh Parihar and overall supervision of SP Headquarters Jammu and SDPO R.S Pura. The operation was conducted while the police team was on routine patrolling duty in the area.

During the course of patrolling, the team rounded up three suspicious persons identified as Inderjeet S/o Balwant Ram R/o Gandhi Camp Tehsil Batala, District Gurdaspur, Punjab A/P Chak Talab Tehsil R.S Pura; Vishal Kumar S/o Charan Dass R/o Sagarpur Tehsil Batala, District Gurdaspur, Punjab A/P Chak Talab Tehsil R.S Pura; and Jagdish Raj S/o Mulkh Raj R/o Chak Talab Tehsil R.S Pura District Jammu. Upon thorough search, the police recovered approximately 186 grams of Heroin (Chitta) like substance from their possession. In this regard, a case FIR No. 203/2025 U/S 8/21/22/29 NDPS Act has been registered at Police Station R.S Pura. All three accused have been arrested, and further investigation is possible links in the drug trade network.

Meanwhile, During patrolling duty near Duddhar Bridge, Roun Domail, a police party of Police Post Roun Domail intercepted one person moving from Manwal towards Roun Domail. During his personal search, approximately 03.77 grams of heroin was recovered from his possession.

The accused has been identified as Rohit Kumar S/O Subash Chander R/O Dhanu, Tehsil & District Udhampur

In this regard, FIR No. 366/2025 U/S 8/21/22 NDPS Act has been registered at Police Station Udhampur and investigation has been set into motion.

in another case, a police team of Police Station Sunderbani led by SHO Sunderbani established a naka near Forest Check Post Sunderbani. During routine vehicular checking a Renault Triber car bearing registration number JK11H-6043 was intercepted

During search police recovered 6.14 grams of heroin like narcotic substance from the possession of the occupants. They were identified as Mohd Sayeed S/O Mohd Bashir R/O Dudasan Bala Rajouri; Parveen Akhter W/O Mohd Sayeed R/O Dudasan Bala Rajouri; Noreen Kouser W/O Mohd Naveed R/O Dudasan Bala Rajouri.

In this regard a case FIR No. 68/2025 under relevant sections of the NDPS Act has been registered at Police Station Sunderbani. All the accused persons have been arrested and the vehicle used in commission of the offence has been seized. Further investigation into the case is in progress

In Case FIR No. 09/25 of Police Station GRP Kathua, 15 grams of heroin like substance was seized from accused Mohd Yasir S/o Mohd Yusuf R/o Maggar Khad, Jagatpur, District Kathua, and was booked under sections 8/21/22 of the NDPS

Subsequently, a team of GRP conducted raids and searches at his residence at Maggar Kahad, Jagatpur, District Kathua. During the search two separate packs of heroine like substance were recovered and seized on the spot in the presence of Executive Magistrate. The market price of the total seized heroine like substance in this case is estimated more than ?26 lakhs. During the search one iron khokri, and one iron tokka has also been seized at the place of search.

The raid and search team was led by SDPO GRP Vijaypur accompanied by SHO GRP Kathua. Investigation of the case is in progress to explore the forward and backward linkages related to the narcotics as well as narco-terrorism

Two street vendors apprehended for causing traffic jam
