He added, "We promised the people that we would restore the 'Darbar' move. The Cabinet has taken a decision regarding its restoration and sent it to the Lieutenant Governor. The LG has signed and returned the file."

Taking a dig at the Bharatiya Janata Party (BJP), Abdullah said, "Why was the Darbar Move stopped? It had been a long-standing tradition. Those who used to accuse us of not understanding the history of Jammu and Kashmir before 1947, and of not respecting the great personalities of the region - let it be known that no one has damaged their egacy more than the BJP."

Opposition parties and traders had been strongly advocatng for the restoration of the Darbar Move for years.

The Chief Minister said solution to all issues facing Jammu and Kashmir lies in the restoration of statehood, as he urged Prime Minister Narendra Modi to fulfil his promise for the same made to the people of the Union territory.

"We were hopeful that the Centre would fulfil its promise to restore statehood (to J-K) in the first year of our government, but it has not happened," Abdullah said, as he urged the Modi government to fulfil its promise made to the people of the Union territory from the floor of Parliament and the Supreme Court.

"Heading a government in a UT is a different experience. We were hoping that the Centre would fulfil its promise on statehood, but it has not happened yet. But we will not back down from our efforts.

"We still believe that the solution to all the problems facing Jammu and Kashmir lies in the restoration of statehood, Abdullah told reporters at the NC headquarters here.

Urging the prime minister to keep his promise on statehood, Abdullah said, "Once again, I would like to urge the government of India, the Prime Minister and his entire team to fulfil the promise made to the people of Jammu and Kashmir.'

The Chief Minister said he took over the reins of the government one year ago, and it is making all out efforts to improve the lives of the people by speeding up developmental works.

"We have made a start. Be it the political promises we made to the people to bring a resolution in the Assembly on the special status of Jammu and Kashmir, or to get a resolution approved in the Cabinet for the restoration of statehood -we did both things," he said.

Referring to the demand of the opposition parties to make public the NC government's one year report card, Abdullah said when his party sought votes from people, it emphasised that the government will last not just for six months or one year, but for a full five-year term.

"Like I said in the Assembly, if you have to judge us on the basis of our manifesto, do it after the government completes its full five-year term because no government fulfils all its promises in six months or one year," he said.

The NC government is "absolutely committed" to the promses made to the people and it will submit a report card after completing five years in office, he added.

The offices moving 'in camp' shall carry only 33 per cent of the staff strength in that particular office, or 10 officials, whichever is minimum, or as otherwise specifically indicated. The Darbar Move traces its origins to 1872 under Maharaja Ranbir Singh, the Dogra ruler who began transferring the royal court between Srinagar and Jammu to escape the extreme weather in both regions. Under this system, government offices functioned from Srinagar during the summer months and shifted to Jammu in the winter.

The exercise involved the movement of nearly 10,000 employees, along with records, computers, and furniture, with dozens of trucks carrying files and equipment across the Jammu-Srinagar highway twice a year.

Earlier, CBI Director Prayeen Sood said in his welcome address that India issued a record 199 Interpol notices in 2025, which is more than double compared to 2024, when 96 Interpol notices were issued -- 52 red and 44 blue. As many 189 notices were issued in the first nine months of 2025, including 79 red notices and 110 blue notices, Sood said.

"So far, Interpol has published a total of 957 red notices against fugitives. Of these, 231 are related to CBI cases, 130 to NIA, 21 to ED, 12 to NCB cases, and the remaining to various state police forces," he said.

Sood, however, said one cannot take pride in these figures just yet for two reasons -- first, the number is still relatively low compared to other countries, and second, the real work begins only after the notices are published.

At the conference, which was also attended by Home Secretary Govind Mohan, Foreign Secretary Vikram Misri, and Director of Intelligence Bureau, Tapan Kumar Deka, Shah said that while maintaining a zero-tolerance policy against corruption, crime and terrorism within the country, we must also adopt a zero-tolerance approach towards those operating such activities from beyond India's borders".

"It is our responsibility to bring all such criminals under the purview of Indian laws and to create a robust mechanism

for this purpose," he said.

The home minister said India cannot be truly secure until those residing abroad who harm the country's economy, sovereignty and security begin to fear the Indian justice system.

Shah said it should be a collective resolve that no matter how cunning a criminal may be, the reach of justice must be even swifter.

The issue of fugitive criminals is linked to the country's sovereignty, economic stability, law and order, and national security, he said.

Asserting that after a long time, a structured approach is being developed on this subject, the home minister said that time has come to ensure a system that adopts a "ruthless approach" and brings every fugitive before Indian laws in a time-bound manner.

Shah said two crucial aspects -- assurance and ecosystem -- are essential to apprehend any fugitive, as he stressed the need to eliminate the assurance in the minds of fugitive criminals that the law cannot reach them.

He said the ecosystem of legal, financial, and political support must be dismantled, and the institutional nexus creat-

ed by fugitives abroad eradicated. The home minister suggested that with the cooperation of the CBI, every state must establish a unit dedicated to cre-

ating a mechanism for bringing back fugitives who committed crimes and fled the state. This effort must be accelerated through a "whole of govern-

ment" approach. Shah also asked the agencies to use "to the fullest extent" Sections 355 and 356 of the Bharatiya Nagrik Suraksha Sanhita (BNSS), which provide for 'trial in absentia' that has been included in the law for the first time since India's Independence, allowing trials of fugitives to proceed even in their absence. The actionable points emerging from this conference, along with the Bharatpol and 'trial in absentia' provisions, should be integrated to create a mechanism within both state police forces and all Central agencies, with the

"We have started working towards becoming atmanirbhar (self-reliant) in the defence sector. In the initial phase, it was difficult because we were trying to transform the entire system. Since Independence, we have been dependent on other countries for weapons. It had become a necessity for us to buy defence equipment from abroad, and indigenous production was almost non-existent," he said.

India has now "broken the barrier" that had existed since Independence, the minister said.

"We have given a strong push to manufacturing weapons within the country. This was not easy at all, as the nation had slipped into a comfort zone regarding defence procurement. We had become habitual of buying weapons from other countries," he said.

There was neither the "political will" to produce weapons domestically nor the legal framework to promote defence manufacturing, Singh noted.

The youth of the country also lacked the inspiration to help India become self-reliant in this sector, the defence minister

"The situation was not conducive for us; in fact, it was adverse. But even in such circumstances, we did not stop. We took every possible step to promote defence manufacturing, and today, those efforts are yielding visible results," he said.

"You must have seen the bravery of our armed forces during Operation Sindoor. Operation Sindoor is the finest example of self-reliance in India's defence sector as the majority of the equipment used by the armed forces was indigenous,

India launched Operation Sindoor in May this year to dismantle the terror infrastructure across the Line of Control and deeper inside Pakistan, in the aftermath of the Pahalgam terror attack which claimed the lives of 26 per-

Singh said Prime Minister Narendra Modi's "charismatic leadership" was evident during Operation Sindoor.

"India has been promoting the concept of 'Vasudhaiva Kutumbakam' - the world is one family - and it is the only country that spreads this message. We do not discriminate on the basis of caste or religion," he asserted.

HC quashes three preventive detentions, raps authorities for 'Non-Application of Mind'

JAMMU: In a significant development, the High Court of Jammu & Kashmir and Ladakh has quashed three preventive detention orders passed under the Public Safety Act (PSA) observing that authorities failed to apply their mind while invoking preventive custody against the detenus. Justice Vinod Chatterji Koul, while pronouncing separate judgments in all three cases, directed the immediate release of the detenus, unless required in other cases.

In the case of Murad Ali, son of Haneef Ali of Kathua detained under Order No. PSA/164 dated June 12, 2025, the Court held that the District Magistrate Kathua ignored the fact that the detenu was already on bail in all registered FIRs, including cases under IPC, NDPS Act, and Prevention of Cruelty to Animals Act.

The Court observed that preventive detention cannot substi tute ordinary criminal proceedings and found the grounds 'vague and ambiguous." Advocate Siddhant Gupta represented the petitioner, while Suneel Malhotra, GA appeared for the

Similarly, in HCP No. 160/2024, the Court quashed the detention of Javid Iqbal Reshi of Poonch, detained under Order No. DMP/PSA/22 of 2024. The Court held that the District Magistrate Poonch had merely reproduced the police dossier verbatim, exhibiting "complete non-application of mind."

It further ruled that the detenu was not informed of his right to make representation to the detaining authority before government approval, which violated Article 22(5) of the Constitution. Advocate Muzaffar Iqbal Khan appeared for the petitioner, while Dewakar Sharma, GA represented the

In HCP No. 90/2025, the Court quashed the detention of Abdul Gani, son of Noor Ahmed of Kathua, detained vide Order No. PSA/162 dated May 26, 2025.

The Court found that nine out of ten FIRs relied upon were stale, dating back to 2008-2020, with only one recent case in 2025. It noted that preventive detention based on outdated cases amounted to punishment without trial. The Court also held that the detenu was not properly informed of his right to representation before the detaining authority. The petitioner was represented by A.P. Singh and Nikhil Verma, Advocates while Suneel Malhotra, GA defended the respondents.

In all three cases, the High Court stressed that preventive detention is an extraordinary measure meant to protect "pub lic order," not to punish individuals for past offences. It reiterated that vague allegations, stale FIRs, and mere branding of individuals as habitual offenders cannot justify curtailing their liberty under the PSA.

The Court ordered the immediate release of all three detenus unless they are required in connection with other cases and returned the detention records to the respective government counsels.

DB upholds termination of Anganwadi Helper, labels it illegal backdoor appointment

JAMMU: The High Court of Jammu & Kashmir and Ladakh has upheld the termination of Geeta Devi, a 54-year-old Anganwadi Helper from Kathua, declaring her appointment as an illegal backdoor entry secured beyond the notified recruitment process.

A Division Bench comprising Chief Justice Arun Palli and Justice Rajnesh Oswal dismissed Geeta Devi's appeal against her disengagement, ruling that her application was submitted in March 2006, nearly a year after the official advertisement of February 2005 that closed on March 11, 2005.

The Court further noted that the State Vigilance Commission had, in a 2014 inquiry, confirmed that she never participated in the selection process. "Once an appointment is found to be illegal from inception, no right flows from it," the judges observed, holding that even denial of a hearing could not cure a fraudulent engagement.

Citing Supreme Court rulings including Jainendra Singh vs State of UP and State of Bihar vs Kirti Narayan Prasad, the Bench ruled that illegally appointed candidates cannot claim continuation or regularisation on grounds of long service.

Geeta Devi, represented by Advocate Amit Gupta, argued that she was terminated arbitrarily and without being heard The UT administration, represented by Advocate Palvi Sharma vice AAG Ravinder Gupta, countered that he engagement was fraudulent from the outset.

Dismissing the appeal as "misconceived," the Court upheld the writ court's earlier findings and refused to interfere.

DB raps FCI for unauthorized land occupation, orders return or acquisition of Channi Himmat Plot

JAMMU: In a major setback to the Food Corporation of India (FCI), the High Court of Jammu & Kashmir and Ladakh has dismissed FCI's appeal and upheld the writ court's order directing the Corporation to either return a piece of land at Channi Himmat, Jammu, or initiate acquisition proceedings in accordance with

The Division Bench comprising Chief Justice Arun Palli and Justice Rajnesh Oswal held that FCI was in unauthorized occupation of land measuring 3 kanals, 9 marlas and 73 sq. ft. belonging to the petitioners, and ruled that delay and technical objections cannot defeat citizens' constitutional right to property.

The case, originally filed by Baldev Raj Mahajan (since deceased, represented by legal heirs), revolved around allegations that FCI had forcibly occupied his land in 1993-2000 for construction of godowns without following proper acquisition procedure. While FCI argued that the land was handed over in 1976 through government acquisition and boundary

construction, the Court rejected this claim after survey reports confirmed unauthorized occupation.

Senior Advocate M.K. Bhardwaj with Ahtsham Hussain Bhat appeared for FCI, while Senior Advocate Sunil Sethi with Paras Gupta represented the landowners.

Citing the Supreme Court's rulings in Vidya Devi vs State of H.P. and Madras Port Trust vs Hymanshu International, the Bench stressed that State instrumentalities cannot take shelter under technicalities like "delay and laches" or adverse possession to defeat citizens' rights. The Court observed that the right to property, though no longer a fundamental right, is a constitutional right under Article 300-A and recognized as a human right.

Concluding that FCI's occupation was unauthorized, the Court directed compliance with the earlier order - either return the land to the petitioners or acquire it under the Right to Fair Compensation Transparency in Land Acquisition, Rehabilitation

and Resettlement Act, 2013.
