PUBLIC NOTICE

In terms of directions issued by Hon'ble Supreme Court in Writ Petition (C) No. 728/2015, only improved and green crackers can be used for fireworks. Accordingly, public in general is advised to comply with the directions above in the interest of environmental conservation.

ADVISORY FOR USE OF CRACKERS

1. Only crackers with reduced emission (improved crackers) and green crackers can be used.

2. Use of firecrackers with banned chemicals, viz., Barium salts, Lithium, Arsenic, Antimony, Lead and Mercury is strictly prohibited.

3. Manufacture, Sale and Use of joined firecrackers (series crackers or laris) is strictly prohibited.

4. Fireworks timings must be restricted between 8:00 p.m. and 10.00 p.m.

5. Only crackers with sound level less than 125 db(AI) can be sold and used.

6. Fireworks are not allowed in silence zones, that is within 100 metres of hospitals, nursing homes, primary and district health-care centres, educational Institutions, courts, religious places etc.

Manufacturers and retailers are advised to ensure compliance of the directions above and restrict the production and sale to improved and green crackers only.
