Congress defers meeting with ally NC

SRINAGAR: The Congress Legislature Party in Jammu and Kashmir did not attend a meeting with ally National Conference (NC) on Wednesday, saying it has written to the party high-command about certain suggestions and sentiments of its MLAs.

"We discussed the invitation extended by National
