

Whereas, a candidate namely Mr. Taj Mehmood S/o Munir Hussain R/o Ward No. 1 Kheora Rajouri, appeared in the said examination under Roll No. 1100026 at Centre No. J-10, Govt. Degree College R S Pura Jammu; and

Whereas, the said candidate was found in possession of mobile phone during the examination, as per the report of the Centre Superintendent and Centre Observer;

Whereas, notwithstanding the above, vide No. JKSSB-COE0Exam (UT)/101/2023-03 (7363646) dated 07.10.2025, a show cause notice was issued to the said candidate to explain his position;

Whereas, the case was placed before the Unfair Means Committee constituted in terms of Jammu and Kashmir Services Selection Board (Conduct of Examinations) Regulations, 2022 under part XXX, 64 (b), and the committee, after considering the nature of the offence and evidence brought on record as well as the reply of the show cause notice submitted by the candidate, recommended as under:-

"The committee observed that the candidate has committed offence under section 64 (b) of Jammu and Kashmir Services Selection Board (Conduct of Examinations) Regulations, 2022. Therefore, the committee recommends cancellation of the candidature of the candidate for the said post, besides debarment for a period of 05 years for all examinations and selections conducted by JKSSB with effect from the date of incident".

Whereas, the recommendations of the Unfalr Means Committee were placed before the Board in its 324th Meeting held on 14-10-2025, which accepted

the recommendations of the Unfair Means Committee with some modification and decided as under:-

cancel the candidature of candidate Mr. Taj Mehmood S/o Munii Hussain R/o Ward No. 1 Kheora Rajouri, for the post of JE (Electrical) advertised vide notification No. 02 of 2025 dated 27.02.2025.

To debar the candidate for a period of two (02) years from all examinations and selections conducted by the Jammu and Kashmir Services Selection Board (JKSSB) with effect from the date of incident

To handover the mobile phone seized from the candidate (Taj Mehmood) during the examination, after six months from the date of incident on his personal request to the Controller of Examinations/Secretary".

Therefore, in view of the above and as per section 69 of Jammu and Kashmir Services Selection Board (Conduct of Examinations) Regulations, 2022, the candidature of candidate Mr. Taj Mehmood S/o Munir Hussain R/o Ward No. 1 Kheora Rajouri, for the post of JE (Electrical) advertised vide notification No. 02 of 2025 dated 27.02.2025 is hereby cancelled. The candidate is further debarred from appearing in all the examinations and selections conducted by the Board (JKSSB) for a period of two (02) years from the date of examination to the said post i.e. 24.08.2025. Besides, the mobile phone shall be released to the candidate after six months from the date of incident on his personal request.
