SDPO Bhaderwah Shoket Ali, SHO Bhaderwah Suresh Gautam, Ex President Anjuman-e-Islamia Bhaderwah Abdul Hafiz, YAC President Naseer Mehboob and others also participated in the event. The inaugural match was played between Khonkhaar 4RR and Bhaderwah Administration XI. After winning the toss, Khonkhaar 4RR opted to bowl first.
