He said the NC government will have no objection to any bill that is beneficial for the people of Jammu and Kashmir, "but we cannot pass a bill which will help the

Asked about the PDP supporting the NC in the Rajya Sabha polls in lieu of support to the bill, the chief minister said he is not ready to "sell" Jammu and Kashmir for a seat in the Upper House of Parliament.

"What does that mean, should I sell Jammu and Kashmir? I am not ready to sell Jammu and Kashmir's land for a Rajya Sabha seat. I have said, bring a bill that benefits the people of Jammu and Kashmir. If you get a bill to help the land mafia, then, at least, it will not be passed through our hands," he added.

The PDP had supported the NC in the recent Rajya Sabha polls on the condition of the government supporting the private member's bills submitted by the opposition party on granting land rights and regularisation of daily wagers.

Earlier, the Assembly rejected the private member's bill seeking to recognise the proprietary rights of houses constructed on government land illegally, with the chief minister saying such a legislation would open the floodgates for land grab.

"A bill to provide special provisions for residents of Union Territory of Jammu and Kashmir for recognising the proprietary rights of houses constructed on State land. Kacharia land, Common land and Shamilat land (section 4 of Jammu and Kashmir Agrarian Reforms Act, 1976), by securing the rights of ownership or transfer in favour of the residents of such residential house owners, who are in possession of such land, in the interest of right to shelter as guaranteed by Article 21 of the Constitution of India and for the matters connected therewith or incidental there-

However, the government opposed the bill and requested Para to withdraw it.

"On the surface, it looks easy. If someone has constructed a house on government land, give the land to him. Last time also, the government made a scheme to convert leasehold into freehold which was known as (the) Roshni (scheme). The aim was to grant freehold to those who had leasehold before militancy. The revenue generated would have been used for power generation," Abdullah said.

He said the then PDP-Congress coalition government removed the pre-militancy

"There was a controversy and there was talk of land jihad and what not. It went to court and we could not defend it there. This proposal of the MLA is beyond the Roshni scheme. The bill does not put a cut-off timeline. We cannot do this. There is a provision of granting land to the landless people under the PMAY. So I request the nember to withdraw the bill," the chief minister said.

However, Para questioned that while state land is being allotted, if "you are willng to give land to landless and house to houseless under the PMAY, will you render nomeless those who are already living on the state land"?

"It is not a problem of one area, but of entire Jammu and Kashmir. You have a egacy of (NC founder) Sheikh Abdullah to live up to," the PDP MLA said.

Responding to these remarks, the chief minister said the PDP never owned the NC's legacy "but today, he is remembering it".

Shopian district in south Kashmir reported the lowest number of dog bite cases -1,357 -- in the past three years, the government said.

A comprehensive drive for the sterilisation and immunisation of stray dogs has

been launched, it said. From June 2023 to September 2025, 48,998 stray does were sterilised and vaccinated, Abdullah said. The Srinagar Municipal Corporation (SMC) tops the list with 27,237 sterilisations and vaccinations, followed by the Jammu Municipal Corporation (JMC) at 13,730.

The municipal committees in the other districts of Jammu region carried out 7,870 sterilisations and vaccinations, the government said.

The chief minister said while Srinagar has two Animal Birth Control (ABC) centres and is establishing a third, the Directorate of Urban Local Bodies, Kashmir, is in the process of setting up such centres in the remaining nine districts of the Kashmir Division, for which identification of land has been taken up with the deputy commissioners. under section 195A is a cognisable offence and pertains to inducing a person to give false evidence by intimidating him with the threat of injury either to his person or reputation or property or to the person or reputation of anyone in whom that person is interested," the court said.

The bench said the threat to a witness may be given long before he comes to the court, though the giving of false evidence under such a threat is in connection with a proceeding before that court.

"That is, perhaps, the reason why this offence was made cognisable so that the threatened witness or other person may take immediate steps by either giving oral information of the commission of this cognisable offence to the concerned police officer under section 154, CrPC, or by making a complaint to a jurisdictional magistrate under section 195A, CrPC, so as to set the process of criminal law in motion,"

relating to matters as specified in the notification, Mohan Singh Parihar, retired district and sessions judge and judicial secretary to the inquiry commission said in his public notice.

He said every statement furnished to the inquiry commission should be accompanied by an affidavit in support of the facts set out in the statement and sworn by the person furnishing the statement.

"Every person furnishing a statement shall also furnish to the inquiry commission along with the statement a list of the documents, if any, on which he/she proposes to rely and forward to the inquiry commission, wherever practicable, the originals or the true copies of such documents as may be in his/her possession or control and shall state the name and address of the person from whom the remaining documents may be obtained," Parihar said.

He said the statements should reach the office of the inquiry commission, ADR Centre New Court Complex Melongthang, Leh within a period of four weeks on or before November 28. On Monday, Justice Chauhan said the commission will examine the collected mate-

rial from December 10 onwards and is open to meet anyone coming forward.
