his links to the terrorist ecosystem has been through a network of other OGWs who have been operating at the behest of terrorist outfit LeT," the investigators observed further adding that having a dangerous terror collaborator working as a teacher in the school is a huge threat to the young and impressionable minds and it also puts at risk the lives of hundreds of children.

Majid Iqbal Dar -Teacher (Education Department) Majid Iqbal Dar was appointed as a Lab Assistant in 2009 in School Education Department on compassionate ground after death of his father. He was later promoted as a teacher in 2019. Majid was working as an Over Ground Worker (OGW) of Lashkar-e-Taiba terror outfit and became one of the key figures involved in radicalising youngsters in Rajouri and surrounding region

Investigation has also revealed that Majid Iqbal Dar was also involved in NarcoTerror and maintained a close link with LeT terrorist Mod Jabar. It has been learnt that Majid Iqbal Dar as a reliable asset of LeT was using the drug money to finance terror activities and radicalisation of gullible youth.

"His terror link was exposed in January 2023 when police recovered an IED planted near J&K Bank in Rajouri. During the course of investigation police arrested three persons including the government teacher, Majid Iqbal Dar. It was later revealed that Majid, LeT terrorists Jabar and Zohaib Shazad had planted the IED on the instruction of their LeT handler based in Pakistan and they had also received money via a conduit," the investigators revealed.

Sources said subsequent to his detention under, Majid Iqbal Dar has continued to display radical tendencies inside the prison. As per credible sources close to Majid, he remained deeply committed to the terrorist ideology.

"That Majid has been doing this since long and that too at the cost of Government exchequer and has managed to evade the law for many years is a double jeopardy against public interest. Majid's damage value is humongous because he was working within the sensitive education department," Sources within the law enforcement

Recently, the Lieutenant Governor, Manoj Sinha had observed that the people from all sections of society must realise that those who provide ideological and financial support for terrorism, create false narratives are dangerous to peace and development. His zero-tolerance policy based on key pillars of anti-terror crackdown, swift against OGWs in administration & society, crackdown on Narco-terrorism and nclusive development has ensured peace and economic revival. Lieutenant Governor Sinha had observed that the peace can only be achieved by completely dismantling the terror ecosystem.

"War against terrorism is not over yet. Kinetic and non-Kinetic operations must continue. We must maintain the momentum and take stringent action against terrorism and its entire ecosystem," the Lieutenant Governor had told the security and ntelligence officials.

Justice Kant also nudged the Election Commission to disclose the details of 65 lakh voters excluded from the draft electoral rolls in Bihar while hearing a batch of petitions challenging the poll panel's decision to undertake special intensive revision of the voters list in the poll-bound state.

In an order that emphasised grassroots democracy and gender justice, he led a pench that reinstated a woman sarpanch unlawfully removed from office and called out the gender bias in the matter.

He is also credited with directing that one-third of seats in bar associations, including the Supreme Court Bar Association, be reserved for women.

Justice Kant was part of the bench that appointed a five-member comm ed by former top court judge Justice Indu Malhotra to probe the security breach during Prime Minister Narendra Modi's visit to Punjab in 2022, saying such matters required "a judicially trained mind".

He also upheld the One Rank-One Pension scheme for defence forces, calling it constitutionally valid, and continues to hear petitions of women officers in the armed forces seeking parity in permanent commission.

In another notable case, he upheld the Char Dham project in Uttarakhand, emphasising its strategic importance for national security, while balancing environmental concerns.

His bench also observed that "freedom of speech is not a licence to flout societal norms" while cautioning podcaster Ranveer Allahbadia for "derogatory" remarks. Justice Kant headed a bench which pulled up several stand-up comedians, including "India's Got Latent" host Samay Raina, for ridiculing disabled people on their

shows and directed the Centre to come up with guidelines for regulating online con-Holding that freedom of speech is not absolute, Justice Kant led a bench which pulled up Madhya Pradesh minister Vijay Shah for his remarks targeting Col Sofiya Qureshi, who gained nationwide prominence for media briefings on 'Operation Sindoor', saying every word uttered by a minister has to be with a sense of respon-

He has repeatedly underscored that corruption undermines governance and public trust.

In a 2023 verdict, he called it a "serious societal threat" and ordered the CBI to probe 28 cases exposing an "unholy nexus between banks and developers" that defrauded homebuvers.

He also led a bench that granted bail to former Delhi CM Arvind Kejriwal in CBI's excise policy case, remarking that the agency must work to dispel the notion of being a 'caged parrot'

His bench flagged the absence of a legal framework for domestic workers, directng the Centre to form an expert committee to propose protective measures for this vulnerable workforce. He has been part of over 300 benches since his elevation to the Supreme Court. Justice Kant was also on the seven-judge bench that overruled

the 1967 AMU verdict, opening the way for reconsideration of its minority status. He was also part of the bench which in 2021 appointed a 3-member panel of cyber experts to probe the alleged use of Israeli spyware Pegasus for surveillance of certain people in India, saying the state cannot get a "free pass" every time the spectre of national security is raised and it cannot be the "bugbear" that the judiciary shies away from.

Amid the din, Leader of Opposition (LoP) Sunil Sharma said the August rainfall affected most areas of J&K, and the people of the Union territory have expectations with this House that the MLAs will raise their issues.

"We respected the House rules ... And followed your promises. Resolutions were managed yesterday in such a way that this important resolution did not even come up. The government seems disinterested in this important issue," Sharma said, adding that the flood-affected victims have been disrespected.

The LoP said there should have been a discussion on the issue on the very first day of the assembly session, and accused the government of running away from a dis-

"What does the government want to hide? A scam in PWD has been unearthed in media today. Why is the government running away? They want to hide corruption, Sharma added. Sharma's comments led to protests by the treasury benches. With both the treasury and the opposition members on their feet, there was uproar in the House. Ruling National Conference (NC) MLA from Gurez, Nazir Ahmad Khan Gurezi, said the BJP members "are enacting a drama" and "wasting the time of the House". As the accusation and counter-accusation flew, deputy chief minister Surinder Choudhary, while pointing towards the BJP MLAs, said, "Chor machaye shor" (thieves were making noise). Another NC MLA, Salman Sagar, asked the BJP to give an account for the ten years from 2014 to 2024 - when the BJP was in power with the PDP till 2018, and then J-K was under the Centre's rule

As the ruckus continued, BJP MLA from Kishtwar, Shagun Parihar, tried to enter the well of the House, but was stopped by female watch and ward staff.

Two BJP MLAs, R S Pathania and Surinder Kumar, were marshalled out after jumping into the well. As the Question Hour continued amid the noisy scenes, the BJP MLAs remained standing till its culmination. As soon as the Question Hour concluded, the BJP MLAs staged a walkout from the House. This was the first walkout by the MLAs in the autumn session. The BJP MLAs shouted slogans against the government, sought an apology from CM Abdullah for "unfulfilled promises", and also demanded his resignation.

Contingents of the Border Security Force (BSF), Central Reserve Police Force (CRPF), Central Industrial Security Force (CISF), Indo-Tibetan Border Police (ITBP) and Sashastra Seema Bal (SSB) will participate in the parade.

In a display of women's empowerment in the security forces, PM Modi will receive a ceremonial salute from contingents of police and paramilitary forces, all of them led by women officers.

Key attractions this year include a BSF marching contingent comprising exclusively of Indian breed dogs such as Rampur Hounds and Mudhol Hounds, Gujarat Police's horse contingent, Assam Police's motorcycle daredevil show, and BSF's camel contingent and camel-mounted band.

Officer, Jammu, Anurag Arya. The team conducted a late-night enforcement drive during which a Tempo Traveller bearing registration number JK12-0949 was inter cepted within the Jammu Range limits. Upon inspection, the vehicle was found loaded with Khair billets being transported in contravention of the provisions of the Indian Forest Act (IFA).

Following due legal procedure, the vehicle and the illicit forest produce were imme diately taken into official custody.
