Advisory regarding Rational Sale of Cold and Cough Syrups by Chemists...rea

Reference: Ministry of Health & Family Welfare, Gol, F. No: 28025/52/2025-SAS.II/EMR dated 03/05/25.

The Union Health Ministry vide communication quoted under reference has advised that Cough and cold medications should not be prescribed or dispensed to children below two years of age. It said, these are generally not recommended for children below five years of age, and above that, any use should follow careful clinical evaluation with close supervision and strict adherence to appropriate dosing and avoiding multiple drug

In its communique, the DGHS further advocates "judicious prescribing and dispensing of cough syrups for children," arguing that most "acute cough illnesses in children are self-limiting and resolve without pharmacological intervention."

All the Chemists /Pharmacists are therefore hereby instructed that Cold and cough syrups for pediatric use, especially those containing ingredients listed under Schedule H and Schedule H1, shall not be sold without a valid prescription issued by a Registered Medical Practitioner (RMP), as mandated under the Drugs & Cosmetics Act, 1940 and the Rules thereunder.

Any violation of these instructions shall attract strict administrative action including Suspension or cancellation of drug sale license, which may be noted.
