and Nagrota seats.

"We welcome the decision to hold bypolls as it is part of the democratic process," BJP spokesperson Altaf Thakur said.

Asked about the one-year delay in holding bypolls to these seats, Thakur said the Election Commission is an autonomous body and political parties cannot impose themselves on it.

"Only the Election Commission knows why the polls were delayed. As political parties, we follow its decisions," he added.

Asked if the party will contest both seats, Thakur said BJP leaders Sat Sharma and Ashok Koul have been called to Delhi. "BJP is always ready for elections. I think it will be clear in a day or two who will be our candidates," he

PDP spokesman Mohit Bhan, while welcoming the decision, said the lack of representation in the Assembly had cost Budgam in terms of development.

"Better late than never... It is the right of the people to have an elected repesentative who will speak for them on issues like development," he said.

Bhan said the political affairs committee of the party will decide whether the party will contest both seats.

"We have done well in the last elections in Budgam and we will be contesting from there. As for Nagrota seats, a decision will be taken in due course," he

Budgam and Nagrota have been vacant since October 2024.

Budgam fell vacant immediately after the 2024 assembly elections when Chief Minister Omar Abdullah chose to retain the Ganderbal constituency. The seat has been vacant since October 21, 2024.

Nagrota, on the other hand, fell vacant on October 31, 2024, after the death of BJP MLA Devender Singh Rana.

Congress Parliamentary Party chairperson Sonia Gandhi, in a statement, said it is not just an attack on the CJI but on our Constitution and no words are enough to condemn such an act.

"No words are adequate to condemn the attack on the Honourable Chief Justice of India in the Supreme Court itself. It is an assault not just on him but on our Constitution as well. Chief Justice Gavai has been very gracious but the nation must stand in solidarity with him unitedly with a deep sense of anguish and outrage," she said.

"An attempt to attack the Hon'ble Chief Justice of India in the Supreme Court today is unprecedented, shameful and abhorrent. It is an attack on the dignity of our Judiciary and the rule of law," Congress president Mallikarjun Kharge said in a post on X.

Solicitor General Tushar Mehta described the act as "unfortunate and condemnable", calling it a result of misinformation and an attempt at cheap pub-

"Today's incident in the chief justice's court is unfortunate and deserves condemnation. This is the result of misinformation in social media. It is really heartening that the chief justice of India reacted with magnanimity.... I only hope that this magnanimity is not treated by others as the weakness of the institution," the top law officer said.

Senior advocate Indira Jaising termed the episode "an attack on the institution as a whole"

The Supreme Court Bar Association(SCBA) expressed its "profound shock, outrage, and unequivocal condemnation" over what it termed a "reprehensible act" committed by an advocate inside CJI's courtroom.

In a strongly worded resolution passed unanimously, the SCBA described the advocate's conduct as "utterly unbecoming of an officer of the Court" and said t "strikes at the very foundation of mutual respect that underpins the relationship between the Bench and the Bar.'

The Supreme Court Advocates-on-Record Association(SCAORA) called the incident as a "disrespectful and intemperate gesture" by an advocate.

The Bar Council of India(BCI) swung into action and swiftly ordered imme diate suspension of Rakesh Kishore.

Issuing the interim suspension order, BCI chairperson and senior advocate Manan Kumar Mishra said the advocate's act was "prima facie inconsistent with the dignity of the court" and in clear violation of the professional conduct rules prescribed under the Advocates Act, 1961 and Bar Council of India Rules.

"On the basis of prima facie material, it appears that at about 11.35 am on 6 October 2025, in Court No. 1 of the Supreme Court of India, you i.e Advocate Rakesh Kishore, enrolled with the Bar Council of Delhi vide enrolment nos..., removed your sports shoes and attempted to hurl them towards the Hon'ble Chief Justice of India during ongoing proceedings, whereupon you were detained by security," the BCI said.

According to sources, the incident could be linked to the lawyer's unhappiness over the CJI's remarks during a hearing last month concerning the restoration of a Vishnu idol in Khajuraho.

A bench headed by the CJI had dismissed the plea seeking directions to reconstruct and reinstall a seven-foot idol of Lord Vishnu at the Javari temple, part of the UNESCO World Heritage Khajuraho temple complex in Madhya Pradesh

Terming the plea a "publicity interest litigation", the CJI had said, "This is purely publicity interest litigation.... Go and ask the deity himself to do some thing. If you are saying that you are a strong devotee of Lord Vishnu, then you pray and do some meditation."

Taking note of the online criticism of his comments, the CJI later said he respects "all religions"

endar year, rallying from Rs 89,700 per kg on December 31, 2024. In the international markets, spot gold rose nearly 2 per cent to touch an all-

time high of USD 3,949.58 per ounce, while silver went up over 1 per cent to hit a high of USD 48.75 per ounce. "Spot gold extended gains and surged above USD 3,940 per ounce for the first time ever as the US government shutdown enters its sixth day, following

the Senate's failure to pass funding bills on Friday," Kaynat Chainwala, AVP Commodity Research at Kotak Securities, said. Meanwhile, gold and silver futures also hit their fresh peaks in the domestic

futures market on Monday. The yellow metal futures for December delivery jumped by Rs 1,962 or 1.66

per cent to hit a record high of Rs 1,20,075 per 10 grams on the Multi Commodity Exchange (MCX).

The February 2026 contract for gold futures appreciated by Rs 2,047 or 1.71 per cent to touch a fresh peak of Rs 1,21,380 per 10 grams.

#### Theft case solved, 5 stolen animals recovered, lifter arrested **STATE TIMES NEWS**

JAMMU: Acting swiftly on a complaint regarding bovine theft, PP Bathindi has arrested one accused involved in lifting bovine animals and successfully recovered five stolen bovines.

On October 3, 2025, a complaint was received at Police Post Bathindi regarding the theft of five bovine animals from the complainant's residence. Acting on the information, a case FIR No. 290/2025 under Section 303(2) of the Bharatiya Nyaya Sanhita (BNS) was registered at Police Station Bahu Fort.

During the course of investigation, a police team from PP Bathindi intercepted a vehicle bearing registration number JK02DL 1094 during the intervening night of October 3 and 4 2025, in the Nowabad Sunjwan area. The vehicle was found loaded with five bovine animals that had been mercilessly tied and were being transported illegally without any valid permission. The driver was apprehended on the spot. Upon identification by the complainant, the recovered bovines were confirmed to be the same stolen animals. The animals were later handed over to the rightful owner on supurdnama. Further investigation into the case is underway to ascertain the involvement of other persons in the theft and illegal transportation racket.

# Army, civilians pay tribute to 1965 War Martyr Pritam Singh

SUNDERBANI: Army personnel, civil administration officials, and local residents gathered today at Rajowa Lam in Qila Darhal block, Rajouri district, to pay homage to Martyr Pritam

Singh on his martyrdom day. The event was held at the memorial site of Pritam Singh, a resident of Rajowa, who laid down his life on October 6, 1965, during the Indo-Pak war. His younger brother and former

Sarpanch Isher Singh recalled his heroic sacrifice while addressing media persons. Isher Singh said, "In 1964, my elder brother Pritam Singh took premature retirement from the Army. When war broke out with Pakistan in 1965, he, along with other ex-servicemen, was

summoned by the local Army unit to assist in defending the region. Pritam Singh volunteered and joined B-Company of the 14 Kumaon Regiment, which moved toward OP Top Hill-captured by Pakistani forces-on the night of October 5, 1965. The final

assault to recapture the strategic position and the nearby Lukhnow post, close to the Pakistan border, began on the morning of October 6. During the operation, Pakistani artillery fire claimed Pritam Singh's life. "He was hit by

splinters and martyred while defending the integrity of the country," said Isher Singh. Following his martyrdom, a memorial was constructed at Rajowa where tributes are paid

annually. On Monday, Army officials and the martyr's family laid floral tributes at the site. Isher Singh recalled that the then Commander of the 80 Brigade, Brigadier UBS Verma, had awarded a bravery certificate and Rs 1,000 as financial support to the family.

He further stated that during the golden jubilee celebrations in Patiala on October 6, 2015, the Kumaon Regiment had invited the family. At the event, Maj Gen V Pandey had promised to recommend a petrol pump or LPG agency for the family-but no action has been taken to date. Among the prominent attendees who paid tribute were Major Harvir Singh (retd), Sukhdev Singh, Malwinder Singh, Bhagwan Singh, Rajinder Singh (Pappu), Satvir Singh, Kamaljeet Singh, Tajwinder Singh, Harbaksh Singh, and Zorawar Singh-all known social activists and community leaders of the area.
