- The contractor shall be fully responsible for safety, security and insurance of its machinery/equipments and personnel engaged during the Mela. The contractor shall make available at spot all required safety equipments/machinery to meet any unforeseen situation during the Mela.
- The contractor shall submit a detailed program along with site map for its deployment/arrangements to be in place at Mela site by 30th October, 2025.
- The successful bidder shall deploy sufficient manpower for sanitation and cleanliness of the area round the clock during the Mela and install required machinery/equipments/dustbins.
