for advance release of 21st instalment of the Pradhan Mantri Kisan Samman Nidhi (PM-KISAN) Scheme for the farmers of

Approx. Rs.171 Cr will be directly transferred into the bank accounts of around 8.55 Lakh eligible farmers of J&K today. This much-needed financial assistance will help our farmers to sustain their livelihoods, speed up recovery to resume agricultur-

Our farmers are the backbone of the economy and providing strong foundation for growth in other sectors. The GOI is committed to provide all possible assistance to mitigate the effects of worst floods in several decades and ensuring stability in the lives of the affected population".

The Union Minister released advance 21st instalment of PM Kisan Samman Nidhi to all eligible farmers, including those in Jammu and Kashmir. Approximately 8.55 lakh beneficiaries from J&K will benefit from this initiative.

The Union Minister also announced assistance of rupees 1.40 lakh for damaged houses with additional Rs 30,000 for each households, making it a total of Rs 1.70 lakhs.

Announcing the decision, Shivraj Singh Chouhan said that the Central Government stands firmly with the people of Jammu & Kashmir during this time of distress. They announced that Rs 171 crore is being directly deposited into the bank accounts of 8.5 lakh farmers in Jammu and Kashmir under the Pradhan Mantri Kisan Samman Nidhi (PM-KISAN) scheme.

Dr Jitendra Singh thanked PM Modi and Chouhan, and further informed that more than 5000 houses to be reconstructed damaged during recent rain, flood, and landslide-affected areas of Jammu division, with immediate relief, financial assistance, and technical support for rehabilitation and reconstruction. Each affected household will receive Rs 1.3 lakh as basic aid, with an additional Rs 40,000 per family to be provided by the

Highlighting the additional assistance of the government in this context, Dr Jitendra said that special provisions are also being considered under NDRF and SDRF norms to support soil restoration and silt removal in the affected farmlands.

The Minister added that farmers whose crops were destroyed will also benefit from the Pradhan Mantri Fasal Bima Yojana. with the state government and insurance companies expediting damage assessment surveys. Dr Singh reiterated the government's resolve to provide employment support through MNRE-GA, extending workdays from 100 to 150 days in severely affected regions, compensation for animal losses, and housing support for families whose homes were destroyed.

Dr Singh commended local initiatives such as lavender cultivation and horticultural diversification in Jammu and Kashmir, calling them models of self-reliance and innovation in the Himalayan region.

Dr. Jitendra highlighted that with the government's continued support through initiatives such as technology enabled progammes, drone technology, and Soil Health Card schemes. farmers are becoming increasingly self-reliant. He noted that agri-startups have successfully established themselves in Jammu & Kashmir, creating livelihood and driving innovation in farming practices.

Javid Dar said that the release of the 21st instalment of PM Kisan Samman Nidhi is a significant step towards providing financial assistance to farmers and promoting agricultural growth in J&K, particularly after the recent floods. "This development is a testament to the close coordination between the Agriculture Production Department (APD) under the guidance of Chief Minister Omar Abdullah and the Union government" he stated.

He further said that the timely release of funds will likely provide much-needed relief to farmers in J&K, enabling them to revive their agricultural activities and rebuild their livelihoods. He added that the collaboration between the J&K and central governments demonstrates their commitment to supporting the agricultural sector and promoting the overall development of

Javid Dar requested the Union Minister to provide a special package for Jammu and Kashmir to address the unique challenges and requirements of the region, particularly in the agriculture sector, as previously discussed during the visit of Union Minister in Jammu.

The Chief Minister reviewed department and district-wise progress under the CAPEX and CDF. He stressed the need for accelerated execution of projects and timely utilization of funds. He directed departments to ensure 100% uploading of works on the BEAMS portal and expedite administrative approvals & tendering process, particularly in view of the limited working season in the Kashmir division.

Chief Minister asked Finance Department to prepare constituency-wise data of works incorporated in the budget which were prioritized by MLAs and directed Districts to immediately upload CDF works on BEAMS, accord administrative approvals and begin early execution of works.

The Chief Minister emphasized close coordination with MLAs to expedite CDF works and ensure visible development outcomes on the ground. He also underlined the importance of enhancing revenue realization and curtailing avoidable expenditure. Wherever possible we have to boost our revenues, we have to cut down on all unnecessary expenditure, but at the same time, the money that has been allocated must be spent efficiently in various schemes." he observed. He directed the concerned ministers to conduct fortnightly reviews to push expenditure and improve funds utilization in their respective departments.

Earlier, Principal Secretary, Finance, Santosh D. Vaidya gave a detailed presentation providing a comprehensive financial and developmental overview of Jammu and Kashmir as of October 7,

Chief Minister directed departments to ensure that funds available in Single Nodal Accounts are utilized well before the deadline as departments shift to SNA-Sparsh financial management system.

Concluding the review, the Chief Minister called for strict monitoring, accountability, and coordinated action among departments to ensure that developmental works translate into tangible improvements on the ground. He reiterated that timely execution, financial prudence, and effective reform implementation remain central to the government's developmental agenda.

May 2022, recently moved an application in the Jammu and Kashmir High Court to seek permission to travel places outside

"That the fact of applicant having been on bail and having not misused or abused the same cannot be the justification for the applicant to claim as a matter of right that he be permitted to eave the territorial limits of UT of J&K.

"Being on bail and applying for leaving the territorial limits of UT of J&K are two different things. Merely because applicant has been released on bail does not mean that person is entitled to be allowed for leaving territorial limits of J&K, that too when the larger public interest and national security is as stake," the counsel said.

He said the applicant has not come with "clean hands" before the court and has tried to "mislead" the court by sheer misrepre-

"The applicant has previously filed a petition of identical nature, seeking identical relief which is still pending adjudication before the court...it is clear that the current application and the earlier petition (filed in 2023) are of identical nature.

"The applicant has not disclosed all the vital and material facts fairly and truly but has stated them in a distorted manner to mislead the court which has inherent powers and is duty bound to protect itself and to prevent an abuse of its processes. Thus it is a fit case where application merits dismissal without examinations on merits," the counsel said.

He also said the applicant by stating that no other application of similar nature is pending in any court has indulged in suppression of material facts which is nothing but practice of willful

Digital Arrest scam...

Nyaya Sanhita (BNS) was registered and a detailed investigation was launched.

During the investigation, the cyber police team traced the money trail, examined bank transactions, scrutinised mobile communications, and analysed digital footprints linked to the fraud, he said, adding the investigation revealed that the network involved in the fraud was primarily operating from Gujarat.

Based on credible intelligence, a special investigation team was deputed to Surat and in a well-coordinated operation, three accused -- Chauhan Manish Arunbhai, Ansh Vithani and Kishorbhai Karamshibhai Diyoria -- were arrested, he said.

He said the arrested individuals were subsequently brought to Jammu for sustained interrogation to identify other co-conspirators, uncover additional evidence, and trace further financial links associated with the crime.

Terming the arrest of the accused as a "major breakthrough", the SSP said the cyber police Jammu has so far frozen Rs 55,88,256.74 across various bank accounts linked to the

Efforts are actively underway to reverse and refund the defrauded amounts to the complainant, out of which Rs 6 lakh has already been credited back to the victim's account, the officer said. On Monday, the first chargesheet in the case was filed in the court against the arrested accused, he said.

Sheikh, accused of providing access to his WhatsApp-linked mobile number, was said to have coordinated with the same handlers. Investigators claimed the duo procured a locally made pistol and shared its image with contacts across the border. The trial court had discharged both accused, observing that the prosecution case relied heavily on inadmissible confessional statements and lacked independent corroboration.

The High Court, however, ruled that seized mobile data, WhatsApp chats, photographs, and foreign fund transfers created "grave suspicion" of their involvement. At the charge stage, the bench said, only a prima facie case is required, not proof

"The trial judge committed a manifest error by assessing the probative value of evidence instead of examining whether there were sufficient grounds to proceed," the court observed.

Restoring the chargesheet, the High Court directed the trial court to hear the case afresh and decide on framing of charges in accordance with law.

While the accused was acquitted of the charge under Section 506 IPC (criminal intimidation) due to lack of evidence, he was convicted under Sections 3 and 4 of the POCSO Act and sentenced to 10 years of rigorous imprisonment, along with a fine. The court also acknowledged that although the victim and accused were later reported to be living together and had married after the incident, the fact remained that the offence occurred when the victim was legally a child.

Adv Purnima calls to contain dengue surge, unsafe street foods

JAMMU: Bharatiya Janata Party (BJP), Jammu & Kashmir, expressed grave concern over the alarming surge in dengue cases across the Jammu division, accusing the present Government and the Jammu Municipal Corporation (JMC) of utter negligence and failure to implement preventive measures to curb the spread of the

Addressing a press conference at the party headquarters Trikuta Nagar, Jammu, BJP Spokesperson and former Deputy Mayor, Adv. Purnima Sharma, along with Dr. Pardeep Mahotra, Media Secretary, J&K BJP, warned the NC-led government against playing with public health and demanded immediate corrective action. Adv. Purnima Sharma said that Jammu is witnessing a steep rise in dengue infections, with eighty-nine new cases reported on Saturday alone, taking the total tally to 1,316 this year. "Just a week ago, the cases were under a hundred, and within days, they have crossed a thousand - exposing the administration's lack of preparedness and seriousness," she stated.Sharma pointed out that J&K recorded nearly 7,000 dengue cases in 2024, 6,403 cases and 10 deaths in 2023, and 8,269 cases with 18 deaths in 2022, yet the authorities have failed to learn lessons.

"Fogging drives are rare, and sanitation measures remain confined to paperwork. JMC have left residents to fend for themselves amid rising infections," she said and demanded that the administration immediately launch intensive fogging, anti-larvae operations, and awareness campaigns across all wards. Adv. Purnima also criticized the Omar Abdullah-led NC government of focusing solely on Srinagar while ignoring Jammu's public health and hygiene. "Why is the government concerned only about Kashmir? Is Jammu's health less important?" she asked. questioning the regime's double standards. Expressing concern over unhygienic street food and unchecked vendors, she urged JMC to conduct regular inspections and strict drives to ensure compliance with food safety standards. "There is a dire need for routine checks around schools, markets, and bus stands to prevent outbreaks of food-borne illnesses. Authorities must act before people start falling sick in large numbers," she warned.
